RESOLVED, That the treasurer of the western shore be and he is hereby authorised and directed to pay unto Young Wilkinson, of the city of Annapolis, late a lieutenant of the artillery in the Maryland line during the revolutionary war, annually, in quarterly payments, a sum of money equal to the half pay of a lieutenant of the

artillery aforesaid.
