And the said Elizabeth Evans in her proper person comes and saith that she is
 not guilty the Indentment aforesaid against her brought nor that she is guilty
 of the premises above upon her imposed as by the said Indentment it is alleged
 and thereupon submits to the Court Therefore it is considered by the Justices
 here to wit at the Court House in the Town of Chester in said County on the third
 day of March being the seventeenth day of said Month Anno Domini Seventeen
 hundred and Twenty Nine that the said Elizabeth Evans pay the Sum of thirty
 Shillings current money of being as a fine for committing the offence of for-
 nication as aforesaid as also the Sum of one hundred and twenty eight yds of
 Tobacco Cost Accruing on the premises aforesaid to the officer of this Court
 ordered by the Court that the said Eliza Evans prove upon her Oath the person
 that was the begot of the said Child Therefore she comes into Court the said Eliza
 and being sworn declares that a certain Charles Griffin was the person that
 begot her said Child as by a certain Certificate of the said Charles Griffin aforesaid
 ordered by the Court here that the said Eliza give Security for her fees as
 aforesaid Therefore she comes into Court Wedge Crombe of said County and sheweth
 that he will pay the aforesaid for the said Elizabeth Evans &c
