- A Supplement to an act, entitled, An act authorising a lottery to raise a sum of money for repairing Shrewsbury church, in Kent county. LXXXVI.
- An ACT to authorise and empower the levy court of Anne-Arundel county to assess a sum of money for the purpose therein mentioned. LXXXVII.
- An ACT authorising the late collectors of public taxes in Cecil county to complete their several collections. LXXXVIII.
- An ACT to incorporate a company to make a turnpike road from the line of the district of Columbia where it crosses the post-road leading from George-town to Frederick-town, through Montgomery and Frederick counties, to Frederick-town. LXXXIX.
- An ACT to prevent free negroes from selling any corn, wheat or tobacco, without having a licence for that purpose from a justice of the peace. LXXX.
- A Supplement to the act, entitled, An act for the relief of sundry insolvent debtors, passed at November session, eighteen hundred and three. LXXXI.
