

bridges, culverts or roads, signboards with lettering not less than three inches in height, setting forth the weight and speed allowed; and any individual, firm, partnership, corporation or other person, whether the owner or the person in charge of such vehicles or an employee or agent of such person, who shall draw, drive or propel or in any other manner take or cause to be taken, drawn, driven or propelled over any such bridge, culvert or road any of the aforementioned vehicles weighing more than the maximum weight allowed upon the posted sign, without a written permit from the Frederick County Board of Commissioners, shall be guilty of a misdemeanor and upon conviction thereof shall be subject to a fine of not less than Twenty five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) for each such offense; in addition to which the owner or person in control of such vehicle shall be liable to the said Board for all damage which may be caused by the violation of any such regulation.

30. (A) THE COUNTY COMMISSIONERS OF FREDERICK COUNTY ARE AUTHORIZED TO REGULATE THE WEIGHT AND SPEED OF TRUCKS, TRACTORS, MACHINES, AND ROAD ENGINES OR OTHER VEHICLES OF ANY KIND PASSING OVER ANY BRIDGES OR CULVERTS INCLUDED IN THE COUNTY ROADS SYSTEM BY POSTING AND MAINTAINING CONSPICUOUSLY AT BOTH ENDS OF SAID BRIDGES OR CULVERTS, SIGNBOARDS WITH LETTERING NOT LESS THAN THREE INCHES IN HEIGHT, SETTING FORTH THE WEIGHT AND SPEED ALLOWED. THE COUNTY COMMISSIONERS OF FREDERICK COUNTY WITH RESPECT TO ANY ROADS INCLUDED IN THE COUNTY ROAD SYSTEM MAY BY RESOLUTION IMPOSE REGULATIONS AS TO THE WEIGHT OF VEHICLES TO BE OPERATED UPON ANY ROADS FOR A PERIOD NOT TO EXCEED 6 MONTHS, WHENEVER ANY SUCH ROAD BY REASON OF DETERIORATION, RAIN, SNOW, OR OTHER CONDITION, WILL BE SERIOUSLY DAMAGED OR DESTROYED UNLESS THE PERMISSIBLE WEIGHTS ARE REDUCED, AND FURTHER THAT ADDITIONAL 6 MONTHS PERIODS MAY BE IMPOSED BY A LIKE RESOLUTION.

(B) THE COUNTY COMMISSIONERS ENACTING ANY SUCH RESOLUTION SHALL ERECT OR CAUSE TO BE ERECTED, POSTED AND MAINTAINED, AT EACH END OF THAT PORTION OF ANY ROAD AFFECTED THEREBY, SIGNBOARDS WITH LETTERING NOT LESS THAN THREE INCHES IN HEIGHTS, SETTING FORTH THE WEIGHT LIMITS ALLOWED, AND THE RESOLUTION SHALL NOT BE EFFECTIVE UNLESS AND UNTIL SUCH SIGNBOARDS ARE ERECTED AND POSTED.

(C) ANY INDIVIDUAL, FIRM, PARTNERSHIP, CORPORATION OR OTHER PERSON, WHETHER THE OWNER OR THE PERSON IN CHARGE OF SUCH VEHICLES, OR AN EMPLOYEE OR AGENT OF SUCH PERSON, WHO SHALL DRAW, DRIVE, OR PROPEL, OR IN ANY OTHER MANNER TAKE OR CAUSE TO BE TAKEN, DRAWN, DRIVEN, OR PROPELLED OVER ANY SUCH BRIDGE, CULVERT, OR ROAD ANY OF THE
