An act to incorporate a Company for the purpose of build- Passed Feb 10 1819 ing a Bridge over the North West Branch of Nanticoke River, at a place heretofore called Crotchers's Ferry, but now known and called The Rising Sun.

WHEREAS, it is represented to this general assembly, by the pe- Preamble. tition of a number of inhabitants of Dorchester county, the convenience of the public would be greatly promoted by erecting a bridge over the North West Branch of Nanticoke River, and praying that a law may pass to incorporate a company for erecting a bridge over the said North West Branch of said river; therefore,

Sec. 1. Be it enacted, by the General Assembly of Maryland. That Commissioners Thomas Ennals, Joseph Nicols, Francis Turner, Ezekiel Wheatly, cons John Brohown, Minos Adams, William S. Harper, John Shehee, William Wheatley and John Cropper, be and they are hereby appointed commissioners, with full power and authority to open, or cause to be opened, a book for receiving and entering subscriptions for raising a capital stock not exceeding five thousand dollars, to be divided into two hundred and fifty shares, each share to be twenty dollars, for the purpose of building a bridge over the North West Branch of Nanticoke River, at a place now called The Rising
