- An ACT to authorise Richard Tilghman, William Hopper, Thomas Wright, of Thomas, and Thomas J. Seth, of Queen Anne's county, to raise by lottery a sum of money for the purposes therein mentioned. LXIX.
- An ACT to repeal part of an act, entitled, A supplement to the act for the establishment and regulation of levy courts in the several counties of this state. LXX.
- An ACT to make permanent and to continue the acts of assembly therein mentioned. LXXI.
- An ACT for the relief of Ralph Ormiston, of Washington county. LXXII.
