- (b) and (c) prior to July 1, 1967 shall not be entitled to receive a pension based upon the increases in the pension schedule provided by Section 40 of this article which became effective upon July 1, 1967 but shall continue to receive those benefits provided for by law immediately prior to that date.
- (f) The pension specified in subsections (a), (b) and (c) shall be paid by the State in full amount to all widows who receive no supplementation from a political subdivision or subdivisions. The pension specified in subsections (a), (b) and (c) shall be paid by the State in reduced amounts to all widows who became entitled to benefits on or after July 1, 1967 and who receive supplementation of pension from a political subdivision or subdivisions. In such event the widow or widows shall be paid annually by the State an amount computed by subtracting from the sums allowable under subsections (a), (b) and (c), a sum equal to the annual supplementation.
- 50A. Same Widow of former chief judge of fourth judicial circuit resident in Allegany County.
- **E(a)** The County Commissioners of Allegany County may pay a pension or salary to the widow of any former chief judge of the fourth judicial circuit if (1) he served as chief judge at any time during or following the year 1960 and resided in Allegany County during his service as such; and (2) she is receiving or cligible to receive payments of a salary or pension under the provisions of Section 50 of this subtitle.
- (b) The pension or salary paid to the widow may be annually an amount computed in this manner: (i) An amount equal to one and one half per centum (1½%) of the total amount being paid annually to the former chief judge under the provisions of Section 48 of this subtitle, at the time of his death, is multiplied by (ii) the number of years (or portions thereof) during which the former chief judge served either as an associate judge or as the chief judge in the fourth judicial circuit.
- (e) The County Commissioners of Allegany County may levy upon the assessable property of the county a tax sufficient to pay the amount payable and computed under this section.
- S=3. 2. And be it further enacted, That Section 12.4 of the Code of Public Local Laws of Prince George's County (1963 Edition, being Article 17 of the Code of Public Local Laws of Maryland), title "Prince George's County," subtitle "Circuit Court," subheading "Judges' Salaries," as this section was last amended by Chapter 925 of the Acts of 1965, be and it is hereby repealed as follows:

F12-4.

The County Commissioners of Prince George's County are hereby authorized and directed to pay to each of the Judges of the Circuit Court for the Seventh Judicial Circuit of Maryland who reside in Prince George's County the sum of five thousand dellars (\$5,000.00) annually in addition to the salary received by each of said Judges from the State of Maryland and to pay to each of the Judges of the Circuit Court for the Seventh Judicial Circuit of Maryland who are non-residents of Prince George's County and who sit in the
