

SIGNED, CONSTITUTING] A MAJORITY OF THE BOARD OF REGISTRY OR THE BOARD OF SUPERVISORS OF ELECTION OF, DO HEREBY CERTIFY THAT:

1. IS A REGISTERED VOTER OF THE PRECINCT, WARD OR ELECTION DISTRICT AND ENTITLED TO CAST HIS BALLOT IN THE AFORESAID PRECINCT, OR ELECTION DISTRICT, HAVING [HERETOFORE] SWORN THAT HE OR SHE HAS NOT APPLIED FOR OR RECEIVED ANY ABSENTEE BALLOT FOR THIS ELECTION.

2. THE FOLLOWING ENTRIES APPEAR UPON THE DUPLICATE REGISTRATION FORM OF THE SAID APPLICANT RETAINED IN THE OFFICE OF SAID BOARD:

THIS SPACE RESERVED FOR THE PERMANENT REGISTRATION FORM ADOPTED AND MADE A PART OF THIS CODE AT SECTION 3-12

WHEREFORE, IN CONFORMITY WITH THE PROVISIONS OF SECTION 3-15, ARTICLE 33 OF THE PUBLIC GENERAL LAWS OF MARYLAND, YOU ARE HEREBY AUTHORIZED AND DIRECTED TO PERMIT THE SAID TO CAST HIS OR HER BALLOT AT THE ELECTION AFORESAID PROVIDED THAT HE OR SHE SIGNS HIS OR HER NAME ON A VOTING AUTHORITY CARD, AND THAT SIGNATURE CORRESPONDS WITH HIS OR HER SIGNATURE AS IT APPEARS ON THE [LINE DIRECTLY BELOW] PERMANENT REGISTRATION FORM HERE ATTACHED.

3. YOU ARE FURTHER DIRECTED TO RETAIN THIS TEMPORARY CERTIFICATE OF REGISTRATION UNTIL THE POLLS CLOSE AND THEN RETURN SAME TO THE BOARD OF SUPERVISORS OF ELECTION, TOGETHER WITH THE PRECINCT OR ELECTION DISTRICT BINDER CONTAINING THE ORIGINAL REGISTRATION FORMS OF THE VOTERS.

AS WITNESS THE FOLLOWING SIGNATURES OF [SAID BOARD AND THE SEAL OF THE BOARD OF SUPERVISORS OF] TWO OF THE JUDGES OF ELECTIONS REPRESENTING THE PRINCIPAL MAJORITY AND MINORITY PARTIES.
