

EXECUTE PROCESS, ORDERS, AND DIRECTIONS FOR THE JUVENILE COURT, AND TO PERFORM THE OTHER DUTIES THE SHERIFF ASSIGNS.

(3) A DEPUTY SHERIFF IS ENTITLED TO FREE MEALS WHILE ON DUTY, IN ADDITION TO THE SALARY PROVIDED IN THIS SUBSECTION.

(4) IF AUTHORIZED BY THE COUNTY COMMISSIONERS, THE SHERIFF MAY EMPLOY A CLERK-BOOKKEEPER UNDER THE COUNTY CLASSIFIED SERVICE AT A SALARY AGREED UPON BY THE SHERIFF AND THE COUNTY COMMISSIONERS. THE CLERK-BOOKKEEPER SHALL PERFORM THE DUTIES ASSIGNED BY THE SHERIFF, INCLUDING THE PREPARATION OF REPORTS SUBMITTED BY THE SHERIFF'S OFFICE TO THE GRAND JURY OR THE COUNTY COMMISSIONERS.

(C) ANNE ARUNDEL COUNTY.

(1) THE SHERIFF OF ANNE ARUNDEL COUNTY SHALL RECEIVE A SALARY OF \$15,000 PLUS AN ALLOWANCE OF \$2,500 FOR PERSONAL EXPENSES INCIDENTAL TO HIS DUTIES. IN ADDITION TO HIS SALARY, THE SHERIFF SHALL RECEIVE \$145,000 ANNUALLY TO BE USED FOR SALARIES OF DEPUTIES AND ANY NECESSARY CLERICAL ASSISTANTS; \$19,500 OF THIS SHALL BE FOR THREE NEW POSITIONS AT \$6,500 EACH AND \$15,000 FOR INCREASES IN SALARY FOR 14 FULL TIME EMPLOYEES.

(2) THE SHERIFF OF ANNE ARUNDEL COUNTY SHALL APPOINT NOT LESS THAN 14 DEPUTIES, AND ANY CLERICAL ASSISTANTS REQUIRED BY THE DUTIES OF THE OFFICE. IN CASE OF EMERGENCY, THE SHERIFF MAY TEMPORARILY DEPUTIZE ANY ABLE-BODIED CITIZEN TO ASSIST HIM IN CARRYING OUT THE DUTIES OF HIS OFFICE. THE COUNTY COUNCIL SHALL FURNISH ALL DEPUTIES WITH AUTOMOBILES SUITABLE FOR THE PERFORMANCE OF THEIR DUTIES, AT NO EXPENSE TO THE DEPUTIES.

(3) THE PAYMENT OF COMPENSATION AND EXPENSES OF THE SHERIFF'S OFFICE SHALL BE MADE FROM THE GENERAL FUNDS OF ANNE ARUNDEL COUNTY.

(D) BALTIMORE CITY.

(1) IN BALTIMORE CITY, THE SHERIFF SHALL RECEIVE A SALARY OF \$20,000. HOWEVER, IF THE MAXIMUM ANNUAL SALARY RECEIVED BY THE CLERKS OF EACH OF THE LAW AND CRIMINAL AND EQUITY COURTS OF BALTIMORE CITY IS LESS THAN \$20,000, THE SHERIFF SHALL RECEIVE THE SAME AMOUNT RECEIVED BY THE CLERKS. HE SHALL APPOINT
