

AN UNDERSHERIFF AND CHIEF DEPUTY SHERIFF, TWO SUPERVISORY DEPUTY SHERIFFS, ONE DEPUTY SHERIFF WRIT CLERK AND FOUR ASSISTANT DEPUTY SHERIFF WRIT CLERKS, ONE STENOGRAPHER AND DOCKET CLERK, TWO CLERKS AND 51 DEPUTY SHERIFFS. SALARIES FOR THESE EMPLOYEES SHALL BE SET BY THE SECRETARY OF PERSONNEL. A DEPUTY SHERIFF WHO USES HIS PERSONAL AUTOMOBILE IS ENTITLED TO A MONTHLY AUTOMOBILE ALLOWANCE AT THE SAME RATE PAID TO OTHER STATE EMPLOYEES. ANY SHERIFF WHO IS ASSIGNED A CITY-OWNED AUTOMOBILE SHALL NOT RECEIVE THE MONTHLY AUTOMOBILE EXPENSE ALLOWANCE. THEY SHALL ALSO HAVE ASSISTANTS AT THE COMPENSATION PROVIDED FOR IN THE ANNUAL ORDINANCE OF ESTIMATES OF BALTIMORE CITY. PROVISION SHALL ALSO BE MADE IN THE ORDINANCE FOR THE EXPENSES OF THE OFFICE OF THE SHERIFF, INCLUDING THE PURCHASE AND MAINTENANCE OF MOTOR VEHICLES. THE MAYOR AND CITY COUNCIL SHALL HAVE THE SAME POWER WITH RESPECT TO THE SALARIES OF THE OFFICE OF THE SHERIFF AS IT HAS UNDER THE CITY CHARTER WITH RESPECT TO THE SALARIES OF ALL MUNICIPAL DEPARTMENTS. EMPLOYEES OF THE SHERIFF'S OFFICE, EXCEPT THE SHERIFF, SHALL BE SELECTED ACCORDING TO THE PROVISIONS OF §9E OF ARTICLE 64A OF THE CODE.

(2) THE MAYOR AND CITY COUNCIL SHALL PAY MONTHLY TO THE SHERIFF OF BALTIMORE CITY ONE-TWELFTH OF THE AMOUNT PROVIDED IN THE ORDINANCE OF ESTIMATES FOR THE EXPENSES OF THE SHERIFF'S OFFICE. WITHIN 30 DAYS AFTER JUNE 30TH IN EACH AND EVERY YEAR THE SHERIFF OF BALTIMORE CITY SHALL PAY TO THE MAYOR AND CITY COUNCIL OF BALTIMORE ANY OF THE UNEXPENDED EXPENSE FUNDS ADVANCED DURING THE PRECEDING YEAR AND RENDER A DETAILED ACCOUNT TO THE MAYOR AND CITY COUNCIL OF BALTIMORE OF ALL EXPENSE FUNDS RECEIVED AND EXPENDED BY HIM. THE MAYOR AND CITY COUNCIL OF BALTIMORE SHALL REIMBURSE THE STATE OF MARYLAND FOR THE ADMINISTRATIVE COSTS INCURRED BECAUSE THE EMPLOYEES OF THE SHERIFF'S OFFICE OF BALTIMORE CITY ARE CLASSIFIED EMPLOYEES OF THE STATE OF MARYLAND.

(E) BALTIMORE COUNTY.

THE SHERIFF OF BALTIMORE COUNTY SHALL RECEIVE A SALARY OF \$18,500. HE SHALL APPOINT A CHIEF DEPUTY, FOUR ADDITIONAL FULL-TIME DEPUTIES, A DEPUTY SHERIFF'S MATRON, AND A DOCKET CLERK. HE MAY ALSO APPOINT PERSONS TO THE POSITIONS OF CAPTAIN, LIEUTENANT, AND SERGEANT WITHIN HIS OFFICE. THERE SHALL BE NO PART-TIME DEPUTIES EMPLOYED BY THE SHERIFF'S OFFICE. ALL FULL-TIME EMPLOYEES UNDER THIS SECTION ARE SUBJECT TO THE PROVISIONS OF THE COUNTY MERIT SYSTEM AND THE
