

RULES AND REGULATIONS PASSED BY THE COUNTY COUNCIL PURSUANT TO THE CHARTER, AS TO QUALIFICATIONS, COMPENSATION, AND OTHER REGULATIONS.

(F) CALVERT COUNTY.

THE SHERIFF OF CALVERT COUNTY SHALL RECEIVE A SALARY OF \$7,000 AND \$2,500 FOR ALL EXPENSES. HE MAY APPOINT NOT MORE THAN FOUR DEPUTY SHERIFFS WHO SERVE AT HIS PLEASURE. EACH DEPUTY SHERIFF SHALL RECEIVE A SALARY OF \$6,000 AND AN ALLOWANCE OF \$2,500 FOR EXPENSES. DEPUTY SHERIFFS SHALL BE BETWEEN 22 AND 48 YEARS OF AGE WHEN APPOINTED, AND WITHIN SIX MONTHS OF THEIR APPOINTMENT, SHALL TAKE A MARYLAND STATE POLICE TRAINING COURSE, OF NOT LESS THAN TWO WEEKS DURATION, AND THEREAFTER TAKE A REFRESHER TRAINING COURSE ANNUALLY. IN ADDITION TO THEIR SALARIES THE SHERIFF AND DEPUTIES SHALL BE REIMBURSED FOR ACTUAL EXPENSES INCURRED FOR TRIPS OUTSIDE CALVERT COUNTY NOT TO EXCEED \$15 PER TRIP. THERE SHALL BE NO HONORARY DEPUTY SHERIFFS OF CALVERT COUNTY AND NO ONE IS AUTHORIZED TO CARRY EADGES, CERTIFICATES OR OTHER MATERIALS FOR THE PURPOSE OF IDENTIFYING HIMSELF AS AN HONORARY DEPUTY SHERIFF.

(G) CAROLINE COUNTY.

THE SHERIFF OF CAROLINE COUNTY SHALL RECEIVE A SALARY OF \$12,000 AND AN ALLOWANCE FOR MILEAGE IN CONNECTION WITH HIS OFFICIAL DUTIES AND FOR BOARDING AND KEEPING PRISONERS AT THE COUNTY JAIL. HE SHALL APPOINT A DEPUTY, AT A SALARY OF AT LEAST \$2,800, AND A MATRON-COOK FOR THE COUNTY JAIL, AT A SALARY OF AT LEAST \$2,500. HE MAY APPOINT ADDITIONAL DEPUTIES WITH THE APPROVAL OF THE COUNTY COMMISSIONERS AS TO NUMBER AND COMPENSATION; THE COUNTY COMMISSIONERS OF CAROLINE COUNTY MAY INCREASE THE SALARY OF THE SHERIFF, HIS DEPUTIES, AND OTHER EMPLOYEES IN ACCORDANCE WITH ARTICLE III, §35 OF THE CONSTITUTION.

(H) CARROLL COUNTY.

THE SHERIFF OF CARROLL COUNTY SHALL RECEIVE A SALARY OF \$9,500. HE MAY APPOINT THE NUMBER OF DEPUTIES NECESSARY FOR THE PROPER EXECUTION OF THE DUTIES OF HIS OFFICE, WHO SHALL RECEIVE THE COMPENSATION SET BY THE COUNTY COMMISSIONERS.

(I) CECIL COUNTY.

(1) THE SHERIFF OF CECIL COUNTY SHALL
