

Amendment No. 72—

On page 5-64, in lines 36 and 37, delete “REFUGES, AND PUBLIC HUNTING AREAS”.

Amendment No. 73—

On page 5-65, in line 32, delete the words “VALUE” and “MAKES”, respectively, and insert in lieu thereof the words “VALUES” and “MAKE”, respectively; in line 42, delete “CONSIDERATION” and insert in lieu thereof “INVENTORY”.

Amendment No. 74—

On page 5-66, in line 23, after the word “NOTICE” insert “HE DEEMS APPROPRIATE”; in line 24, delete “HE DEEMS APPROPRIATE”.

Amendment No. 75—

Amendment No. 76—

On page 5-68, immediately before line 14, insert the following:

“5-1212. RESTRICTIONS ON CERTAIN USES.

EXCEPT AS PROVIDED IN PART II OF THIS SUBTITLE, AND SUBJECT TO EXISTING PRIVATE RIGHTS, A COMMERCIAL ENTERPRISE OR PERMANENT ROAD, EXCEPT FIRE ROADS, MAY NOT EXIST WITHIN ANY WILDLAND AREA DESIGNATED BY PART II OF THIS SUBTITLE. EXCEPT AS NECESSARY TO MEET MINIMUM REQUIREMENTS FOR THE ADMINISTRATION OF THE AREA FOR THE PURPOSE OF PART II OF THIS SUBTITLE, INCLUDING MEASURES REQUIRED IN EMERGENCIES INVOLVING THE HEALTH AND SAFETY OF PERSONS WITHIN THE AREA, THERE SHALL BE NO TEMPORARY ROAD, USE OF MOTOR VEHICLES, MOTORIZED EQUIPMENT, MOTORBOATS, LANDING OF AIRCRAFT, OR OTHER FORMS OF MECHANICAL TRANSPORT, AND NO STRUCTURE OR INSTALLATION WITHIN ANY AREA.”

Amendment No. 77—

On page 5-70, delete all of line 21 and insert in lieu thereof the following:

“SUBTITLE 13. PENALTIES AND FINES.”

Amendment No. 78—

On page 5-71, strike all of line 8 and insert in lieu thereof “(C) VIOLATION OF RULE OR REGULATION.—”; in line 9, delete “RESTRICTION.—”; in line 11, delete “OR RESTRICTION”.

Amendment No. 79—

On page 5-72, strike all of lines 5 through 11, inclusive.
