 missuagio tenements Dwelling houses, yards, Barns, Stables, out houses,
 Edificing buildings Tobacco houses, barns, gardens and out gardens and all
 and singular other the premises therunto belonging or in anywise appertaining
 with their and every of their appurtenances, To have and to hold, all and
 singular the said Tract parcel Division of Land and premises and every part &
 parcel thereof with their and every of their appurtenances unto the said
 Solomon Thomas his Heirs and assigns forever so that neither the
 said Thomas Taylor nor my Heirs, nor any other person or persons for us or
 in name or their names or names Right title or share shall or may by any way
 or in any hereafter have Claim Challenge or Demand any right title
 Interest use possession or Reversion to offer in the aforesaid parcel or Division of
 Land and premises or any part thereof, But of and from all Action of right
 title Interest or Demand therunto or to any part thereof to be had, &
 the said Thomas Taylor and my Heirs and assigns be altogether barred and
 forever Excluded by these presents, In witness Whereof the said Thomas
 Taylor have hereunto set my Hand and seal the eighth day of Aprill
 in the fifth year of the Dominion of the right honorable Charles absolute
 Lord and Proprietary of the Province of Maryland and Avalon Lord Baron

This Indenture made the tenth day of Aprill in the fifth year of
 the Dominion of the Right honorable Charles absolute Lord and Proprietary of the
 Province of Maryland and Avalon Lord Baron of Baltimore &c. and in the year
 of our Lord god one thousand six hundred and Eighty, Betweene Solomon Thomas
 of Calvert County in the Province of Maryland, Paul Lawfull son and Heir of
 Thomas Thomas late of Calvert County deceased of the one part and Robert Sumner
 of Calvert County, aforesaid Marshall on the other part Whereby a Certain
 Inquisition Inducted at the Courthouse in Calvert County in the County of the said
 Province of Maryland the Eleventh day of December in the fourth year of the
 Dominion of the Right Hon^{ble} Cecilius of most noble memory, and in the year of our
 One thousand six hundred seventy and one, Before Thomas Spragg and Richard Perry
 gent^l by virtue of his Letters Commission in the nature of a writt of Mandamus to
 them directed and to the said Commission annexed to Enquire after the death of
 &c.
