

## VETOES

DISAPPROVED RULE, REGULATION, STANDARD, OR PORTION THEREOF, EXCEPT AS PROVIDED IN SUBSECTION (J) .

{6} TEMPORARY ADOPTION HAS THE EFFECT OF ALLOWING IMPLEMENTATION OF A DISAPPROVED RULE, REGULATION, STANDARD, OR PORTION THEREOF, IF PERMITTED BY THE COMMITTEE, UNTIL THE ADJOURNMENT OF THE GENERAL ASSEMBLY SESSION IN WHICH THE RESOLUTION PROVIDED FOR IN SUBSECTION (J) IS INTRODUCED AND ALSO COMPELS PREPARATION AND SUBMISSION OF THE RESOLUTION PROVIDED FOR IN SUBSECTION (J) .

"(I) (1) DISAPPROVAL OF ANY RULE, REGULATION, OR STANDARD OR PORTION THEREOF BY THE COMMITTEE PURSUANT TO SUBSECTION (H) SHALL BE BASED SOLELY ON THE FOLLOWING GROUNDS:

(I) THE RULE, REGULATION, OR STANDARD OR PORTION THEREOF FAILS TO COMPLY WITH THE LEGISLATIVE INTENT OF THE LAW AUTHORIZING PROMULGATION; OR

(II) THE DEPARTMENT, BOARD, COMMISSION, OR OTHER AGENCY OF THE EXECUTIVE BRANCH HAS EXCEEDED THE AUTHORITY DELEGATED TO IT BY THE GENERAL ASSEMBLY.

(2) ANY RULE, REGULATION, OR STANDARD OR PORTION THEREOF WHICH IS DISAPPROVED BY THE COMMITTEE MAY NOT BE RESUBMITTED IN SUBSTANTIALLY THE SAME FORM PENDING REVIEW AS PROVIDED IN SUBSECTION (J) OR WITHDRAWAL AS PROVIDED IN SUBSECTION (H) .

{3} THE COMMITTEE MAY EITHER SUSPEND OR ALLOW THE TEMPORARY IMPLEMENTATION OF ANY RULE, REGULATION, OR STANDARD OR PORTION THEREOF PENDING THE REVIEW BY THE GENERAL ASSEMBLY AS PROVIDED IN SUBSECTION (J) . THE TEMPORARY IMPLEMENTATION OF ANY RULE, REGULATION, OR STANDARD MAY ONLY BE ALLOWED BY THE COMMITTEE IN ORDER TO AVOID LOSS OF FEDERAL MONEYS OR TO AVOID CONFLICT WITH FEDERAL LAW.

"(J) IN THE EVENT OF DISAPPROVAL BY THE COMMITTEE OF ANY RULE, REGULATION, OR STANDARD OR PORTION THERETO:

{1} THE RULE, REGULATION, OR STANDARD OR PORTION THEREOF DISAPPROVED SHALL HAVE NO FURTHER EFFECT UNLESS THE GENERAL ASSEMBLY, WITHIN ONE YEAR OF THE COMMITTEE'S DISAPPROVAL, ADOPTS A JOINT RESOLUTION APPROVING THE PROPOSED RULE,
