{9}--Striped--bass,--less--than--14--inches--in--length--or measuring--more--than--32--inches.--However,--a--person--may--possess--one striped--bass--over--32--inches--per--day--caught--with--hook--and--line--in the--tidal--waters--of--the--State--at--any--time--of--the--year--except--from March--1--to--April--30--inclusive,--which--may--not--be--sold--or--offered for--sale,--in--any--year--that--the--young--of--the--year--striped--bass
