RESOLUTION OF THE MAYOR AND CITY COUNCIL OF ABERDEEN TO AMEND SECTION 4(A) OF THE CHARTER OF THE CITY OF ABERDEEN TO EXTEND THE CORPORATE BOUNDARIES AND TO DESIGNATE THE ZONING CLASSIFICATION OF THE LAND BEING ANNEXED. (18.06 acres of land, more or less)

Charter Amendment No. 48

A RESOLUTION OF THE MAYOR AND COUNCIL ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XIE OF THE CONSTITUTION OF MARYLAND AND OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS) TO REPEAL THE ENTIRE CHARTER OF "THE CITY OF ABERDEEN", TITLE "HARFORD COUNTY", SUBTITLE "ABERDEEN" OF THE CODE OF PUBLIC LOCAL LAWS OF HARFORD COUNTY (1965 EDITION AND AMENDMENTS), BEING ALSO ARTICLE 13 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, AND TO ENACT, IN LIEU THEREOF, A NEW CHARTER UNDER THE NEW SUBTITLE OF "CITY OF ABERDEEN" TO BE CODIFIED AS NEW SECTION I THROUGH X (INCLUSIVE), RETAINING THE MAYOR-CITY COUNCIL FORM OF MUNICIPAL GOVERNMENT UNDER THE NAME OF THE "CITY OF ABERDEEN", SPECIFYING THE MUNICIPAL CORPORATE POWERS, AND GENERALLY PROVIDING FOR: THE REDEFINITION OF THE POWERS AND DUTIES OF THE MAYOR AND CITY COUNCIL; THE ESTABLISHMENT OF THE OFFICE OF CITY MANAGER; THE ABOLITION OF THE OFFICE OF CITY ADMINISTRATOR; THE MODIFICATION OF THE DATE ON WHICH CITY ELECTIONS ARE TO BE CONDUCTED FROM THE FIRST TUESDAY IN MAY TO THE FIRST TUESDAY IN APRIL, COMMENCING IN 1996; LIMITATION OF THE TERM OF OFFICE FOR OFFICIALS ELECTED IN MAY 1994 AND MAY 1995; THE LIMITATION OF TERMS AND OTHER REQUIREMENTS FOR ELECTED OFFICE; THE RESTRUCTURE OF THE CHARTER; AND SUCH OTHER AMENDMENTS AS MORE PARTICULARLY DESCRIBED THEREIN.
