(A) THE CHIEF JUDGE OF THE COURT OF APPEALS SHALL SERVE AS THE CHAIRMAN OF THE COMMISSION UNTIL THE COMMISSION CHOOSES A CHAIRMAN.

(B) THE COMMISSION SHALL CHOOSE A CHAIRMAN FROM AMONG ITS MEMBERS.
