(b) At least [ 1 month ] 3 2 MONTHS before a certificate of authority expires, the Commissioner shall mail to the holder of the certificate of authority, at the last known address of the holder:

(1) a renewal application form; and

(2) a notice that states:

(i) the date on which the current certificate of authority expires;

(ii) the date by which the Commissioner must receive the renewal application for the renewal to be issued and mailed before the certificate of authority expires; and

(iii) the amount of the renewal fee.

~~(E) (1) UNTIL THE INSURER HAS FILED AN INSURER SHALL MAIL A RENEWAL APPLICATION AND THE APPLICABLE RENEWAL FEE; ON OR BEFORE JUNE 1 JUNE 30.
