Be it remembered and it is hereby certified that the following Bill of Sale, was received and recorded on the 5th day of April 1852 to wit: -

Know all men by these presents, That I Thomas H. Hurley, of Dorchester County, and State of Maryland, for and in consideration of the sum of Two thousand Dollars, current money to me in hand paid by Lewis Ross of Dorchester County and State of Maryland, have granted, bargained and sold, and by these presents do grant, bargain and sell unto the said Lewis Ross his heirs and assigns, the following negroes, to wit; one negro man named Thomas aged about twenty eight years of a dark complexion - one negro man named Isaac aged about twenty four years of a dark complexion - one negro woman named Maria aged about twenty two years of age, of a dark complexion, one negro boy named Thomas two years old of a dark complexion, child of said Maria - the above named negroes are slaves for life, and sound in body and mind, to have and to hold the said negroes Thomas, Isaac, Maria and negro boy Thomas as above bargained and sold unto the said Lewis Ross his heirs, executors, administrators and assigns, against me the said Thomas H. Hurley, my heirs, executors and administrators, and against all and every ^{other} person or persons whatsoever, shall and will warrant and forever defend. In Testimony whereof, I Thomas H. Hurley have hereto set my hand and affixed seal this fifth day of April, Eighteen hundred and fifty two.

Hurley of the same place and County of the other parts, Whereas the said Thomas H. Hurley by Indenture of Mortgage, bearing date the twenty fifth day of March, in the year 1852, duly executed and acknowledged and recorded among the Chattel records of Dorchester County, did for and in consideration of the sum of Two thousand Dollars Current money grant bargain sell alien convey and confirm unto the said Lewis Ross, his heirs and assigns all his personal Estate of whatever kind or nature more particularly described in the said Mortgage as by reference to the same will more fully and at large appear, and whereas the said Thomas H. Hurley, hath fully paid and satisfied to him the said Lewis Ross, the above mentioned sum of money and interest by a full conveyance
