Robson his heirs and assigns forever. Witness my hand and seal this fifth day of June Eighteen hundred and fifty two.

Pope his Executor administrator or assigns in the balance said note or obligation supposed and believed to be about the sum of two hundred and fifty dollars current money with legal interest thereon. And whereas the said Thomas D. Smith (principle) and the said James R. Phillips as security for the said Thomas D. Smith by their note or obligation dated — stands bound to a certain John Bain his administrator Executor or assigns, supposed and believed to be now about the sum of two hundred and twenty five dollars current money, bearing interest from date as referred to the aforesaid note or obligation will appear.
