

(7) THAT PART OF ELECTION DISTRICT 20, PRECINCT 9 THAT IS GENERALLY NORTH OF A LINE THAT RUNS ALONG THE CENTER OF ELECTRIC AVENUE FROM GLENN DALE ROAD TO WALNUT AVENUE, THENCE ALONG THE CENTER OF WALNUT AVENUE TO MARYLAND STREET, THENCE ALONG THE CENTER OF MARYLAND STREET TO LINCOLN AVENUE, THENCE ALONG THE CENTER OF LINCOLN AVENUE TO CRESCENT AVENUE, THENCE ALONG THE CENTER OF CRESCENT AVENUE TO ELM STREET, THENCE ALONG THE CENTER OF ELM STREET TO BALTIMORE LANE, THENCE ALONG THE CENTER OF BALTIMORE LANE TO ANNAPOLIS ROAD.

(6) THAT PART OF ELECTION DISTRICT 20, PRECINCT 9 THAT IS GENERALLY SOUTH OF A LINE THAT RUNS ALONG THE CENTER OF ELECTRIC AVENUE FROM GLENN DALE ROAD TO WALNUT AVENUE, THENCE ALONG THE CENTER OF WALNUT AVENUE TO MARYLAND STREET, THENCE ALONG THE CENTER OF MARYLAND STREET TO LINCOLN AVENUE, THENCE ALONG THE CENTER OF LINCOLN AVENUE TO CRESCENT AVENUE, THENCE ALONG THE CENTER OF CRESCENT AVENUE TO ELM STREET, THENCE ALONG THE CENTER OF ELM STREET TO BALTIMORE LANE, THENCE ALONG THE CENTER OF BALTIMORE LANE TO ANNAPOLIS ROAD.
