

a deed of conveyance therein mentioned; the bill, entitled, An act to authorize Richard Lockwood, of Cecil county, to remove two slaves from the state of Delaware into the state of Maryland, severally endorsed "will not pass." Also the resolution requesting the president of the United States to cause a survey to be made to ascertain the practicability and expense of a canal from the Chesapeake and Ohio canal to the basin of Baltimore, endorsed "assented to." Also the resolution relative to the colonization society, endorsed "will pass with the proposed amendments;" which were read and assented to.

The clerk of the senate returns the resolution relative to repairing arms; the resolution relative to the sale of notes in the treasury; and the resolution in favour of John J. Brooke, esq. severally endorsed, "assented to." Also returns a bill to authorize the keeping of gates on the public road therein mentioned in Montgomery county, endorsed "will not pass." Also the bill to authorize the levy court of Anne-Arundel county to levy a sum of money on said county for the use of Jeremiah L. Boyd of the city of Annapolis, endorsed "will pass." Ordered to be engrossed.

Also delivers a bill, entitled, A supplement to the act, entitled, An act declaring the power of the governor in certain criminal cases, endorsed "will pass;" referred to Messrs. Goldsborough, Maxcy and Barnes.

On the second reading of the act supplementary to an act to regulate lotteries, Mr. Speed moved to strike out the words following: "and over and above the said salary, the said commissioners shall be entitled to receive a per centage upon the net proceeds of the state lotteries, so far as the said net proceeds shall exceed the sum of thirty thousand dollars in the year, counting from the thirtieth day of November in each year; and beginning from the thirtieth day of last November, at the rate of five dollars on every hundred dollars of the said net proceeds; provided, however, that the same, including the salary aforesaid, shall not exceed in any one year, three thousand dollars."
