

for Talbot county, fifty dollars; the clerk of Caroline county court, twenty dollars; the register of wills for Caroline county, ten dollars; the clerk of Dorchester county court, seventy-five dollars; the register of wills for Dorchester county, fifty dollars; the clerk of Somerset county court, seventy-five dollars; the register of wills for Somerset county, fifty dollars; the clerk of Worcester county court, seventy-five dollars; and the register of wills for Worcester county, fifty dollars.

And be it enacted, That such of the said officers who do not consent to, and shall not comply with, the provisions of this act, shall be bound by the several provisions contained in the above recited acts, in the same manner as if this act had not passed.

And be it enacted, That all acts, and parts of acts, inconsistent herewith, be and the same are hereby repealed."

Mr. Thomas moved to refer the whole to the first day of June next? Resolved in the affirmative.

By the House of Delegates, March 3, 1826.

Gentlemen of the Senate,

As the session is rapidly drawing to a close, and as we are extremely desirous that the important subjects of the honourable Jno. C. Weems's communication, referred to in a former message, may be brought before the legislature, by the joint committee proposed in that message, we respectfully beg leave to call the attention of your honourable body to that communication, and to our message relative to it, and to beg that you will, at your earliest convenience, signify to us your assent to, or disagreement with, our proposition for a joint committee.
