On motion by Mr. Ridout, the 18th rule was altered so as to read—
'All conferrees and committees shall be appointed by the speaker, unless otherwise directed by the house.'

On motion by Mr. Spencer, the words 'under the penalty of such fine as may be imposed by the speaker, not exceeding _____ dollars,' were stricken out of the 29th rule.

On motion by Mr. Eccleston, the question was put, That the 31st rule be stricken out? Determined in the negative.

On motion by Mr. Ridout, the words 'and executive council,' were added to the 42d rule.

Mr. Kennedy moved to reconsider the 15th rule? Determined in the negative.

The question was put, That the house assent to the rules as amended? Resolved in the affirmative.

Mr. Barnes reports a bill for the relief of the executors, in Maryland, of William Murdoch of London, deceased.

And Mr. Tyson reports a bill, entitled, An act to incorporate the Lafayette Beneficial Society of Baltimore.

Mr. Thomas presents a petition from sundry inhabitants of Cecil county, residing in Port Deposit, and its vicinity, praying that the levy court of Cecil county may be required to alter and improve a road leading from said village to "Chesapeake;" referred to Messrs. Thomas, Grubb and Harlan.

Mr. Garner presents a petition from Mary Ann Clements, of Charles county, for support; referred to the standing committee on similar petitions.
