Ordered, That the committee on internal improvement lay before this house, as early as practicable, all information in their possession, and within their reach, respecting the origin, progress, and present state of the Chesapeake and Ohio Canal Company, so far as the said information may be beneficial to this house.

Mr. Hughes obtained leave to withdraw the petition of the trustees of Concord meeting house.

The clerk of the senate returns the resolution relative to the election of the council, endorsed, "assented to with the proposed amendments;" which amendments were read and assented to.

Mr. Stevens presents a report from the state's agent for the eastern shore; referred to the committee of ways and means.

Mr. Kennedy reports a bill, entitled, An act granting to the state of Pennsylvania, the right to cut a canal from the Maryland line.
