

FENDALL, Philip Richard (? - ?). His brother John Fendall d. Chas. Co., 1763; m. at St. Paul's, King George Co., Va., 24 Sept. 1751, Sarah Alexander. His 2nd wife was evidently Elizabeth Steptoe, dau. of Col. James and Hannah (Ashton) Steptoe of "Homany Hall", Westmoreland Co., Va., who m. (1) by 1763 Philip Ludwell Lee (1726-1775), nephew of Philip Lee (cl681-1744), Fendall's grandfather. He is alleged to have m. (3) Mary Lee, b. 9 Jul. 1764; d. Alexandria, D.C., 10 Nov. 1827, dau. of Col. Henry and Lucy (Grymes) Lee and granddaughter of Henry Lee (1691-1749) the brother of Philip Lee (cl681-1744). Or was Mary Lee the wife of Fendall's nephew, another Philip Richard Fendall (d. 1820) son of Fendall's brother Dr. Benjamin Fendall (d. 1820)?

FENWICK, Ignatius (d. 1784). His brother Capt. James Fenwick d. 3 Feb. 1806; his son James Fenwick (d. 1823) m. Chas. Co., 14 Feb. 1786, Henrietta Mary Lancaster; his son Thomas Fenwick m. Wash. DC 12 Oct. 1802 Nelly Young.

FITZHUGH, William (cl1722-1798). His mother Mary Mason was granddaughter of Gerard Fowke (1625-1669) and niece of Gerard Fowke (1662/63-cl1734/35). He m. (1) 28 Mar. 1740 Martha Lee (cl1716-1751), widow of Col. George Turberville and dau. of Richard and Martha (Silk) Lee of London, England, and niece of Philip Lee (cl681-1744). He m. (2) 7 Jan. 1752, Ann Frisby, widow of, etc.

FITZHUGH, William, Jr. (1761-1839). His unnamed dau. m. Gerritt Smith (1797-1874) who was a member of Congress from New York, 33rd Congress, 1853-1854.

FORREST, Uriah (1746-1805). His sister-in-law Ann Plater who m. Philip Barton Key (1757-1815) d. Georgetown, D.C., 18 Dec. 1834. Key was member of Congress from Maryland 1807-1813. Forrest had a dau. Elizabeth who m. at Woodley, 30 Jun. 1814, Upton Scott Reid; his dau. Maria m. at Rosedale, 13 Nov. 1817, Lt. John Tayloe, U.S.N.

FOWKE, Gerard (1625-1669). He was transported to Virginia by his brother Thomas in 1654.

FOWKE, Gerard (1662/63-cl1734/35). His dau. Catherine Fowke (1694-) m. Ebsworth Bayne or Bean son of John Bayne (cl662-1701).

HAMMOND, John (1735-1784). He died between 14 and 20 Jan. 1784 (Gleanings from Md. Newspapers, 1776-1785, p. 21).

HANSON, Alexander Contee (1749-1806). His son Charles Wallace Hanson (cl1784-) m. Rebecca Dorsey Carnan; his dau. was Mary Jane Hanson who d.s.p. Annapolis 4 Dec. 1815 and who m. 16 Mar. 1815 Thomas Peabody Grosvenor (1778-1817), member of Congress from New York 1813-1817.
