# TURNER

Thomas Turner, St. Winifred, St. Mary's Co., Oct. 2, 1662, "Whereas there is an Estate Due to me in the Kingdom of England & lying in several parishes about and in Essex (as may appear by my father's will)... I give to my Sonne Thomas Turner".

#### **UBBEN**

Barnard Ubben "Subject to the States of Holland having transported himselfe wife and children" was issued on February 17, 1662/3, patent of Denization.

## UNDERWOOD

Anthony Underwood clerk to Barrister Robert Rideley on March 1, 1687, declared at court that he served councilors-at-law at Gray's Inn prior to his Maryland settlement. The family was registrants at the 1633-35 Visitation of London.
