

## SENATOR MALOY A BENEDICT

He Weds Miss Matilda F. Backus  
At Pro-Cathedral.

William Milnes Maloy, State Senator from the Third legislative district of Baltimore city, and Miss Matilda F. Backus were married yesterday morning at the Pro-Cathedral. The ceremony was performed by Rev. Thomas Atkinson, who was the first pastor of the bride.

Mrs. Maloy is the daughter of the late Justus and Fredericka C. Backus, and a sister of Mrs. Charles Schorr, 3011 East Baltimore street, with whom she made her home. The bride is a graduate of the Eastern High School, class of '99. She is an accomplished instrumentalist and vocalist, having studied voice culture under Prof. Pietro Minetti, of the Peabody, for several years, and has been the organist at the Church of the Holy Evangelists and the Church of the Epiphany, a member of the choir at East Baltimore Station Methodist Episcopal Church and is now a member of the choir of Emmanuel Protestant Episcopal Church.

The groom is a son of Mrs. Margaret Hopkins Maloy and of the late Rev. William C. Maloy, a Presbyterian minister. He is a graduate of the City College, of the law department of the University of Maryland, and holds a master's and doctor's degree from the Catholic University of America, in Washington. Mr. Maloy has been active in politics, was a member of the House of Delegates in 1908 and is now a member of the State Senate.
