Francis DeSales Mudd graduated from the Catholic University (D.C.) in 1931. The 1947 Georgetown U. (D.C.) Alumini Directory refers to him as receiving his LLB at, Georgetown in 1933. He was Supt. of the State Bureau of Immigration; in 1942 he was practising law with his father (Mudd & Mudd) in LaPlata, Md.; and in 1946 he was attorney for the Board of Charles County (Md.) Commissioners.

Patrick Conroy Mudd was a Staff Sergeant in the U.S. Army during World War #2. He entered active service in May 1941; he was assigned to the 3d Cavalry on duty at Ft. Meyer (later on duty at Ft. Oglethrope, Ga.); was transferred to Hqts. Co. 3d Bn. of the 11th(?) Armored Regiment at Ft. Benning, Ga.; he was promoted to Sergeant in 1942; he sailed for overseas duty on 9-13-1944; he was reported as missing in action" on 12-21-1944 while serving in a tank unit of the 10th Armored Division in Belgium, later, however, it was reported that he was captured by the German Army in Luxembourg and was liberated 4-13-1945; he was honorably discharged on 9-13-1945. In 1949 he was County Clerk, Chas Co., Md.

In 1941 she was employed by the Agricultural Department in Wash., D.C.; and later, in 1945, was secretary to the Director of the Office of Scientific Research and Development, War Production Board.

In December 1946 Mary Helen Mudd was a student at the Maryland Art Institute in Balto., Md.

John Francis Mudd received his AB degree from St. John's College in Annapolis, Md. in 1904, and his LLB degree from the University of Maryland Law School in 1907. The 1947 Georgetown University Alumni Directory refers to him as a student in the law school in 1907. Soon after he passed his State Bar Examination he became a member of a law firm headed by Chief Judge Walter J. Mitchell of the Seventh judicial district. As a defense attorney he won a reputation in criminal law. In 1908 and 1909 he was the editor of the LaPlata, Md. weekly newspaper; in 1911 he was a member of the House of Delegates (Maryland); in 1912 and 1913 he was a member of the Maryland Legislature; from 1914 to 1920 he was State Senator; from 1916 to 1920 he was a member of the State Roads Commission; in 1923 he was the state Republican candidate for Circuit Court Judge; in 1924 he was the State Racing Commissioner; and in 1944 was the editor of the Times-Crescent newspaper in LaPlata, Md. He was (1945) a member of the State Bar Association and a member of the K. of C. Prior to his death he was in law practise with his son F. DeSales Mudd.
