Nov. 12, 1917 Transcript of Record from the Circuit Court for Anne Arundel County received and filed to charge murder, issue joined, January 23 1918 court direct the Sheriff to summon thirty talents, Simpson, John A. Koerner, William St. James, Mrs. E. J. Goff, Judge Huebler, Wm. St. Holter, George C. Miller, R. C. Lee, J. B. Stealey, J. Schmidt and Edmund A. Brooke. (Judge Duncan) January 31 1918 - 9:30 P.M. Verdict guilty of Murder in the first degree. February 1st 1918 motion for a new trial with reasons filed. February 13 1918 affidavit of Ella Bush Murray filed. February 13 1918 affidavit of A. J. Brady, Atty. filed. February 13 1918 motion for a new trial overruled. Exception noted. February 13 1918 John Snowden the prisoner was asked by the Court if he had anything to say before the sentence of death should be passed upon him and he answered "I am not guilty." February 13 1918. It is the judgment of the Court that John Snowden be delivered by the Warden of the Baltimore County Jail to the Sheriff of Anne Arundel County and there be safely kept in the jail of Anne Arundel County until such time as the Governor of Maryland shall appoint, when a jury shall be taken there by the Sheriff of Anne Arundel County, and hanged by the neck until you are dead, and may God have mercy on your soul. Duncan to the Judges of the Court of Appeals of Maryland filed. September 24 1918 Bill of Exceptions filed. January 23 1919 mandate from the Court of Appeals of Maryland received & filed. 1918 Nov. 18th motion for dismissal filed. 1918 Nov. 20th motion for dismissal filed. 1919 January 16th motion to dismiss appeal denied and judgment affirmed with costs.
