

JUDGE C. GUS GRASON SUCCEUMBS HERE AT 71 YEARS

County's Grand Old Man Had Distinguished Career

Judge C. Gus Grason, Baltimore County's grand old man and one of Maryland's most distinguished jurists, died peacefully Thursday afternoon at Cottage Manor, a nursing home near Lutherville.

Judge Grason was 71 and had been in failing health since his retirement from the bar on his 79th birthday—Nov. 8, 1951.

A member of one of Maryland's most prominent families, Gus Grason was born on Dulaney Valley Road in Towson and spent his entire life close to the spot where he grew up.

Chief Judge

Until he retired, Judge Grason had been a member of the Maryland Court of Appeals since 1942, and formerly was chief judge of the Third District Circuit Court to which he was appointed in 1922.

Judge Grason came from a long line of distinguished jurists. His father, John Grason was once state's attorney for Baltimore County and his grandfather, Richard Grason was once chief judge of the Circuit Court. His great-grandfather, William Grason was Governor of Maryland.

Trial Lawyer

In his younger days, Judge Grason was renowned for his ability as a trial lawyer. Possibly his most famous case was in the 1920's when he defended Walter Socolow in the notorious Norris murder trial which was later transferred from the city to the county courthouse.

Judge Grason was a lifelong member of Trinity Protestant Episcopal Church in Towson. Funeral services will be held there either Saturday or Sunday at 3 P.M. with interment in Prospect Hill.

Judge Grason is survived by his wife, Muriel Powers Grason; two sons, Powers and Richard Grason; and a daughter, Mrs. Lella Lyons.

Seminary Ave. Extension Bid Is Approved

The Board of County Commissioners, this week approved a contract for the extension of Seminary avenue from the York Road to the Dulaney Valley Road.

Michael J. Birmingham, President of the Board, announced that the contract for the work has been awarded to the Crest Contracting Company, Inc., of Baltimore, on the low bid of \$94,800.35.

Mr. Birmingham pointed out that this will cover the entire cost of the project, including draining, paving and the installation of necessary drainage facilities.

The new piece of road, roughly a mile in length, is expected to relieve some of the congestion at the intersection of York road and the Dulaney Valley road in Towson, by making it possible for motorists to get from one road to another without coming into town.

Work on the new roadway is expected to get underway in the immediate future. In addition to furnishing a much needed link between two main highways, the extension of Seminary avenue is expected to open up a new suburban area for development.

County To Create Review Board As Check On School Spending

The Baltimore County Board of Education has agreed to submit all plans for new school buildings to a Board of Architectural Review, to be created under a proposed amendment to the Public Work Law, it was revealed this week by Michael J. Birmingham, President of the Board of County Commissioners.

The proposal amendment, setting up the review board, was sponsored by the County Commissioners at the suggestion of the Department of Public Works.

Mr. Birmingham said that he had consulted with Edward Guy Stapleton, Superintendent of Schools and Morris R. Baker, Chief Engineer for the Department of Education, and found them "not only agreeable to, but enthusiastic over the proposed change in the law."

However, Mr. Stapleton said yesterday that he had apparently been misquoted on the subject.

Voluntary Board To Benefit Polio

"The board of review the School Board has in mind would require no legislation or amendments," Mr. Stapleton said. "We are not interested in changing the Public Works Law, but we would be willing to have a voluntary review board set up which could make recommendations on school plans to the chief county engineer or to Morris R. Baker, chief engineer for the Board of Education," Mr. Stapleton continued.

"The county commissioners and the School Board would have no difficulty, I believe, in agreeing on who would serve on this Board of Architectural Review, but neither the County nor the School Board would be bound by law to accept the board's suggestions," Mr. Stapleton concluded.

The Board of Architectural Review will pass on all plans for county buildings of every kind, including all public school buildings,

ly Commissioners and the School officials to govern the future construction of new schools in the county.

Under the new working agreement new in effect between the Commissioners and the School Board, every step in the planning of new schools is checked twice by the Department of Public Works, and it is not until after final revision of plans have been made and approved, that the County Commissioners approve advertising for bids for the new construction.

Sweetheart Ball To Benefit Polio


