

George Moore Brady, prominent Baltimore attorney and member of the bar since 1903, died at noon yesterday in the Union Memorial Hospital after three weeks of ill-

Mr. Brady was senior partner in the firm of Brady, Jones & Hed-rick and began his law practice here in 1904 with the late William Milnes Maloy, former State Sena-tor who sought the Democratic continuities for decoration in 1626

The formation of the democratic nomination for governor in 1926. He graduated from the Loyola College in 1900, later receiving a law and philosophy degree from Georgetown University. He was also a graduate student of the Catholic University and held the degrees of master of laws and doc-tor of jurisprudence tor of jurisprudence.

Aided Hospital

Although he twice filed for the Supreme Bench, in 1934 and again in 1938, Mr. Brady never held public office. In later years his civic interest was concentrated on the Children's Hospital, which he served as counsel and board mem-ber, and the Children's Rehabilita-tion Institute.

tion Institute. During World War I Mr. Brady. served the War Shipping Board in the Baltimore and Norfolk areas and after his return to practice the original Maloy & Brady firm Was joined by John S. L. Yost, present general counsel for the Panhandle Eastern Pipeline Com-pany, and by Roger Howell, at present dean of the University of Maryland Law School. Survivors Listed
