William A. Swisher, the state's attorney, won renomination to a second term after piling up a comfortable lead over

two opponents last night.

In a separate Courthouse contest, Saundra E. Banks appeared well ahead in a field of six hopefuls for the clerkship in the Court of Common Pleas, apparently defeating J. Randall Carroll, the incumbent clerk.

Robert R. Weed was unopposed for the Republican nomination for state's attor-

ney. Judges up for election this year are Milton B. Allen, Solomon Baylor, Shirley B. Jones, Joseph H. H. Kaplan and Edgar P. Silver. One Baltimore lawyer, Leonard J. Kerpelman, sought a seat on the bench, but he ran far behind in last night's vote

counts. The judges had moved early to head off opposition. The five sitting judges offered an experienced, balanced ticket for election to the 15-year term. Judge Jones has

been on the bench for 16 years. The other judges are known in the legal community. Judge Baylor and Judge Sil-ver served on the District Court. Judge Allen is a former state's attorney, and Judge Kaplan had been active in public causes before his appointment to the bench.

In the race for clerk of the Court of Common Pleas, Mr. Carroll faced opposi-tion from Mrs. Banks, Roland G. Baker,

A Republican, John W. Reed, Jr., was unopposed. Mr. Carroll, a black, had been opposed by an organized group of blacks. who support Mrs. Banks. Mrs. Banks's supporters claimed Mr. Carroll helped unseat Paul L. Chester, his former boss, who was convicted of malfeasance in office.

Three court clerkships and the register of wills were unopposed. In Superior Court, Robert H. Bouse, the incumbent, was leading William Allen and Elmer O. Harris was leading Robert E. Ayd for clerk of the Baltimore City Court, in incomplete returns.

For the office of sheriff, George W.

Freeberger, the incumbent, appeared an easy winner in race where he was challenged by seven other candidates. Four candidates were listed for judges

Vienna (AP)-Interior ministers from five nations met in a heavily guarded former palace yesterday for the second West European conference on combating international terrorism. It was the first time France was represented. West Germany, Italy, Switzerland and Austria met for the first time in April and agreed to continue the meetings. The conference was closed to the press.
