 Whereas Isaac Briggs, of George Town in the State of Maryland, the son of Samuel Briggs of Philadelphia & Mary his wife, having declared their intentions of taking each other in marriage before several Monthly Meetings of the people called Quakers in the County of the said State aforesaid, the proceedings of the said Isaac Briggs & Hannah Brooks after due enquiry & deliberate consideration were allowed by the said meetings they being cleared of all others & having consent of parents and relations. Now these are to certify whom it may concern, that for the accomplishing their said marriage, this twentieth day of the eighth month in the year of our Lord one thousand seven hundred & sixty four, they the said Isaac Briggs and Hannah Brooks appeared in a public meeting of the aforesaid people & others in their meeting house at Sandy Spring in the County of Montgomery aforesaid and the said Isaac Briggs taking the said Hannah Brooks by the hand did openly and volantly declare as follows before the Lord and in the presence of this assembly I take this my friend Hannah Brooks to be my wife promising with divine assistance to be to her loving & faithful husband until I shall separate us, & the said Hannah Brooks did then and there in the said assembly declare as follows before the Lord & in the presence of this assembly I take this my friend Isaac Briggs to be my husband promising with divine assistance to be to him loving & faithful wife until death shall separate us, and the said Isaac Briggs and Hannah Brooks according to the custom of Marriage assuming the name of their husband as a full confirmation thereof and in testimony thereto did then & there to these present set their hands
