You cannot but be aware, that the 3d article of the freaty of the peace of 1783, containing two distinct stipulations, the one recognizing the rights which the United States had to take fish upon the high seas, and the other granting to the U. States the privilege of fishing within the British jurisdiction, and, of using, under certain conditions the shores and territory of his majesty for purposes connected with the fishery; of these, the former being consider. ed permanent, cannot be altered or affected by any change of the rela-tive situation of the two countries; but the other being a privilege de-rived from the treaty of 1783 alone, was, as to its dufation, necessarily limited to the duration of the treaty itself. On the declartion of war, by the American Government, and the consequent abrogation of the then existing treaties, the U. States forfeited, with respect to the fisheries, those privileges which are purely conventional, (and as they have not been renewed by a stipulation in the present treaty,) the subjects. of the United States can have no pretence to any right to fish within the British jerisdiction, or to use the British territory for the purposes connected with the fishery. Such being the view taken of the question of the fisheries as far as relates to the U. States,

I am commanded by his royal highness the Prince Regent to instruct you to abstain most carefully from any interference with the fishe ry, in which the subjects of the U-States may be engaged, either on the Grand Bank of Newfoundland, the Gulph of St. Lawrence, or other places in the Sea. At the same time you will prevent them, except under the circumstances hereinafter mentioned, from using the British territory for purposes connected with the fishing vessel from bays, haroours, rivers, creeks, and inlets of all his majesty's possessions. In case, however, it should have happened that the fishermen of the U. States, through ignorance of the circu stances which affect this question, should previous to your arrival, nave already commenced a fishery similar to that carried on by them previous to the late war, and should have occupied the British harbours. and formed establishments on the British territory, which should not be suddenly abandoned without very considerable loss, his royal highness the Prince Regent, willing to give every indulgence to the citizens of the U. States, which is compatible with his majesty's rights, has commanded me to instruct you to ab stain from molesting such fishermen or impeding the piogress of their hishing during the present year, unless they should, by attempts to carry on a contraband tiade, render, themselves unworthy protection or indulgence, you will however not fail to communicate to them the tenor of the instructions, which you have received, and the view which his majestys government takes of the question of the fishery, and you will, above all, be careful to explain to them that they are not in any future season to expect a continuance of the same indulgence.

REPUBLICAN MEETING. Chamber of the House of Repre-sentatives of the United States,
