From the Aurora. Democratic Republican Meeting. Agreeably to public notice, a numerous meeting of the democratic republicans of the city and county of Philadelphia, who are opposed to caucus nominations, assembled in the Town-Hall, in the Northern Liberties, on Monday afternoon last, the 26th August; and after discussion, unanimously adopted the following resolutions:

Resolved unanimously, That as citizens of Pennsylvania, we protest against the usurpation of certain members of the general assembly, in dictating to the freemen of this commonwealth, electors of president and vice-president of the United States; because no trust of that sort was conferred upon them by the people; because an essential attribute of a free state was violated by the assumption of a power not delegated; and because the people of this congressional district were not even nominally represented in the Harrisburgh caucus.

Resolved unanimously, That we have strong grounds for believing that the constitutional rights of the people have been infringed by the interference of the executive magistrate of the U. States in this selection of his successor; that the repeated elections of the secretary of state as successor of the president strengthen our belief; and that we consider any compromise made by members of congress, in collusion with the executive, or executive influence used to insure the selection of a successor, as having the most dangerous tendency in a republic.

Resolved unanimously, That as citizens of Pennsylvania, we protest against the usurpation of certain members of the general assembly, in dictating to the freemen of this commonwealth, electors of president and vice-president of the United States; because no trust of that sort was conferred upon them by the people; because an essential attribute of a free state was violated by the assumption of a power not delegated; and because the people of this congressional district were not even nominally represented in the Harrisburgh caucus.

Resolved unanimously, That this meeting accept the invitations of the democratic republicans of Lancaster county, to send delegates to a convention to be held at Carlisle on the nineteenth of September next, for the purpose of forming an electoral ticket, to be recommended to the suffrages of the democratic republicans of Pennsylvania.
