30 Sign Petition for His Reappointment As County Judge

Reappointment of George B. Merrick as police court judge is asked in a petition signed by 30 members of the Prince Georges County Bar Association and submitted to Goy. Herbert R. O'Conor, it was revealed yesterday.

The request is contingent on passage of legislation creating two judgeships in the county. Alan Bowie, former State's attorney, has already been named police justice under the present set-up and will succeed Judge Merrick if the pend-

succeed Judge Merrick if the pending legislation is not passed.

The petition lauds Judge Merrick's outstanding service since he was appointed by Gov. Nice in 1934. It also points out that appointment of Merrick, a Republican, will divide the honors equally between Democrats and Republicans and serve to keep the court system out of politics.

School Contract Let Upper Marlboro.—A contract for a new elementary school at Meadows was awarded by the Prince Georges Board of Education yesterday to Robert L. Blalock & Co., of Washington, on the firm's low bid of \$22,358. The contract is subject to approval of the PWA. The new school will contain three classrooms. The project is part of a \$400,000 school building program, financed in part by the Public Works Administration.
