PETITION

TO THE HONORABLE, THE JUDGE OF SAID COURT:

The Petition of James F. Price, Administrator of the Estate of Arthur B. Price, deceased, respectfully represents:

 That he was appointed Administrator of the Estate of Arthur B. Price, deceased, by this Honorable Court on January 10, 1958.

2. That on September 5, 1958, he filed a list of debts due to the decedent and through an oversight, a debt due the deceased from Paul Blum in the amount of \$14,170.23 (including interest), which was thought to be desperate at that time, was not included in the said list of debts. Said debt arose out of a decree in personam in the case of Arthur B. Price vs. Paul Blum in the Circuit Court of Baltimore City, Docket No. 90C, Folio 100.

3. That an amended list of debts due to the decedent has now been filed in the proceedings, which amended list of debts includes the debt due from Paul Blum.

4. That it has now come to the attention of your Petitioner that Paul Blum owns the legal title to a half interest in the property known as 3907 Cedardale Road, Baltimore, Maryland, which property has been sold under Contract of Sale by Paul Blum and the co-owner, at and for the price of \$8,000.00. 5. That after payment of unpaid balance of mortgage, ground rent, taxes and settlement expenses due from sellers, the net equity in the property at 3907 Cedardale Road in favor of Paul Blum and his co-owner, is slightly in excess of \$3,450.00.

6. That the co-owner of said property alleges that for the past three years, she has paid all of the expenses relating to said property, including taxes, and she maintains that out of the net equity of approximately \$3,450.00, she is entitled to reimbursement of her expenses advanced as aforesaid, and that after these expenses have been deducted, there will be little equity left for division between the two co-owners.

7. That the co-owner of said property has agreed not to litigate the question of her right to reimbursement of the expenses paid by her aforesaid if James F. Price, Administrator of the Estate of Arthur B. Price, deceased, will execute a waiver of lien as to property No. 3907 Cedardale Road upon receipt of \$1,500.00 out of the net proceeds of settlement.

8. That your Petitioner believes it is in the best interest of the Estate to accept this offer and prays the Court to pass an Order authorizing such settlement. AND, AS IN DUTY BOUND, etc.

INSTRUCTIONS

RETURN TO BE FILED:

A MARYLAND ESTATE TAX RETURN shall be filed for the estate of any decedent who at the time of his death was a resident of the State of Maryland, provided a Federal Estate Tax return is required on which credit is allowable against the Federal Estate Tax for estate, inheritance, legacy, or succession taxes paid to any State, Territory, or the District of Columbia. The MARYLAND ESTATE TAX RETURN shall be filed in duplicate by the Executor or Administrator with the Register of Wills of Baltimore City or of the County in which administration is had. The Register of Wills shall certify the original copy and forward it to the Comptroller.

PAYMENT TO BE MADE:

The amount of tax due as shown by the MARYLAND ESTATE TAX RETURN is payable to the Comptroller of the Treasury, Annapolis, Maryland, at the same time or times at which the Federal Estate Tax is payable. Check should be mailed directly to the Comptroller.

PROCEDURE IN FILLING OUT RETURN:

In order to facilitate the filling out of the return the procedure should be as follows:

- 1. Complete the Federal return.
- 2. Fill out Schedules A, B, C (where applicable), which are included herein. The purpose of Schedules A and B is to procure information which is also required in the Federal return, and the information furnished in these schedules must be in complete agreement with that given in the Federal return. The terms used in these schedules are for the most part the same as those used in the Federal return.
- 3. Fill out the section headed "Computation of Maryland Estate Tax." The terms used in this section are as defined in Article 62A of the Annotated Code of Maryland.

ADDITIONAL ASSESSMENTS OF TAX:

Additional Maryland Estate Tax resulting from the final determination of the Federal Estate Tax shall be reported in an amended return to be filed in duplicate with the Register of Wills with whom the original return was filed and any additional tax and interest shall be paid to the Comptroller at the same time or times at which the Federal Estate Tax is payable.

REFUND OF EXCESS PAYMENT:

In the event that upon final determination of the Federal Estate Tax, a decrease results in the Maryland Estate Tax, the executor or administrator of such estate shall file with the Comptroller an APPLICATION FOR REFUND OF THE MARYLAND ESTATE TAX (form M E T #2), which form will be supplied by the Comptroller upon request. Refunds found to be due shall be paid by the Comptroller as provided in Section 5 of Article 62A of the Annotated Code of Maryland.

PETITION AS TO ATTORNEY FEE

TO THE HONORABLE, THE JUDGES OF SAID COURT:

The Petition of James F. Price, Administrator of the Estate of Arthur B. Price, Deceased, respectfully shows:

1. The decedent, Arthur B. Price, died intestate on December 9, 1957, survived by his wife, Mary E. Price, and four children, Arthur B. Price, son, Audrey B. Toth, daughter, James F. Price, son, and David W. Price, son, as his next of kin.

2. The gross personal estate of the decedent being administered by the Administrator is \$172,355.03.

In addition, the said Arthur B. Price, deceased, owned a one-half interest in certain real estate in Baltimore County, which interest in said real estate was appraised at \$125,000.00.

Also, the husband and wife owned real property as tenants by the entirety, said real property having an appraised value of \$36,000.00; and also the said husband and wife held a joint interest in a mortgage due by the Lakewood Company in the amount of \$42,500.00.

3. The Administrator employed Allen, Burch & Allen, attorneys, of Baltimore, Maryland, to assist him in the administration of the estate.

4. Among the assets of the estate were ten shares of stock of Gwynn Oak Amusement Park, Inc., a closely held corporation, the same representing one-third of the outstanding shares of stock of said corporation. In addition the decedent owned 140 shares of stock of the Lakewood Company, also a closely held corporation, said shares of stock representing in excess of 25% of the outstanding stock of said corporation.

5. Francis B. Burch of the firm of Allen, Burch & Allen, prepared the Preliminary Federal Estate Tax Notice on Form 704 and also prepared the U. S. Estate Tax Return on Form 706 for the Estate of the decedent, the Federal Estate Tax being calculated to be approximately \$35,890.39. The return on Form 706 involved the calculation of the Maryland deduction which took into account the widow's onethird interest as an intestate heir, the widow's other property acquired as survivor of her husband and also the widow's interest in certain insurance policies on the life of her husband. This necessitated appraisals of the aforesaid real property as well as an appraisal of the property of the Lakewood Company, 140 shares of the stock of which Company was owned by the decedent. In determining the value of the closely held stock of the Lakewood Company and Gwynn Oak Amusement Park, Inc. which was owned by the decedent it was necessary for Francis B. Burch, attorney, to consult with the certified public accountant who had represented the said Arthur B. Price during his lifetime and to obtain and analyze various profit and loss statements and balance sheets of said corporations.

6. The said Francis B. Burch also assisted the Administrator in the preparation of the real and personal

inventories which were filed among the papers in this case and after the filing of said inventories he prepared a petition for reappraisal of the stock of the Lakewood Company in order to correct an erroneous statement of the book value of the said stock as of the time of the death of the said Arthur B. Price, deceased.

7. The said Francis B. Burch also prepared miscellaneous petitions in the within proceedings relating to the payment of funeral expenses, retention of assets, etc.

8. The Administrator is about to file his first administration account in which he will ask the Court for authority to retain certain assets for future accounting to take care of contingencies and awaiting the audit by the proper authorities of the Federal Estate Tax Return and Income Tax Returns to be filed hereafter.

9. The Administrator intends to waive commissions, except an amount sufficient to pay the State of Maryland the tax on commissions. The Administrator would like to have this Honorable Court fix the compensation of Allen, Burch & Allen, attorneys for their services rendered to the Administrator. Mr. Burch has suggested an attorney fee of \$5,000.00 which is agreeable to the Administrator.

10. Allen, Burch & Allen have agreed that the said fee of \$5,000.00 will include services to be rendered in the future in the preparation and filing of additional administration accounts and any conferences and negotiations with the field representative of the Internal Revenue Service relating to the Federal Estate Tax Return to be filed by the Administrator.

TO THE END THEREFORE that an appropriate Order

On December 9, 1957 Arthur B. Price while viewing a television program was suddenly and unexpectedly seized with a heart attack and he died two hours later. At the time of his death Mr. Price was 72 years of age. Up until the moment of his sudden heart seizure Arthur B. Price had enjoyed excellent health and was quite active both in business and civic affairs.

As a matter of fact just about two months prior to his death he received his annual physical examination and was told he was in excellent physical condition.

Arrangements had been made by Mr. and Mrs. Price to leave on December 10, 1957 for their annual trip to Florida. The death of Mr. Price, of course, caused a cancellation of these plans. Some several months prior to his death Mr. Price had offered to purchase a residence in Florida, but having been unable to negotiate a satisfactory price the purchase was not effected.

On December 27, 1956 Arthur B. Price made gifts to each of his four children, Arthur B. Price, Jr., David W. Price, James F. Price and Audrey Price Toth, each gift being an assignment of \$6,000.00 of an account receivable which he had against The Lakewood Company, a portion of the stock of which was owned by him. This gift was one of many gifts which over the years he made to his children during his lifetime. The purpose behind his gifts over the years was to give to his children during his lifetime a sense of security and independence and to himself the pleasure of seeing his children enjoy the gifts he made to them.

Examples of other gifts made by Arthur B. Price to his four children may be noted in his gifts to each of 15 shares of the capital stock of The Lakewood Company at a value of \$3,041.55 in the calendar year of 1952 and a like gift to each child in the calendar year 1953. Other gifts of lesser amounts of cash or property were made by Arthur B. Price to his children in years prior to 1952 and in the years 1954 and 1955.

It should be also noted that the 1956 gifts did not constitute a material part of the property of Arthur B. Price in that the said Arthur B. Price at such time was possessed of real and personal property in an amount in excess of \$ **30**,000 while the said gifts of \$6,000.00 to each of his four children represented a very small part of his property.

For the above reason it is submitted that the gifts in question are not subject to the Maryland lineal inheritance tax as gifts made in contemplation of death.


