CHAPTER NO. 281

A BILL ENTITLED

An Acr to amend the Constitution of Maryland by adding a new section to Article 4.

- 1 Section 1. Be it enacted by the General Assembly of Mary-
- 2 land, three-fifths of all the members of both Houses concurring,
- 3 That the following section be and the same is hereby proposed
- 4 as an amendment to the Constitution of the State of Maryland,
- 5 and if adopted by the legal and qualified voters thereof, as
- 6 hereinafter provided, the same shall stand as an additional
- 7 section to Article 4 of said Constitution, to follow Section 31,
- 8 and to be known as Section 31A.
- 1 31A. In addition to the authority granted to the Mayor
- 2 and City Council of Baltimore by the preceding section to pay
- 3 to each of the Judges of the Supreme Bench the annual sum of
- 4 five hundred dollars, authority is hereby given to said Mayor
- 5 and City Council to pay to each of said Judges such further
- 6 annual sum as an addition to their respective salaries as the
- 7 Mayor and City Council of Baltimore shall from time to time
- 8 deem right and proper, provided, that any such sum being once
- 9 granted shall not be diminished during the continuance of said
- 10 Judges in office.

- 1 Sec. 2. And be it further enacted, by the authority afore-2 said, That the said foregoing section hereby proposed as an 3 amendment to the Constitution shall be at the next general
- 3 amendment to the Constitution shall be, at the next general
- 4 election for members of the General Assembly to be held in
- 5 this State, submitted to the legal and qualified voters thereof,
- 6 for their adoption or rejection, in pursuance of the directions
- 7 contained in Article 14 of the Constitution of this State; and
- 8 at the said general election the vote on said proposed amend-
- 9 ment to the Constitution shall be by ballot, and upon each bal-
- 10 lot there shall be written or printed the words "For the Con-
- 11 stitutional Amendment," and "Against the Constitutional
- 12 Amendment," so that the voter may elect; and immediately
- 13 after said election due return shall be made to the Governor of
- 14 the vote for and against said proposed amendment, as directed
- 15 by the said 14th Article of the Constitution.
