From the Office of the Executive Director

A HISTORY OF THE MARYLAND POLICE AND CORRECTIONAL TRAINING COMMISSIONS

The Maryland Police and Correctional Training Commissions began life as the Police Training Commission on 1 June 1966. Mr. Robert L. Van Wagoner, a retired FBI agent, was appointed as the Commission's first Executive Secretary, later re-titled as Executive Director. The Commission's primary responsibility was to establish and regulate minimum standards for law enforcement training in Maryland.

PART I THE EARLY YEARS: 1966 - 1982

The agency's first home was in a small office building on Church Lane in Pikesville, Maryland. With a reorganization of the Executive Branch of State government in 1970, the Police Training Commission became a component of the Department of Pubic Safety and Correctional Services, where it has remained to this day.

In the following years, the agency grew and staff expanded. With enabling legislation in 1971, the Commission was empowered to establish minimum selection standards for state law enforcement officers.

In 1971, the Maryland General Assembly enacted legislation creating the Correctional Training Commission and combined it with the Police Training Commission, creating dual commissions—Police and Correctional under Executive Director Van Wagoner, using the same limited staff, budget, and office facilities.

The new Correctional Training Commission, with identical regulatory powers as the Police Training Commission, established minimum training and selection standards for Maryland correctional officers, along with State parole and probation officers. Despite the added correctional role, the agency continued to be known as the "Police Training Commission."

In its formative years, the Commissions had no training facilities of its own and had to rely entirely on client agencies, National Guard armories, local colleges, and others. Funding was primarily from federal grants and professional instruction was provided by personnel from client agencies and the FBI.

Between 1966 and 1974, the Police Training Commission launched several innovative training initiatives, which included mandated training courses for police supervisors and administrators; police manager and chiefs' seminars; a police instructor's course; traffic safety and radar enforcement courses; drug abuse seminars; and a Training Directors' Workshop.

By 1975, the agency had officially become known as the Maryland Police and Correctional Training Commissions.

HISTORY

Although the two Commissions were separate and distinct, both continued to operate under a single budget and both were administered by the same Executive Director and the same staff.

The following year, the Police Training Commission had grown to 14 members and the Correctional Training Commission consisted of 13 members. The offices in Pikesville comprised 29 employees and continued to serve both Commissions.

By this time, limited office space and lack of training facilities had become a serious problem. The most desirable solution was for a central facility in which both Commissions could perform their regulatory and training functions. In the interim, however, a larger facility for the administration staff was an immediate and pressing need.

An abandoned US Army NIKE missile site in the Granite community in western Baltimore County was considered as a suitable location for the Commissions' administrative offices. In January 1976, the federal government agreed to deed this property to the State at no cost and State funds were later allocated to conduct an architectural and engineering study of the site.

The agency encountered its first legislative challenge during the 1977 General Assembly, when a State budget committee reported that the Commissions had exceeded their legal mandate by providing direct training services, rather than "their primary role of curriculum development and standard setting."

The budget committee then recommended that this Commission training function be phased out and that actual police and correctional training should be conducted by those agencies themselves. The Commissions vigorously opposed this recommendation and eventually prevailed during committee hearings in September 1977. Crucial assistance was provided by numerous law enforcement and correctional officials who testified on behalf of the Commissions.

Their zealous defense of this critical prerogative was a milestone in the early history of the agency as it aggressively reaffirmed and legally established its twofold mission as both regulatory and training. Providing direct professional training would continue to remain an integral and important function of the Maryland Police and Correctional Training Commissions. This episode also cemented the partnership between the Commissions and the client agencies it serves.

The installation of a centralized records system with capability of tracking compliance with the Maryland Police Training Act was a positive development during 1978. This was crucial to the regulatory function of the Police Commission as this new system

could track attendance in mandated entry-level, inservice, and firearms training of all police and security personnel covered by this legislation.

In June 1980, Commissions' offices and staff moved to their newly-renovated facility, the former NIKE site at 3085 Hernwood Road in Granite. Correctional training which had formerly been conducted at a state prison in Jessup, was now centralized at the new location. This 27 acre site, with approximately 16,500 square feet of office, classroom, and storage space is the present home of the Training Commissions.

In May 1981, the Commissions' Executive Director since inception, Mr. Robert Van Wagoner, retired from State service. Mr. John A. Schuyler, the Assistant Executive Director for Administration and Enforcement was appointed Acting Executive Director. In September 1981, Donald G. Hopkins was appointed as Assistant Executive Director for Training.

In January 1982, legislation titled: the Police Officer Certification Act was passed in the Maryland General Assembly authorizing the Police Training Commission to certify, re-certify, revoke, or suspend certifications of individuals as Maryland law enforcement officers. This accomplishment added significant oversight and enforcement authority to the Commission's police regulatory function.

Failure to drive in a single lane probable cause to stop vehicle

When may police stop motorists for failing to drive in a single lane (Md.Code, Transportation Article, §21-309(b))? Brian Dowdy was stopped a few minutes before midnight by a Maryland State Trooper, while driving on a 4-lane highway with the 2 east- and west-bound lanes were divided by a grass median. The trooper observed Dowdy's vehicle drift from side to side in the right west-bound lane, and twice saw Dowdy's vehicle move from the right lane across the broken line into the left lane, each time passing one quarter of its width into the left lane for a tenth of a mile. After stopping Dowdy for failing to drive in a single lane, the trooper smelled alcohol and noted Dowdy's face was flushed and speech was slurred. Dowdy failed field sobriety tests, and was arrested for DWI. A search incident to arrest turned up 2 marijuana baggies and a pipe. Dowdy was convicted of violating §21-309(b), and DWI and CDS offenses.

At his suppression hearing, Dowdy argued police lacked probable cause to stop him based on the totality of the situation, because his driving across the center of 2 westbound lanes twice did not violate §21-309(b). Dowdy based his argument on Rowe v. State, 363 Md. 424 (2001)(no violation of §21-309(b), where driver momentarily crossed the white line on the shoulder side of the road, because there was no unsafe lane change or unsafe reentry onto the road). However, the court distinguished *Rowe* by noting that Dowdy crossed from the slow lane to the passing lane and remained there for a tenth of a mile, twice, and that his erratic driving created a potential danger to anyone in the passing lane. The court found more similarity with a case decided after Rowe (Edwards v. State, 2002 WL 3405587 (March 5, 2002)), where it held the motorist was properly stopped for violating §21-309(b) when he crossed the center line. So under current Maryland law, police may have probable cause to stop motorists for violating §21-309(b) for crossing the center line into an oncoming travel lane or for crossing into a passing lane, but *not* for crossing onto the white shoulder line. Dowdy v. State, 2002 WL 857572 (May 7, 2002).

Search warrant - probable cause

Police suspected Brian Covell of selling drugs, and obtained warrants to search Covell's person, home, and car. Douglas Holmes, Covell's friend, got caught in police surveillance of Covell when he and Covell were seen going in and out of their respective parents' homes (who lived on the same street), repeatedly

glancing around suspiciously, and engaging in what appeared to be a hand-to-hand drug transaction on a corner near the parents' homes. When Covell and Holmes were stopped, police saw a plastic baggie of marijuana in Holmes' jacket pocket and found a large amount of money on him. Holmes was arrested, and a crowd started to gather on the street to watch. Police took Holmes and Covell back to Holmes' father's house, and decided to get search warrants for both parents' homes. Police did a protective sweep of, and then secured, both homes. They kept Holmes and Covell at Holmes' father's home while they obtained the warrants. In the warrant affidavits, police mentioned a safe they had seen in a closet while doing the sweep, and that it may hold evidence. A search of Holmes' father's home pursuant to the warrant produced drugs, paraphernalia, and weapons. Holmes challenged the validity of the initial entry into the home, and challenged the search warrant, arguing that police used their observation from the sweep in the affidavits (that they saw a safe) and the judge who issued the search warrant improperly considered this. The circuit upheld the warrant and its fruits, the Court of Special Appeals reversed.

The Court of Appeals resolved the matter by examining whether the warrant would stand even without reference to the safe, and concluded that it Mere police observation or suspicion of criminal activity will not establish probable cause that there is evidence in a suspect's home. There must be something more, either directly or by reasonable inference, that would justify a conclusion there is contraband in the home. Based on police observations and their knowledge of drug activity, the fact that the transaction occurred less than a block from the home and Holmes was in and out of the house before the transaction, and that he had drugs and money on him after the transaction, the Court found a sufficient link between police observations and the inference that evidence of illegal drug activity would be found in the home to support the issuance of the warrant (*Note:* The Court was careful to say it was not making a determination about whether there is enough PC for a search warrant on a home where an isolated drug transaction occurs some distance away from the home). Holmes v. State, 2002 WL 531489 (April 10, 2002).

LEOBR - standard of proof of disciplinary charges

Former Cpl. Charles Coleman was terminated by the Chief of the Anne Arundel County Police Department, pursuant to a recommendation from a hearing board convened in accordance with the Law Enforcement Officer's Bill of Rights (LEOBR).

The basis for the disciplinary proceedings arose from a sting operation after which it was discovered Coleman had retained money he should have processed as evidence. A primary issue Coleman raised on appeal was that, because Coleman's LEOBR hearing was on charges of theft-related violations of departmental rules, regulations, and procedures, the standard of proof should have been clear and convincing evidence, rather than the lower standard of preponderance of the evidence.

The Court of Appeals disagreed, and held that the preponderance of the evidence standard is the correct evidentiary standard to be applied in LEOBR proceedings, even where there are allegations of serious misconduct that could be heard in criminal court. The Court noted this standard makes for more efficient and understandable LEOBR proceedings, is beneficial where hearing boards are primarily comprised of non-lawyers, and produces a uniform system of police discipline throughout the The Court also concluded that LEOBR procedures satisfy due process because they adequately protect an officer against erroneous deprivation of his rights, and strike the appropriate balance between the accused officer's rights and the law enforcement officer's interest in maintaining discipline. Coleman v. Anne Arundel County Police Dept., 2002 WL 851801 (May 6, 2002).

U.S. Supreme Court - Americans with Disabilities Act - seniority

The Supreme Court has punched another hole in the umbrella of protections afforded employees by the Americans with Disabilities Act (ADA), this time on the issue of whether the ADA trumps employers' seniority systems. US Airways employee Barnett injured his back while he was a cargo handler for US Airways, and transferred to a less physically demanding position in the mailroom. Barnett's new mailroom position later was opened to seniority-based employee bidding under US Airways' seniority system, and employees with more seniority than Barnett planned to bid on his job. US Airways refused Barnett's request that it accommodate his disability by letting him remain in that job. Barnett lost the job, and sued under the ADA. The ADA prohibits an employer from discriminating against an individual with a disability who, with reasonable accommodation, can perform essential job functions, unless the employer can show the accommodation would impose and undue hardship on the operation of its business. Barnett alleged US Airways violated the ADA by refusing to give him a reasonable accommodation when it did not protect his job from the seniority system.

US Airways' position was that altering its seniority

system would result in an undue hardship to both the company and its non-disabled employees. The District Court agreed with US Airways, but the 9th Circuit reversed, holding that seniority system was just a factor in the case-by-case undue hardship analysis.

The Supreme Court ruled in favor of US Airways, holding that an employer's showing that a requested accommodation conflicts with its seniority rules is ordinarily enough to show that an "accommodation" is not "reasonable." In other words, the general rule now is that seniority trumps the ADA, even if the accommodation would be reasonable otherwise. Employees are free, however, to show evidence of special circumstances justify the requested accommodation even if it conflicts with a seniority system. Employees could do this, for example, by showing that the employer unilaterally changes fairly often so employees have reduced expectations of seniority benefits, or by showing that the system already contains exceptions so that another exception would make little difference to the employer. US Airways, Inc. v. Barnett, 122 S.Ct. 1516 (April 29, 2002).

Workers' compensation - correctional officer playing basketball at detention center.

Off-duty correctional officer Smith injured his knees while playing basketball in the gym of the county detention center where he worked. Detention center employees are permitted to use the gym when they are off-duty so long as inmates are not using it; the County neither encouraged nor discouraged offduty use of the gym. The Workers's Compensation Commission ruled his injuries "arose out of and in the course of" the officer's employment, and ordered the County to pay. On the County's appeal, Smith submitted pages from the County manual that correctional officers such as Smith were required to have an extraordinary degree of physical fitness, and to complete periodic medical exams (once every 3 years). The County submitted an affidavit from the deputy warden of the detention center that, while correctional officers like Smith must undergo periodic physicals and fitness is encouraged, they are not subject to physical fitness testing, regulation, or evaluation after being hired. The County lost, and appealed the Court of Special Appeals.

The Court reversed, holding that Smith's injuries did not arise out of his employment. Smith was off-duty, and he was not engaged in activities incident to his duties as a correctional officer. His job

did not require or expect him to use the gym; the Court noted he could have exercised anywhere. Even if Smith's physical condition improved by using the gym, this did not establish injuries while playing basketball as "as arising out of employment" for making the County responsible for Smith's medical expenses. *Montgomery County v. Smith*, 2002 WL 1160198 (June 3, 2002).

U.S. Supreme Court - prisoner litigation - exhaustion requirement

State prison inmate Nussle sued correctional officers in federal court under 42 U.S.C. §1983 (requiring government agent to pay money damages for constitutional violations), alleging a pattern of harassment and intimation, and a severe beating. The Prison Litigation Reform Act of 1995 (PLRA), 42 U.S.C. §1997e(a) requires that prisoners exhaust all available administrative remedies before bringing a civil action under §1983 with respect to prison conditions. The District Court dismissed Nussle's suit because he had not availed himself of administrative remedies available to Connecticut Department of Correction inmates, as required by the PLRA. The Second Circuit reversed, holding that exhaustion of administrative remedies is not required for the kind of claim Nussle asserted, saying that "prison conditions" covers only conditions that affect prisoners generally, not single incidents that affect only particular prisoners, such as excessive force by a correctional officer.

The Supreme Court reversed, holding that the PLRA's exhaustion requirement applies to all inmate suits about prison life, whether they involve general circumstances or particular episodes, and whether they allege excessive force or some other wrong. The Court noted that the present version of the PLRA was intended to reduce quantity and improve quality of prisoner suits, and to give correctional officials the chance to address complaints internally before a federal case is filed; in some situations, corrective action may be taken in response to an inmate grievance that would remove need for litigation. The Court also declined to differentiate which kinds of cases are subject to the exhaustion requirement based on how many inmates are affected or based on the type of claim; therefore, "prison conditions" in the PLRA should be read broadly to include post-incarceration prisoner claims. Porter v. Nussle, 534 U.S. 516 (February 26, 2002).

NOTES FROM THE CERTIFICATION UNIT

Employee of the Year

The Certification Unit is very proud to have the Police and Correctional Training Commissions Employee of the Year award given to Ann Kochanski, Certification Specialist. Ann has worked in the Certification Unit since she joined the Commissions' staff in January 1997. Ann has always provided outstanding assistance and support to all of our customers and to our agency. Many, many thanks to Ann for a job well done.

Police Officer Certification Renewal

As of May 28th, the Certification Unit has issued 4,746 certification renewals to law enforcement officers throughout the State. In accordance with COMAR. 12.04.01.06, all law enforcement agencies have been notified regarding the officers in their agencies whose authority to enforce the general laws of the State may expire at midnight on June 30, 2002 due to failure to meet the Commission's training standards.

Annual Training Records

During the first quarter of the year, the Certification Unit issued annual training compliance reports to all law enforcement and State and local correctional agencies. The reports provided the agencies with training compliance percentages as well as listing the officers for whom we have a record of less than complete annual training. As a result of these reports, agencies have submitted additional training data or corrected previously submitted data.

This was the first year many law enforcement and correctional agencies utilized the Skills Manager format to report their previous year's annual training data to the Commissions. While some agencies experienced difficulties using the Skills Manager program, we were able to lend some assistance in resolving many of these problems. Using Skills Manager has been a learning experience for all of us.

Thanks to all of the agencies for assisting us in maintaining complete and accurate records for your mandated personnel.

Application For Certification Form

All law enforcement and correctional agencies are required to submit an Application For Certification (AFC) form for individuals employed in mandated positions and who are required, by law, to be certified.

As a reminder, do not take for granted that because your agency has forwarded the AFC to the Commissions' office that your employee is certified. Too frequently we receive incomplete AFC forms which must be returned for corrected or additional information, thereby, delaying the certification process. An AFC submitted for a previously certified officer may lack the required training documentation and will be returned since the individual is not eligible for certification without proof of training.

Law enforcement officers will be issued a certification card which will identify the officer by name and agency and contain a certification expiration date. Correctional agencies will receive a copy of the front page of the AFC form which contains the name of the mandated employee with the date of certification indicated in the lower right hand corner. Until your agency receives either the card or the copy of the front page of the AFC (for correctional personnel), do not assume that the officer is certified.

We encourage agency personnel responsible for preparing the AFC forms, and training forms, to proofread all forms before sending them to the Commissions' staff in an effort to prevent delays in certification.

Why be concerned with brain injury?

Every 15 seconds, one person in the U.S. sustains a Traumatic Brain Injury (TBI). There are 5.3 million Americans living with TBI-related disabilities today. Brain injury is the leading cause of death and disability for Americans under the age of 45. In Maryland alone, there are approximately 6,000 moderate to severe brain injuries that occur each year. That is 15 Marylanders admitted to the hospital with a brain injury each day!

What is involved in this training?

Audience

This series is intended to train all law enforcement officers to interact safely and knowledgeably with subjects with brain injury. The focus is on the protection of both parties and the deescalation of a stressful situation.

Video

The video is 24 minutes and 19 seconds long, and is divided into three segments, each depicting a law enforcement confrontation with an individual who has a brain injury and/or family member. It is recommended that the training instructor/facilitator present each of the three video segments individually, taking sufficient time to critique and discuss each segment with the class.

Mental Health Issues for Corrections Staff VHS, color, 24 mins.

In a correctional facility, the focus on mental health issues is usually reserved for the inmate population. It's important that there be programs for inmates who need these services, but Corrections staff have issues to deal with in this area as well. And often, their needs are overlooked. It's the staff in any correctional facility that keeps the operation moving smoothly and securely. And good mental and emotional health on the part of staff is directly related to the smooth and safe operation of the facility. Any officer who is preoccupied with problems at home is not paying attention to the inmates 100 percent. And this could mean trouble not only for that officer but for everyone else in the institution. That's why staff must learn to practice good mental health. Being in good physical shape is a plus for any Corrections Officer. The same goes for being in good emotional and mental shape. But it's not something that gets as much attention.

This training program explores some of the common problems that affect Corrections staff in the area of mental health, both on the job and outside. It also looks at what the supervisor's responsibility is, what some of the warning signs are that supervisors should be looking for, and it offers some solutions and suggestions for stress reduction and other mental health related problems.

The Internet as an Investigative Tool

CD-Rom (230 screens, four self-tests, and six animated sequences) National White Collar Crime Center

This educational program was developed to provide law enforcement professionals with basic information on the uses of the Internet and the World Wide Web as both communications media and tools to investigate crimes. It also educates them to be aware of crimes being perpetrated using the Internet and crimes against the infrastructure of the Internet.

The program is a self-contained training application that does not require a live Internet connection and may not require a trainer or leader. It assumes that the user has no or limited experience with the Internet but does not claim to answer all questions. The program is self-paced and users can follow the application linearly or randomly, depending on their needs, interests, or time available.

Workbook

The workbook is a companion piece to the video and reviews each scenario with questions and discussion points. A written examination, which must be successfully completed by each participant, is provided at the end of the Workbook. These statistics indicate that a significant portion of the U.S. population is living with some degree of brain injury. As a police officer, the chances are good that you will be interacting with a person with a brain injury more frequently than you previously imagined.

What does brain injury look like?

Brain injury is often referred to as "the unseen injury" because some people appear "fine" physically, but may have cognitive or behavioral impairments that are harder to "see." Effects of brain injury may be categorized into 3 general areas:

Physical, for example: seizures, slurred speech, difficulty walking, poor balance

Thinking (cognitive), for example: memory problems, difficulty concentrating, unable to organize or prioritize difficulty with multitasks. confusion

Behavior, for example: poor social skills irritability and anxiety, impulsive and excitable, poor self-awareness, anger and aggression, verbally/physically combative

How to use the video and workbook

The video and workbook are designed to be used together as a complete training tool. The video consists of three separate vignettes designed to train police officers in interacting with individuals with brain injury. The workbook addresses each video segment individually outlining the important elements of each scenario. The facilitator should play each video segment, stopping after each segment to refer to the workbook before proceeding to the next. Each segment of the workbook begins with a headsup statement to the officer viewing the video.
