PARTNERSHIP FOR WORKFORCE QUALITY PROGRAM (PWQ)

History and Program Description

The PWQ Program was established by legislation in 1989 and is administered by the Department of Business and Economic Development (the "Department"). The PWQ Program encourages Maryland companies to invest in training for employees.

The Partnership for Workforce Quality provides reimbursable grants that match (1:1) the investments of Maryland's manufacturing and technology companies in employee training, thus helping the companies improve their efficiency, develop quality management practices, modernized operations, and upgrade manufacturing processes. As a result, companies are better equipped to expand in Maryland and to compete in a global marketplace.

Funded annually through general and special funds, the Partnership for Workforce Quality helps participating companies develop and implement training systems to improve business competitiveness and worker productivity, upgrade the skills of workers to accommodate new technologies and production processes, and promote employment stability.

The Department's goal for use of PWQ funds is "maintaining the quality of the state's workforce," which is consistent with Maryland's Economic Development Strategy. PWQ provides critical funding support that is integrated with Department's overall efforts to grow Maryland's economy. Funds are disbursed to eligible Maryland companies in the form of a grant of up to 50% of qualified reimbursable direct cost of training. These funds enable companies to acquire new skills and technologies that have been identified by the business plan as a catalyst for growth and competitiveness in the industry.

The Department has focused the use of the PWQ funds on Maryland companies who are manufactures or threatened by the pressures of increased foreign or domestic competition.

Program Performance Since Inception

Program funds are used for grants to eligible Maryland companies primarily manufacturing and technology companies with 150 or fewer employees and assists these companies to provide:

- Training in manufacturing, professional, scientific and technical services;
- Job-specific training and training to upgrade or retain existing employees; or
- Training related to strategic goals and objectives of a company.

Since the program's inception in 1989, the PWQ Program has invested in nearly \$36 million of training for more than 96,000 employee-training slots in Maryland companies.

Program Performance for Fiscal Year 2008

During fiscal year 2008, Partnership for Workforce Quality Program funded grants totaling \$1.0 million to 82 Maryland companies that with matching funds from participating companies funded 2,561 employee-training slots. There were 464 training projects consisting of the following training types: 35% computer systems applications, 30% management and business, and 35% process and product improvements.

Projected Program Performance for Fiscal Year 2009

The appropriation for PWQ for fiscal year 2009 is approximately \$890 thousand of special funds. The Department is actively working to identify additional eligible training opportunities and anticipates full usage of the \$890 thousand appropriation. The Department's strategy for use of PWQ funds will emphasize support of upgrading the skills of Maryland employee's to encourage Maryland companies to expand and to compete in a global marketplace.
