REMARKS: As a result of the MPA's efforts to develop the Port of Baltimore as a desirable port for vacation cruises, the cruise business has increased from 27 cruises and 89,840 passengers in 2008 to 81 cruises and 329,441 passengers in 2009. The MPA estimates that the cruise business will increase to 115 cruises in 2011 which drives considerable economic impact to the Maryland economy. The MPA received approximately \$5.7 million in revenue associated with "Cruise" in 2009.

In order to maintain and increase Maryland's burgeoning vacation cruise business, the Port of Baltimore must provide a first-rate gangway or boarding bridge for loading and unloading passengers from multiple size cruise ships. The new gangway must be mobile along the berth and it must be articulating in order to respond safely to minor ship movement at the berth. It must also be protected from the weather to accommodate cold weather cruising.

This contract provides for furnishing all necessary materials and equipment to design, fabricate, deliver, erect, commission, test and provide a warranty for a mobile passenger boarding bridge with heating, ventilation and air condition (HVAC) for year round cruises.

The Solicitation was advertised on eMaryland Marketplace. Additionally, the MPA directly solicited proposals from two known manufacturers of this equipment, TEAM Ports and Maritime of Spain and FMT Aircraft Gate Support Systems AB of Sweden. Two proposals were received and both were found reasonably susceptible for award. Both TEAM and FMT submitted proposals, with TEAM submitting a price of \$2,895,637.00 and FMT submitting a price of \$2,610,353.00.

The mix of ships served by Cruise Maryland requires a passenger loading bridge with a high degree of flexibility and mobility. The TEAM design of the Mobile Walkway Module and Passenger Boarding Bridge is such that movement of both can be done at the same time and with minimum staffing. The FMT design of the Module and Bridge would need to be done separately and the two components would have to be disconnected and reconnected to complete the movement.

The TEAM design allowed for maximum flexibility while the FMT design allowed for minimum flexibility with regards to vessel door heights, vessel placement longitudinally along the pier and clear span working area under the gangway.

Overall, TEAM had a superior understanding of the needs of the MPA and its operation while FMT showed a lack of attention to detail and the needs of the MPA.

A 0% MBE goal was established for this contract due to the fact that only two companies were identified as manufacturing this type of heavy equipment.

REMARKS: This contract is for the reconstruction of both the eastbound and westbound Welcome Centers on I-70 at the summit of South Mountain in Frederick County, Maryland. The Office of Tourism and SHA have shared responsibilities in the construction oversight and funding of Tourism related work.

This additional work is being funded with a combination of funding from Office of Tourism, the National Scenic Byway Program and Federal Highway Administration Transportation Enhancement Funds encumbered by SHA. The Welcome Center project will achieve the LEEDs Silver level rating standard.

With regard to the use of federal funds, SHA and the Office of Tourism have maximized the opportunity to leverage state funds to federal funds. If the projects are not completed, all unused federal funds will have to be returned, all expended federal funds will have to be repaid and all expended match will be lost. Specific to the exterior promotional exhibits, the Office of Tourism would have to pay back \$145,000 in design funds and lose its \$34,000 match for a total loss of \$179,000. It is justified to keep moving forward because the OTD match to complete the project is \$45,557 which is \$133,443 less than would have to be returned if the project was cancelled.

Advantages to completing the Welcome Centers are:

- The centers will be in "turn-key" condition which provides the best opportunity to develop operational partnerships with local stakeholders.
- The exterior displays and kiosks will enable access to visitor information 24 hours per day, 365 days per year thus enabling economic return on the State's investment through visitor spending.
- Completion of the centers allows the State to maximize available federal funding.
- The project remains on schedule for delivery on May 2010.
