*From the Office of the Executive Director*

### Certification

The Maryland Police and Correctional Training Commissions (MPCTC) is tasked with many important and varied roles within our state—to train law enforcement and correctional personnel, to provide the tools for communities to keep themselves safe through the Maryland Community Crime Prevention Institute and Drug Abuse Resistance Education, and to provide ongoing educational opportunities for those who train our peace officers. There is, however, a more central role that MPCTC plays across Maryland; i.e., to assure that all those who serve as police and corrections personnel are certified to perform their duties.

**In the case of the law enforcement officer, certification establishes the legal authority of such an officer to enforce the general criminal laws of Maryland.**

Back in 1966, the Maryland General Assembly passed the bill that established the Police Training Commission as the agency to regulate selection and training standards for police officers in Maryland. Later, in 1971, the Maryland General Assembly established the Correctional Training Commission as the body to do the same for mandated correctional personnel in the State. In the case of the law enforcement officer, certification establishes the legal authority of such an

officer to enforce the general criminal laws of Maryland. Insofar as certification of correctional personnel, this allows anyone serving in a mandated correctional position to exercise the duties of that mandated position.

As the end of fiscal year 2010 approaches, we are also coming to the end of our certification year. Let this be a reminder to those officers among our ranks who must still submit all of the relevant and appropriate

documentation prior to June 30 to guarantee that their certifications do not lapse.

At this time, the staff of MPCTC is in the process of

reviewing current COMAR requirements for the various Police and Correctional Instructor certifications. The necessary requirements to achieve and maintain instructor certification are as varied as the different types of instructor certifications. Some of those variations are specific to the particular discipline/topic in which the instructor is certified to teach; likewise there are many other requirements that apply to most, if not all, instructor certifications. These can be found listed repetitively in separate sections of COMAR. The primary objective of this planned review and update process is intended to consolidate those similar requirements into a more concise and easy-to-follow unit and to help ensure the uniformity of those instructor certifications across the various disciplines. In this way, we can be confident that the instructors who train our police and correctional students are of the highest caliber.

Both Commissions have assigned the MPCTC staff, along with representatives from both the Police and Correctional Training Directors Associations, to complete this project. ### LEADERSHIP CHALLENGE XIX

The January session on Gangs with the Core Competency *Managing the External Environment* was held at the Maryland Crime Analysis Center in Woodlawn. The program provided participants with information about various initiatives around the State. The February session on MD Government with the Core Competency of *Self-Awareness* was held in Annapolis. Speakers provided insight into the judicial and legislative processes, and the program was well-received. March's session focused on Transportation with the Core Competency of *Strategic Thinking* and the April session addressed the Environment with the Core Competency of *Mission and Vision*.

## **SGT. LEE GOLDMAN: A FINAL FAREWELL**



My name is Bill McMahon and I have the honor of being the Chief of Police in Howard County. More importantly, I have the honor and privilege of having known Lee Goldman for 24 years. Like many here today, I was a student of Lee's, first as a recruit in 1986, in Academy Class #10. Truth be told, however, I never really stopped being his student. Though our assignments and positions would change over

the years, Lee was always a source of advice and guidance, solicited or otherwise, even as recently as a few weeks ago. The lessons he taught me have been invaluable, and where I have made mistakes was in not listening more closely to him. From the e-mails, phone calls, and conversations I have had with many people over the last few days, I know I am not alone in that feeling.

With all due respect to the officials in this church today, I cannot think of many people who have had as much influence on law enforcement in Howard County and in this state as Sgt. Lee Goldman. His impact was on more than just a good group of police recruits in an academy...it was on the officers those recruits would become. His personal sense of obligation to allow only the best-trained officers to serve this community drove his career.

We extend our sympathy to another law enforcement family of which Lee Goldman was a part— Mr. Rapp and the members and staff of The Maryland Police and Correctional Training Commissions. Lee was a critical element of this organization, and in the various roles in which he served, he had an immense impact on law enforcement in Maryland.

I also wish to extend my personal sympathies to Sue Goldman, Lee's wife, and to his children and grandchildren. I know how much you loved him and how much he loved all of you.

Lee Goldman began his career in public service in the U.S. Navy in 1957. He left the Navy in 1961 and soon joined the Baltimore City Police Department. Lee served with them until 1965 at which time he joined the Howard County Police Department (HCPD). In 1968, he left to pursue his interest in electronics and opened his own business. It was during this time that he felt the pull to return to his real passion of service to others....to policing his community.

A review of correspondence and applications from this time truly reveals the traits we came to know and love about Lee: his dedication, his sense of humor, his self-deprecation, and his honesty. On his 1975 application to return to the HCPD, he wrote: "I will not be happy until I am back in law enforcement." On that same application, when asked to state his reason for leaving a few years earlier, he responded: "Stupidity – went into business for myself." The application also asked if the Department could contact his current employer. Lee's response was: "Only when my appointment is assured or I will very soon be unemployed." And finally, on that same application, when asked if he had ever been fired, Lee replied: "No, but I will be if you contact my present employer too soon."

Fortunately, Lee was able to return to HCPD, and the agency and the community have been better because of it. As you might imagine, Lee succeeded in all of his assignments, and his personnel file overflowed with commendations and letters of support from people in all walks of life.

Of course, it was as a trainer that Lee made his mark and where he had the most influence. He could teach on any subject, no matter what, and bring instant credibility to it. A former member of HCPD recently shared with me that: "Lee could create a class on how to tear a piece of paper out of a legal pad and make it interesting." Moreover, Lee wasn't interested in rote memorization. Thinking back on my Academy days, I remember how we asked him the questions that only recruits could come up with. He looked back at us with his trademark look—one hand in the air and two fingers from his other hand at his lips—and would say, "Let me throw that back to you. What do you think about that?" We, of course, mumbled to each other: "If you don't know, just tell us." What we didn't realize, of course, was that he was teaching us to think. What better skill could he have taught budding officers?

But more than that, Lee's training went beyond the technical and beyond the written material. He taught us how to treat people. He was concerned not just with what we did—the number of arrests we made or tickets we wrote—but with how and why we did it.

On a more personal note, my learning from Lee did not stop when I left his Academy. In fact, it did not stop when he retired. He was a constant source of good advice for me, even as recently as a few weeks ago. He was a great sounding board. Most often he was simply a friend who would listen to me. I suspect he was that for many of you as well.

Lee's passion as a trainer was obvious as was the sense of obligation and responsibility he brought to it. Many of you may have seen the picture he had in his office that stated: "Let the ghost of no man ever return to say 'If only training had done its job.'" This defined his approach to his job. Lee's approach to his fellow man was just as telling. My guess is that he had another

Tragically, on February 17, we lost Lee Goldman, the Deputy Director of the Maryland Police and Correctional Training Commissions and my boss for the last two years. Lee, as most people knew him, was a man of integrity. He was always there to help his fellow co-worker, whether it was someone in his office or an officer on the street. Lee was the first person to admit that his area of expertise

was in law enforcement and that he did not have a lot of knowledge about Corrections. However, he knew how to be a good leader, and this is what he gave back to the entire criminal justice community. Lee always had time for his staff as well as the clients around the State. He had a way of making people feel valued and appreciated, and his support and allegiance to the Training Commissions were unwavering.

After Lee's passing, I was invited into his office to see if there were any books on his bookshelves that I wanted. His book collection said a lot about who Lee Goldman was. Many of the books had the same themes and were somewhat repetitive, about such topics as communication, character, ethics, and personal change. These are the same words I would use to sum up Lee Goldman, his impact on me, and on many of the people whose lives he touched. We were lucky to have had the opportunity to work with and for Lee, and I only hope those who were not so fortunate can take some time to appreciate the leadership Lee provided through his kindness, knowledge, and integrity. A bookshelf tells a lot about a person as does each book on it. I found one small book titled Creating and Motivating a Superior, Loyal Staff. To my way of thinking, this is the book that exemplifies the leadership of Lee Goldman, and I plan to keep it close to my heart.

## Defensive Tactics Instruction

On March 23, 2010, fifteen students in the Defensive Tactics (DT) Instructors' school underwent their final practical exam. They completed the DT seven-day training in what is quickly becoming one of the most sought after and challenging classes offered by the Maryland Police and Correctional Training Commissions.

Typically, the instructor classes are limited to twelve participants; however, due to high demand, fifteen began the course and other interested individuals were advised to enroll in the next session.

The class includes five days of skills training. This training is both physically and mentally challenging, teaching skills for stand-up, ground level survival, and weapons defense and retention. All skills are reinforced via drills designed to fatigue and stress the participants. The instructors are asked to actively perform all the drills with their students so they have a better understanding of how they work and what they are meant to accomplish. Later on, they can incorporate them into their own lesson plans. Five days of skills and lectures are followed by two days of testing, where there is mock-teaching, a practical exam, and a written exam that requires a score of 80 or higher to graduate.

Twelve participants who have successfully passed all of the requirements and graduated this course are now eligible to teach DT at their own agencies.

Future DT Instructors' courses are scheduled for June 21, 2010 (Correctional) and August 9, 2010 (Police). **UPCOMING COMMERCIAL AND RESIDENTIAL  
CRIME PREVENTION TRAINING PROGRAMS**

MCCPI conducted a four-day *Residential Crime Prevention Training Program* on March 15-18, 2010 at PSETC in Sykesville and another on April 12-15, 2010 at the Castle in the Sand Hotel in Ocean City, Maryland. The programs are free of charge and have been approved for 26 hours of in-service credits.

Another *Residential* program is being planned for September-October, date and location to be determined. Also, a five-day *Commercial Program* is being planned for June 2010.

Throughout the year, MCCPI will also offer **Specialized Residential or Commercial Crime Prevention Training**, upon request, to departments with 15 or more students. This is usually a two-day training program and must be requested on an individual basis by contacting the MCCPI Office. A two-day *Commercial Program* will take place in Howard County on May 3-4, 2010 and a two-day *Residential Program* will take place in Frederick County on May 25-26, 2010.

**CURRENT TRENDS V CRIME PREVENTION  
TRAINING PROGRAM**

MCCPI recently offered a training program for *sworn* law enforcement officers entitled "Current Trends V: Human Trafficking – Modern Day Slavery – Central and Western Regions." This program took place on April 21-22, 2010 at the Public Safety Education and Training Center in Sykesville and provided an overview of human trafficking that includes patrol and investigative indicators, prevention techniques, and material about its victims. The program also included a Street Gang Enhanced Update; Personal Safety for Young Adults; and a Crime Prevention Review. The information will be useful to all law enforcement personnel regardless of their assignment. The program has been approved for 11 hours of police in-service credits.

A similar program is being planned for June 23-24, 2010 in Cumberland.

**COMMUNITY GANG AWARENESS TRAINING-  
OF-TRAINERS**

A two-day Community Gang Awareness Training-of-Trainers took place on March 10-11, 2010 at the Cambridge Police Department and will again be offered on May 19-20, 2010 in Allegany County. Topics to be covered include the following: Why Youth Join Gangs; Gang Identification; History of Gangs; Gang Culture; Recruitment; Consequences of Gang Involvement; How to Recognize Youth Gang Involvement; and How to Prevent Youth Gang Involvement. In addition, a Personal Safety presentation will be given, and the Maryland EXILE Gun Crime Program and RICCO (Racketeer Influenced and Corrupt Organizations Act) will also be explained.

The course is designed for those responsible for training individuals/groups in their community and/or place of employment. It is geared toward those whose jobs or day-to-day activities may potentially bring them into contact with gang members, such as law enforcement, health care professionals, counselors, etc.

## FOCUS ON PAST GOVERNOR'S CRIME PREVENTION AWARDS RECIPIENTS

Each year, the State of Maryland honors law enforcement agencies, officers, citizens, and programs for their contributions to the furtherance of crime prevention programming in Maryland. MCCPI would like to take the opportunity to highlight some of these efforts in Training Notes. In this issue, we are featuring the **Community Outreach Email and Social Media Program**, which was nominated for the award by the Ocean City Police Department.

While Ocean City is a small, quiet community in the winter months, the town becomes the second largest city in Maryland during the summer season. The Ocean City Police Department has the unique task of providing crime prevention tips to not only full-time residents but

also to visiting tourists and non-local property owners. In a proactive approach to providing citizens with information in a timely manner, the police department created a program that would allow residents and visitors the opportunity to stay involved and updated, no matter where they were located.

The Ocean City Police Community Outreach Email and Social Media Program has become a huge success throughout the Ocean City community. By posting information on Twitter, Facebook, You Tube, and the Ocean City Police Department Official Blog, the police department is using technology to provide citizens with crime prevention information and community-related news in a matter of seconds. In addition, press releases are emailed to participants of the program that detail police-involved incidents that are happening in the communities in which they live and the neighborhoods they visit.

Along with providing crime prevention information, an additional goal of the program was to create a forum that would allow the police department to have a direct and immediate interaction with the public. For example, if the police department posts a blog entry about internet scams, citizens are encouraged to add their comments and experiences. Not only has the program created an opportunity for the police to educate the public, but it has also created an opportunity for the public to educate the public.

The Community Outreach Email and Social Media Program was implemented on April 14, 2009 with its first blog posting, entitled "Summer is Coming and the OCPD is Reminding Citizens and Visitors to Stay Safe Throughout the Season." In addition to the blog, the first Twitter update was sent on that date, advising citizens of heavy rain and providing traffic safety tips. Other postings have addressed numerous other subjects including Bicycle, Moped, and Scooter Safety; Sexual Assault Awareness; Pedestrian Safety; National Night Out; Burglary; Hurricane Season; Public Transportation; and many others. The open communication and strengthened partnership between the community and the Ocean City Police Department is perhaps the most outstanding outcome of this program.

## "CITIZEN OF THE YEAR"

Kudos to one of our own! The National Association of Social Workers—Maryland Chapter recognized Tzviel "BK" Blankchtein at their annual conference that took place this year on Friday, March 26, 2010 at Martin's West. Each year the organization recognizes and presents a "Citizen of the Year" Award at the conference luncheon that is part of their Social Work Month Annual Conference. BK, along with Vincent DeMarco, an attorney and an advocate for social justice, was recognized for his efforts on behalf of those in need and for embodying the mission of social workers.

BK owns and operates a self-defense and conditioning center in Pikesville called *Clinch Fight and Fitness*. In the three years of its existence, BK has conducted seminars twice per year for clients of **CHANA** (Counseling Helpline and Aid Network for Abused Women), a local organization that deals with victims of domestic abuse. These seminars are held in conjunction with Domestic Violence Awareness Month and Stalking Awareness Month. Each seminar conducted at *Clinch* services between 15 and 40 participants, and these have been very well-received in the community. Naomi Taffet, one of the directors at **CHANA**, is the person who nominated BK for this prestigious award.

This unexpected recognition means a lot to BK and he is especially honored that his nomination was generated by one of the directors of **CHANA**. The organization does important work with women in the Jewish community who are victims of domestic abuse, and the seminars that BK runs at *Clinch* do much to help these women move past the violence in their lives.

**CHANA**, in addition to helping those who have been abused, also focuses on abuse prevention through education about healthy relationships. The organization is a partnership between Jewish Family Services and the House of Ruth, with the support of the Women's Division of THE ASSOCIATED. **CHANA's** helpline handles roughly 200 calls each year and its volunteers, trained in crisis intervention, channel these callers to the services that can best help them. There is also a safe house where women can receive kosher food and shelter from a violent home environment. The organization was founded in 1995 when one member of the House of Ruth Board of Directors realized that Jewish women needed a shelter and services that were "culturally appropriate and comfortable" for them. Support groups, legal assistance, counseling services, and referral to a safe house are part of the myriad services provided by **CHANA**. Now, thanks to BK and *Clinch Fight and Fitness*, these women also have the opportunity to attend seminars that provide them with information and statistics to help them deal with their circumstances and with the physical skills that empower them to move forward with their lives.

Again, we congratulate BK on this important award.

## TRAINING, RESEARCH & DEVELOPMENT UNIT

### Field Training Officer Symposium

On March 10, 2010, the staff of the Maryland Police and Correctional Training Commissions (MPCTC) facilitated a Field Training Officer (FTO) symposium. This symposium, held at the Howard County Police Academy, included representatives from corrections, law enforcement, and the Division of Parole and Probation.

Dr. Sheldon Greenberg, Associate Dean for the Division of Public Safety at Johns Hopkins University, delivered the opening remarks for the symposium. Dr. Greenberg spoke about the diminished role of officers as journeymen. According to [Dictionary.com](http://Dictionary.com), a journeyman is a person who has served an apprenticeship at a trade or handicraft and is certified to work at it assisting or under another person. This term seems apropos in describing the role of an FTO in relation to the officer in training. While initial FTO programs may be lacking in structure and accountability, current programs strive to partner rookies with experienced officers who can guide them as they transition from the classroom to the field.

Following Dr. Greenberg's remarks, Mr. Jim Durner reviewed the objectives taught by the MPCTC staff in our own FTO Training-for-Trainers program. While the content of the FTO programs is not regulated, the objectives established in the MPCTC program are the result of input from supervisors and administrators as well as research into existing programs. It is recommended that those involved in modifying or developing similar programs review these objectives to help them in their efforts.

Sergeant Gordon Carpenter, Howard County Police Department, and Lieutenant Dan Watson, Maryland Division of Correction, presented findings from two pre-planning sessions that focused on what works and what doesn't work in FTO programs. Attendees were able to participate in two networking activities that gave them a chance to gather additional information about existing programs. The symposium closed with a presentation by Ms. Jane Sachs, Corrections Administrator MPCTC, and Lieutenant Bob Wagner, Howard County Police Academy, that outlined an ideal FTO training program.

The networking sessions yielded many positive suggestions. We hope to offer similar events in the future that will allow us to expand on these suggestions. Many thanks to all of the departments that participated in the development of this symposium—Maryland Division of Correction, Montgomery County Department of Correction, St. Mary's County Office of the Sheriff, Prince George's County Police Department, Frederick Police Department, and the Anne Arundel County Police Department. We also extend a special thank-you to the Howard County Police Department for providing the venue for this program.

## Personal Safety Tips for Women

### PERSONAL SAFETY WHEN DRIVING

Keep anything of value, such as bags or phones, out of sight. Those things are easy pickings for a snatch thief.

Whether driving or just sitting in the car, always keep the doors locked. If you are in an accident, the windows can be broken to get you out.

### FEELING THREATENED WHILE DRIVING?

If you think you are being followed, you may find yourself clutching the wheel and having difficulty breathing. Exhale slowly and release the tension. Do this again while gripping the wheel. As your body relaxes, you will find yourself able to think more clearly.

Keep driving until you come to a busy place such as a police station or a busy shopping mall.

If a car pulls up alongside you and the occupants try to attract your attention, ignore them and make no eye contact.

If you see an accident or someone tries to flag you down, first decide if you can really be of immediate assistance. If not, it is best to call or go for help.

If another driver is causing you concern, use your cell phone to deflect unwanted attention. Phone (or pretend to phone) the police, and make an obvious note of the car's tag number. If the other driver suspects what you are doing, it's likely he will stop pestering you.

If a car pulls in front of you and forces you to stop, don't turn off the engine. Stay calm and make sure that all car doors and windows are locked. If the driver gets out of his car to approach you, reverse the car as far as you can while continually sounding the horn and activating your hazard lights.

### WHAT HAPPENS IF I BREAK DOWN?

Pull as far off the road as you can and switch on your hazard lights.

Use your mobile phone or walk to the nearest phone and call your automobile association or the police.

Beware of someone who warns you of the dangers of walking alone and then offers to accompany you. This is a common ploy some attackers use.

Remember to **PLAN**: Prepare, Look confident, Avoid risk, Never assume it won't happen to you.
