# GOVERNOR O'MALLEY EMPOWERS "CLEAN ENERGY COMMUNITIES" WITH AN ADDITIONAL \$2 MILLION FOR ENERGY IMPROVEMENTS

\$2.23 Million in Energy Efficiency Grants Expected to Help Approximately 1,400 Maryland Families

**ANNAPOLIS, MD (December 20, 2011)** – Today, Governor Martin O'Malley announced award recipients for the FY2012 "EmPOWER Clean Energy Communities" grant program. The program helps local governments and not-for-profit organizations fund energy efficiency projects specifically designed to benefit low to moderate income Marylanders. The grants are administered by the Maryland Energy Administration (MEA), and are expected to help 1,400 Maryland families save a total of 1,450 MWH of electricity and almost 6 million cubic feet of natural gas each year. This amounts to more than \$4.5 million in savings over the estimated life of the measures.

"These grants are an example of exactly the type of efficiency projects we had intended for Maryland communities and families when we entered into the Regional Greenhouse Gas Initiative, the nation's first multi-state collaborative carbon cap-and-trade program," said Governor O'Malley. "These grants are another step forward in our effort to make Maryland's future cleaner, greener, and more sustainable for all our citizens."

Forty-seven grants will be awarded to organizations in every county across Maryland and Baltimore City. Municipalities and not-for-profit organizations will use these funds to ensure an energy efficient future for Maryland. Funded projects range from energy efficiency upgrades at a homeless shelter in Anne Arundel County to whole home audits and retrofits for low-to-moderate households in Prince George's County.

"Energy efficiency upgrades are a smart investment providing real results to Maryland families," said Malcolm Woolf, Director of the Maryland Energy Administration. "Not only will families save hundreds of dollars on utility bills, but the State will move closer to achieving a 15% reduction in energy consumption by 2025. Furthermore," said Woolf, "these 47 projects will stimulate the economy and create jobs across the state of Maryland."

Each Maryland county and Baltimore City was provided an allocation based on the number of low-to-moderate income households residing in the respective area. The list of grants awarded is detailed below. Funding for the program comes from the Strategic Energy Investment Fund, which was created from public auctions of carbon credits through the Regional Greenhouse Gas Initiative.

# 2012 EmPOWERing Clean Energy Communities Grant Awardees

C&O Conservation Allegany County \$30,000

C&O Conservation will complete an energy audit and then install energy efficiency measures in at least four low income homes.

Arundel Community Development Services Anne Arundel County \$63,000

Arundel Community Development Services will complete energy efficiency retrofits on two homeless shelters.

C&O Conservation Anne Arundel County \$40,500

C&O Conservation will complete an energy audit and then install energy efficiency measures in at least six low income homes.

Maryland Energy Conservation

Anne Arundel County \$40,000

Maryland Energy Conservation (MEC) will install an energy efficient HVAC unit in five homes receiving weatherization services.

Associated Catholic Charities Baltimore City \$50,000

Catholic Charities will weatherize 178 senior rental apartments, installing hot water heater wraps, low flow showerheads, and HVAC duct insulation, as appropriate.

Civic Works Baltimore City \$90,000

Civic Works will use their EmPOWERing Clean Energy Communities grant to fund two programs. *Project Lightbulb* will leverage AmeriCorps members, who themselves are low-to-moderate income, to complete energy conservation visits in low-to-moderate income Baltimore City households. The energy conservation visits will be used to identify households that could also benefit from air sealing and insulation through Civic Works' *Energy Ready* program.

**Baltimore City Department of Housing and Community Development** 

\$85,000

ENERGY STAR qualified furnaces or boilers will be installed in approximately 18 homes receiving weatherization services, maximizing the energy savings in each home.

Coalition to End Childhood Lead Poisoning Baltimore City \$75,000

The Energy Plus program will deliver energy audits and interventions to an estimated thirty five low-to-moderate income households already undergoing home-based environmental interventions through the Coalition's Safe at Home Healthy Homes Program.

St. Ambrose Housing Aid Center

\$40,000

As part of a larger retrofit project, St. Ambrose Housing will install ENERGY STAR heat pumps in five low income rental homes.

Civic Works Baltimore County \$75,750

Civic Works' *Project Lightbulb* will leverage AmeriCorps members, who themselves are low-to-moderate income, to complete energy conservation visits in more than 200 low-to-moderate income Baltimore City households.

\$75,750

The EmPOWERing Clean Energy Communities grant will allow Catholic Charities to weatherize senior rental apartments throughout Baltimore County.

**Diversified Housing Development** 

**Baltimore County** 

\$75,750

Diversified Housing Development will complete energy audits followed by the installation of applicable energy efficiency measures in approximately 15 low-to-moderate income Baltimore County homes.

# St. Ambrose Housing Aid Center

**Baltimore County** 

\$75,750

As part of a larger energy efficiency retrofit project, St. Ambrose Housing will install energy efficient HVAC units in approximately 10 low-to-moderate income rental homes.

## **Patuxent Habitat for Humanity**

**Calvert County** 

\$27,500

Patuxent Habitat will complete energy efficiency retrofits on at least five low-to-moderate income homes.

#### **Caroline County Habitat for Humanity**

**Caroline County** 

\$25.000

Habitat for Humanity will weatherize eight existing homes. In addition, Habitat for Humanity will also install energy efficiency measures in one new home that is being constructed.

C&O Conservation will complete an energy audit and then install energy efficiency measures in at least three low income homes.

**Hindman Foundation** 

**Carroll County** 

\$22,250

Hindman Foundation will complete an energy audit and then install energy efficiency measures in at least three low-to-moderate income homes.

**C&O Conservation** 

**Cecil County** 

\$10,000

C&O Conservation will complete an energy audit and then install energy efficiency measures in two low income homes.

### Habitat for Humanity Susquehanna

**Cecil County** 

\$24,000

Habitat for Humanity Susquehanna (HFHS) will use EmPOWERing Clean Energy Communities grant funding to install energy efficiency measures in at least three low-to-moderate income homes through HFHS's Neighborhood Revitalization Initiative.

**C&O Conservation** 

**Charles County** 

\$47,500

C&O Conservation will complete an energy audit and then install energy efficiency measures in seven low income homes.

### **Prosperity Pail Ministry Works**

**Dorchester County** 

\$25,000

Prosperity Pail Ministry Works will install low cost energy efficiency measures in approximately 125 low-to-moderate income homes in Dorchester County that do not have access to EmPOWER Maryland programs through the local electric utility.

C&O Conservation will complete an energy audit and then install energy efficiency measures in six low income homes.

#### **Hindman Foundation**

Frederick County

\$41,500

Hindman Foundation will complete an energy audit and then install energy efficiency measures in at least six low-to-moderate income homes.

### **Garrett County Community Action Committee**

**Garrett County** 

\$25,000

Garrett County Community Action Committee will be replacing the existing furnace or boiler in five low income homes with an ENERGY STAR qualified HVAC unit.

#### **Associated Catholic Charities**

**Harford County** 

\$36,000

The EmPOWERing Clean Energy Communities grant will allow Catholic Charities to weatherize approximately 151 senior rental apartments in Abingdon and Aberdeen.

### **Habitat for Humanity Susquehanna**

**Harford County** 

\$55.000

Habitat for Humanity (HFH) will use EmPOWERing Clean Energy Communities grant funding to install energy efficiency measures in existing and new construction low-to-moderate income homes.

# **Community Action Council of Howard County (CACHC)**

\$45,000

CACHC will complete energy efficiency retrofits on seven low income homes. The funded energy efficiency measures will include air sealing, insulation, and ENERGY STAR appliances, as appropriate.

**Howard County Housing Commission** 

**Howard County** 

\$45,000

Howard County Housing will leverage EmPOWERing Clean Energy Communities grant funding to install more efficient gas water heaters and refrigerators in approximately 27 low-to-moderate income homes.

Kent Center Kent County \$9,984

The Kent Center will complete energy efficiency upgrades in two homes for individuals with complex medical conditions and/or severe disabilities.

**Kent County** 

\$15,016

Upper Shore Aging will install an energy efficient HVAC system in two homes.

C&O Conservation will complete an energy audit and then install energy efficiency measures in approximately 23 low income homes.

Rebuilding Together Montgomery County (RTMC) Montgomery County

\$99,356

EmPOWERing Clean Energy Communities grant funding will be used to fund at least 10 energy efficiency home retrofits being completed during RTMC's Spring Rebuilding Weekend. Funding will also be used to purchase and install at least 15 energy efficient HVAC and/or gas hot water heater replacements as part of RTMC's critical repair initiative.

Habitat for Humanity International's weatherization pilot program will be leveraged by Habitat for Humanity of Montgomery County to complete energy efficiency retrofits in 15 homes.

The Town of Bladensburg, in cooperation with seven other Prince George's County municipalities, will leverage EmPOWERing Clean Energy Communities grant funding to complete energy audits and retrofits in an estimated 12 low-to-moderate income Prince George's County households.

United Communities Against Poverty will complete energy audits and retrofits of approximately 35 low-to-moderate income homes.

Prosperity Pail Ministry Works will install low cost energy efficiency measures in low-to-moderate income homes in Talbot County that do not have access to EmPOWER Maryland programs through the local electric utility.

EmPOWERing Clean Energy Communities grant funding will be used to implement energy efficiency upgrades in a home for individuals with intellectual disabilities.

C&O Conservation will complete an energy audit and then install energy efficiency measures in nine low income homes.

Shore-Up will leverage EmPOWERing Clean Energy Communities grant funding to replace HVAC systems in eight low income homes receiving weatherization services.

Shore-Up Worcester County \$25,000

Shore-Up will leverage EmPOWERing Clean Energy Communities grant funding to replace HVAC systems in five low income homes receiving weatherization services.
