## EXECUTIVE SUMMARY



The Governor's Commission on Middle Eastern American Affairs (GCMEAA) was created under the leadership of the O'Malley/Brown Administration in 2008 through Executive Order 01.01.2007.22. Being the first state-level Commission of its kind, the Commission aims to set a standard for other states. Focusing on business, workforce, and community development the GCMEAA every year establishes a work plan to fulfill the development in the three arenas as charged by the Executive Order.

Taking a more aggressive stance on positioning Maryland on a global scale, the Commission's business committee was afforded the opportunity to help Maryland organize various visits from delegations from Iraq and Bahrain throughout the year. In regards to workforce development, the GCMEAA in partnership with the Governor's Ethnic Commissions, hosted a training program at the Maryland Department of Transportation (MDOT) highlighting the Middle Eastern American community in the state along with addressing sensitivities and concerns for employers.

In 2011, the Middle Eastern region began experience tremendous change. As we witnessed the Arab Spring and experienced uncertainty and hope in the region the Commission played a vital role in regards to informing the community about these substantial changes. Participating in White House briefings, inviting guest speakers to Commission meetings and supporting events through other Middle Eastern organizations, the GCMEAA took every opportunity to learn about and disseminate information about the revolutions in the MENA region.

One of the biggest accomplishments for the Commission on Middle Eastern American Affairs was in regards to the pursuit of including Middle Eastern Americans to the Maryland Minority Business Enterprise (MBE) program. MDOT and the Office of MBE invited Middle Eastern American business owners, professionals and leaders to participate in an MBE focus group. The goal of the focus group was to capture firm-level experiences with the programs and any barriers to participation in State contracts and subcontracts across a wide spectrum of goods and services. This discussion is a necessary first step to studying the possibility of Middle Eastern American inclusion into the MBE pool.

As the Commission continues to strive to represent the diversity of the community in Maryland the following report details the 2011 accomplishments and highlights 2012 initiatives.
