# Message from the Mayor

Mayor James L. Eberhardt

Since our last newsletter some very positive things have happened in Perryville. First and most important we have once again reduced the property tax rate and this year it is one of the largest property tax rate reductions ever in Perryville. As a result we remain one of the lowest tax rates in the County. As important is the fact that the board unanimously approved a balanced budget for this fiscal year.

Some of the major improvements to the Town include the completion of the Lower Ferry Pier at Rodgers Tavern which will enhance our greatest asset; the river front. I saw about 125 people on the pier viewing the fireworks on the 4th and have received numerous comments about how people have enjoyed their experience there. We have also completed a new building for the Department of Public Works. Both of these major projects were accomplished with a large amount of grant funds and the town's portion was from operating funds, meaning the Town has no debt for either of these projects. In our financial planning for future new facilities, we have established reserve account to be funded each year in hopes of having minimum or no debt on those facilities.

In order to stimulate business in Perryville we have done a couple of things to directly affect business growth; that is in addition to a lower tax rate and water and wastewater plants to accommodate growth. First we are incentivizing businesses by offering grants for façade improvement. The first recipients include business facilities at Aiken and Broad Streets as well as Box Car Avenue Ice-cream. Second, we have established an Economic Development position filled by Susan O'Neill who will work closely with new businesses to bring them to Perryville. We have also brought on board an engineer, Ralph Ryan. It is expected that our engineer will more than make up his salary by the reduction in contractual/engineering costs that we have incurred, and we will have an in house representative looking out for the town's interest regarding construction and design change orders of any major contract.

I believe the Town Board is committed to moving Perryville forward with positive action and sound financial management. Our goal is that all of our actions make Perryville a better place to do business and a better place to live.

In the past 6 months, the Town has hired no less than 6 new full-time employees costing taxpayers upwards of \$400,000 annually.

All of this sounds nice at first, but do we really need it? Wouldn't it be better to put this money back into your hands? Instead of government construction, wouldn't it be great to see new businesses in Perryville? People are struggling to find jobs and businesses are fighting to stay afloat, how will multi-million dollar government spending in Perryville do anything to help our crumbling economy?

You deserve to know about every dollar spent at Town Hall. I want to change that. That's why if you email me at mdawson2059@gmail.com I will send you purchase orders from the Town of Perryville so that you can see exactly what I see and where your tax dollars are being wasted.

In closing I ask, how will we pay for this massive expansion of government? Is the answer the Casino? If you read the paper you know that they just lost 30 to 40 percent of their revenue. As the summer has come to a close, Fall is here and it is only a matter of time before winter is completely upon us. This is the best time to prepare yourself for the winter months by readying your home for emergencies that you may encounter during the sometimes harsh winter weather. Winter weather can sometimes have enough strength to cause major issues. Some stronger storms in recent years have had the ability to cause a loss of power from several minutes to several days. Often when a storm is powerful enough to cause a loss of power, it also comes with the unfortunate circumstance of being stranded in your home while snow removal crews battle the elements to keep roads open for emergency vehicles. Some things to consider keeping as part of your "snow emergency kit" should include:

#### THE ESSENTIALS

- Food: Food that requires no cooking or refrigeration such as bread, crackers, cereal, canned foods, and dried fruits. Remember baby food and formula if you have young children.
- Water: In case water pipes freeze or rupture, keep a supply of tap water or purchase bottled water. The recommended amount of water to keep is .5 gallons per person.
- Medicines: Roads may be inaccessible for several days due to the storm. Make sure to order or refill any prescriptions that family members may need.

  Identification: Make sure to keep forms of identification with you such as
- social security card, passport, photo ID, and driver's license. In addition, make sure to have bank account information, and insurance policies.

#### **EMERGENCY MATERIALS**

- Alternate methods to heat your home: Dry firewood for a fireplace or wood stove Kerosene for a kerosene heater Furnace fuel (coal, propane, or oil) Electric space heater with automatic shut-off switch and non-glowing elements
- Blankets
- Matches
- First Aid Kit and instruction manual
- Multipurpose, dry-chemical fire extinguisher
- Flashlight
- Battery-powered radio, clock/watchExtra batteries
- Shovel
- Rock salt
- Non-electric can opener

When creating a winter survival kit for your home, take into consideration factors that are specific to your home and family. For instance if your home is isolated or on the outskirts of a residential area, making it more difficult for help to reach you, make sure to stock additional amounts of food, water, and medicine. Listening to weather forecasts regularly can provide you with several days' notice to allow you to check emergency materials and to stock-up on essential supplies.



# TRASH AND RECYCLE PICK-UP

(Please display in a convenient place as a reminder.)

There has been a misconception among some Town residents that since all recyclables were put into the same truck by the Town's trash contractor that the Town was not recycling. However, even though the Cecil County Landfill only recently went with single-stream recycling, the Town's trash contractor has been taking our recyclables to a facility that does single stream recycling and will continue to do so. The Town of Perryville will now be picking up Yard Waste. The following Holidays will cause the pick up to be a day behind on anything after the holiday for the Town's trash contractor if during the work week. The holidays included are, New Years Day, Independence Day, Memorial Day, Labor Day, Thanksgiving, Christmas Day.

#### All of the following recyclables can be mixed in the same container:

- Newspaper
- Aluminum cans
- Glass jars & bottles (excluding canning jars)
- Narrow neck plastic containers > Codes 1,2,3,4,5,6, & 7
- Newsprint
- Cardboard
- Tin, Steel, & Bi-metal cans (including empty aerosol cans)
- Office Paper

- Mixed Paper
- Rigid Plastics, including yogurt containers, butter tubs, flower pots (with dirt & flowers removed), plastic laundry baskets, buckets, cups (party cups - plastic cups all types), food trays, crates, totes.
- Bagged Plastic Grocery Bags
- Aluminum Foil, pie plates, food trays
- Milk Cartons
- Bagged Shredded Paper

All containers must be rinsed with lids removed. Wet cardboard is not accepted. If you do not see an item on your list, please do not include it with your recyclables. Paint cans are **NOT** accepted in trash, heavy trash or recyclables.

# **BULK TRASH**

Bulk trash items are picked up on the second Monday of the month. In order to have your bulk trash picked up please contact Town Hall at 410-642-6066 no later than **2:00 pm** on the Friday before the pickup for scheduling. We require that items be put out on Sunday evening for Monday morning pickup. Bulk trash is intended for households needing to get rid of a few large items. If you have more than that, you may need to rent the Town's dump truck or find other means to take your items to the Landfill.

#### Below are rules and regulations pertaining to Bulk Trash Pick-Up:

Refrigerators must have doors removed, anything using a motor must have motor removed, no more than two demounted tires. We will not pick up items over 8 ft. long, propane tanks, shingles, batteries, anti — freeze, oil, or cans of paint.

December 2012 through March 2013 the Yard Waste will be picked up on the Second Tuesday of the month. In order to have yard waste picked up during that period please contact Town Hall at 410-642-6066 no later than 2 p.m. on the Friday before the pickup for scheduling.

Leaves and grass clippings should be put loose into a container no larger than 35 gallons. They will no longer be accepted in bags.

Additionally, a maximum of 5 containers and/or bundles per household per

service day of yard waste will be picked up. Branches, no greater than 3" in diameter, should be bundled and tied; length cannot exceed 4 feet.
