*In accordance with the Americans with Disabilities Act and our desire to have our meetings open to everyone in our community, Council meetings are held at the Chevy Chase United Methodist Church which has handicapped elevator access via the parking lot entrance. We are grateful to the Church for their generosity in allowing us to use their facility each month.



The Council met on Wednesday, March 12, 2008 at room 109, CCUMC. The meeting began at 7: 50 p.m. All Council members with the exception of Paul Kiernan were present.

The minutes of the February meeting as published in the newsletter were approved.

The Council first took up the variance request for a bay window which will extend 22 inches into the setback on the Taylor Street side of **Dr. Irene Tamanga**'s Connecticut Avenue home. The Council voted to grant the variance.

The Council then took up a discussion of the proposed revised plan for the re-subdivision of the lot at Bradley Lane and Connecticut Avenue presented by the owner **Patrick Strauss** and his attorney, Todd Brown of Linowes & Blocher. The plan has not yet been submitted to the National Capital Park and Planning Commission but the intent was to get a sense of the Council's informal response. The Council agreed that when the plan was formally submitted to the Commission that it would have a formal response. In the interim, the owner would have the feedback from the Council and the Council would have an opportunity to consult with neighbors regarding the proposed changes.

The main difference in the plans is that this proposed plan has two lots instead of three and proposes a single driveway opening onto Bradley Lane close to the Terpeluk residence, approximately across the street from B.F. Saul's driveway opening and a second driveway opening using the existing opening on Connecticut Avenue. The Council felt on first look that the plan was a significant improvement and addressed many of the issues raised in the public hearing held on the first proposed plan. The two areas the Council found still needed some attention involved set backs from Bradley Lane more than indicated on the plan, and that the house closest to the Terpeluk home should have more offstreet parking and room to turn around as there is no parking allowed on the street in front of these two houses. The owners agreed to provide the Council with copies of the Development Review Committee's findings on the first proposal, which is still pending at the Planning Board. The owners indicated that they would take into consideration the comments made by the Council.

PUBLIC SAFETY ISSUES

The Chevy Chase police reported giving a number of speeding tickets and warnings to drivers traveling on both Connecticut Avenue and Taylor Street. They responded to a call for suspicious persons on Bradley Lane (kids looking inside cars parked on the street who were shooed away), the loss of a diplomatic license plate on Georgia Street and the arrest and jailing of a drunk driver followed from Oxford St up Connecticut Ave until he was stopped on Taylor Street.

BUILDINGS AND ROADS

In addition to granting the variance to Dr. Tamagna and the discussion of the proposed re-subdivision of Bradley and Connecticut Avenues, the Council discussed the recent sign inventory by our consulting engineer, Joseph Cutro. It was found that almost 50 percent of all our signs are in poor condition and need to be replaced and in some instances, moved.

The Village Manager is getting pricing for the signs and their installation and will be reporting back to the Council about this and about possibly replacing all the street signs with new, easily readable signs which would distinguish Section 3's boundaries in style and color.

The Village Manager also reported that all the cracks in the street found during the survey of the condition of streets and sidewalks conducted with consulting engineer John Strong of Huron Consulting, will be sealed on March 26, weather permitting. Estimates for the concrete work and milling and overlay work will also be provided to the Council at the next meeting.

The Buildings and Roads Council representative Carolyn Greis reported that she was meeting with developer Jim O'Brien regarding the demolition and construction of the two homes he owns on Florida Street. She also reported that Gil Wilson is busy finishing up the demolition of the former Lyerly home on Taylor Street. She noted that the Keller family is about to apply for a fence permit for their property on Taylor Street.

The Village Manager discussed the upcoming WSSC work and attempts to try and get the agency to coordinate various offices within the agency to time their work so that residents would have the least possible disruption of their lives. The water line replacement for Fulton Street and Taylor Street from Fulton to Brookville Road is tentatively slated to begin the week after Easter, on or about March 25th. The Village Manager is sending a letter to all who are affected.

COUNCIL ACTIONS, CONTINUED FROM PAGE 2 FINANCIAL REPORT

In addition to providing a current financial report, the Village Manager and the Council Chairman discussed the current Montgomery County budget concerns and how that may impact Section 3 in terms of budget planning for next year. There is a hearing with members of the County Council on March 17th which will discuss municipal revenues and possibly touch on tax duplication. There is a feeling among all the municipalities that the report recently issued by the County's Office of Legislative Oversight focused too heavily on our sources of revenues and our reserves without understanding our expenses or plans for our reserves. With the exception of Rockville and Takoma Park, all 19 of Montgomery County's municipalities and the three special taxing districts are debt-averse, so reserves are used for major projects rather than facilitating borrowing. The concern is that in tight budget times, it would be easy for the County Council to focus on those reserves and decide to cut our tax duplication payments, which compensate each municipality for services paid for by our property taxes that Section 3 provides (hence the name tax duplication). This way, our residents pay for services only once, not twice, via their taxes. For example, your county property taxes pay for snow removal services among other things. Section 3 provides snow removal services, so the county has a formula (currently being revised in a joint committee) which looks at what the county spends per household or per capita for snow removal that they would have otherwise provided to us, and reimburses Section 3 for those expenses. The extra costs which Section 3 incurs to shovel the walks of our seniors, are not reimbursed because the County does not provide that service.

COMMUNITY AND SOCIAL

The Easter Egg Hunt plans are well in hand for March 22nd and a postcard will be sent to families with young children to remind them of the date. The House Tour is tentatively slated for May 4th and the Village Manager is working on getting together the tour.

The Village Manger is still working on the history of Section 3 and has found fascinating minutes from early Council meetings. Once the first draft is finished, she will have several key people within the Chevy Chase Historical Society check the accuracy of the information she's found and it will accompany every house history.

The meeting adjoured at 9:20 p.m.

If you are listed in the yellow Section 3 Directory, then we know you deserve to vote here. If you have not registered to vote with the Montgomery County Board of Elections, please do so at once. Their number is (240) 777-8683 or you can go to their website: www.montgomerycountymd.gov or pick up registration applications at the post office or public library.

VOTER REGISTRATION

Unlike most jurisdictions, if you live in Section 3, we want you to vote in our elections—even if you're not a citizen of the U.S. Our only requirement is that you be 18 years of age and own or rent in Section 3. Those who have registered with us in prior years do not have to re-register. If you are listed in the Section 3 directory, you don't need to show us proof that you're a resident. If you're not listed in the directory, we will need a copy of a driver's license with your Section 3 address or a bill proving that you are indeed a resident.

Just fill out this form and submit it to the Village Manager (3801 Bradley Lane) prior to 5:00 p.m. on election day and we'll be happy to have you vote.

Five years ago, Zack and I moved to Section 3 with our oldest son, Will. We had lived in DC for eight years at that point, and every time we drove through Chevy Chase, we imagined what a wonderful place it must be to live. 
It is in this spirit of good community stewardship that I am eagerly volunteering to serve on the Council and respectfully ask for your vote in the upcoming election.
