## Council Approves New Street Lights

At its November meeting, the Town Council took a positive step towards improving the quality and quantity of Town street lighting. In response to resident requests, the Council approved the installation of 6 new street lights in locations identified as dark areas by the recent street light evaluation study. The specific locations are listed on the Town website.

In October, the Council approved a policy for considering requests for new street lights and approved a budget of \$20,000 for new street lights in this fiscal year. This amount will allow the Town to purchase and install approximately 13 new street lights over the next 7 months.

Residents are encouraged to continue to request new street lights by using the form available on the Town's website, but are reminded that the Town may not be able to fund the installation of all requested lights in this fiscal year. The Council will consider all requests and prioritize those located within dark areas and along major commuter routes in Town.

## Building Ordinance Changes Approved

At its **November 9** meeting, the Town Council held a public hearing on and approved several amendments to the Town's Building Ordinance. The changes to the ordinance, which were recommended by the Town's Land Use Committee, relax some permitting requirements, allow accommodations for accessibility by disabled persons, codify existing practices and clarify some provisions.

The Council approved all proposed changes, except for those related to guard rails and hand rails, and clarified language related to the placement of air conditioners and heat pumps within side yard setbacks. The Council asked the Land Use Committee to consider further the proposed guardrail regulations and report back to the Council with recommendations.

The full text of the approved ordinance is posted on the Town's website.

**11/13/11**

A resident in the 7300 block of Meadow Lane reported that her son's car was broken into. The window was smashed damaging the door and the seat.

## Public Hearing on Permit Parking on Hillcrest Place

At its **December 14** meeting, the Town Council will hold a public hearing on amending the permit parking area along the 6800 block of Hillcrest Place. In November, the Council proposed to reduce the area reserved for permit parking on this block in order to create more spaces for public parking immediately adjacent to Chevy Chase Elementary School. The current parking restriction encompasses the entire frontage of 6808 Hillcrest, providing for parking of 5 to 6 vehicles. The Town Council proposes to reduce this area to provide permit parking for approximately 3 to 4 vehicles.

Residents are encouraged to attend the **December 14** public hearing. The Council meeting will begin at 7 p.m. in the Town Hall. ## CC Club Decides Against Use of Methyl Bromide

The Town is pleased to report that the Chevy Chase Club has decided against using methyl bromide to treat its golf course greens in response to concerns expressed by the Town, other neighboring municipalities, and state lawmakers. Town representatives attended a meeting with Club administrators to request an alternative solution to treat the Club's golf greens. The Town and others cited major health concerns with the use of methyl bromide, as well as negative effects on the ozone layer. In late October, the Club informed the Town and the community of its decision to refrain from using this highly toxic substance, and the Town has asked the Club to keep us informed about alternative plans.



# Preparations for Winter Weather

The Town has taken a number of steps to prepare for the upcoming winter season. An overview of our winter preparedness plans follows.

## **Street Snow Removal:**



The Town's maintenance crew, supplemented by Mulheron Tree Experts, will remove snow from Town streets. In storms producing less than 3 inches of snow, the Town's maintenance crew will plow streets without assistance from Mulheron. In significant storms, Mulheron will provide heavy equipment, such as skid loaders and back hoes. The Town has a snow removal operations plan in place that specifies the number of trucks to be used and the routes of those trucks during storm events of varying magnitudes.

## **Sidewalk Snow Removal:**

The Town's contractor, Mulheron Tree Experts, will continue to remove snow from Town sidewalks and crosswalks if accumulations total 3 inches or more. Several areas of Town have been prioritized for clearing, including sidewalks leading to and from Elm Street Park, those around CCES, as well as the Thornapple Path. Mulheron has equipment and supplies in the Town garage to expedite their response time.

## **Trees and Power Lines:**

The Town arborist will continue to survey the Town following significant winter storms. The arborist will assemble a list of any damages to Town trees and provide it to the Town's tree maintenance contractor for immediate remediation. The Town will report all downed power lines to PEPCO.

## **Power Outages:**

Please report power outages directly to PEPCO at 1-877-PEPCO-62 to ensure that PEPCO knows you are without service and can schedule repairs.

## **Fire Hydrants:**

The Town has installed fire hydrant flags, which help identify hydrant locations in emergency situations during significant winter storms.

## **Communications:**

The Town will use voicemail, the Town website and the Town Crier to communicate with residents during winter storms. Town staff will communicate early following the onset of the storm as well as often during the storm. We will attempt to relay Town service interruptions (e.g. cancelled trash collection, etc.) in a timely way, preferably on the day prior to any anticipated interruptions.

## **Office Coverage:**

During significant winter storms, Town staff may not be able to maintain a presence in the Town Office. However, staff has the capability to monitor voicemail and e-mail remotely as well as to update the Town's voicemail and website and to send Town Crier alerts to residents.

## Climate and Environment Committee

### **Energy Trailblazers of the Month: John and Jill Kolakowski.**

If a 60,000 pound rig rumbled in and prepared to drill two 450 ft deep holes into your backyard, you'd be forgiven for having a couple second thoughts. After deciding to revamp his HVAC system as a geothermal system for part of a home renovation, John Kolakowski found himself wondering "are my wife and neighbors going to kill me?" and then hoping "this will be as smooth as advertised." Thankfully it was, and John is still happily married, on good terms with his neighbors, and the backyard is no worse for wear. ### **Energy Tip of the Month**

When you're snuggling in front of the fireplace do you see all those dollar bills going up in flames? It's true. Not only is your fireplace not heating the room more than a couple of feet from the fire, it's actually sucking the heated air from the rest of the house and sending it up the chimney. An open damper can add 30% to your heating bill, and 80% of us forget to close the damper. If you have a gas-fired fireplace, you're losing even more if the pilot is lit all the time. What can you do? Close your damper whenever there is no fire burning and extinguish the pilot. Then go to the Town website to find several things you might do to prevent your money from going up in smoke.

### **Less Parking and More Congestion Coming Soon to Bethesda**

On or about January 15, parking and traffic conditions in Bethesda will worsen as construction begins on new development at the intersection of Woodmont and Bethesda Avenues. During construction, the area will lose approximately 300 metered spaces on the two existing surface lots—one across from Barnes & Noble next to Ourisman Honda, and the other across the street beside Print 1. Construction is expected to last three years.

To assist with interim parking, a third Bethesda shuttle bus will begin operating on December 1. Buses will run every six minutes during peak hours to help people reach garages around downtown Bethesda more quickly.

By March 15, the block of Woodmont Avenue between Bethesda Avenue and Leland Street will be closed to traffic for approximately 20 months. During that period, Miller Street (between Woodmont and Wisconsin Avenues) will remain open, but the stretch of Leland east of Woodmont will be closed to traffic entering from Woodmont. It will remain open from Bradley Lane onto Woodmont and continuing to Wisconsin Avenue. Once construction is completed, traffic on Bethesda Avenue will shift as lanes become straighter and shrink from four to three lanes: two for traffic and one turn lane.

The new Bethesda development, located on 3.1 acres of Montgomery County-owned parking lots, will include two condominiums, both with ground-level retail. A new underground parking garage will contain an estimated 800 to 900 spaces for public use, a net gain of 500 to 600 parking spaces. The garage will be part of a five-story, 162-unit condo on the larger lot across from Barnes & Noble. Across the street, a nine-story condo with 88 units will be built.

The County has budgeted \$49 million of the anticipated \$89 million cost of constructing the underground parking lot. To finance construction, the County will issue bonds through the Bethesda Parking Lot District to be paid back by parking-meter revenue. The Capital Crescent Trail will remain open during construction. After everything is finished, bike lanes will be added on the block of Bethesda Avenue west of Wisconsin Avenue, as called for in the Bethesda Master Plan.

## **DRIVE WITH CARE! WALK WITH CAUTION!**

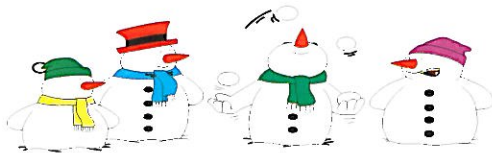
