which resulted in the continuation of an all-female Town Council. Our residents are to be congratulated for setting this example.

As someone who has been involved for over two decades with political organizations promoting the candidacies of female citizens, I am the biggest booster of our Council's current lineup. According to many studies, men are more likely to run for public office than women. I am so glad that our Council members chose a different path. In my view, the Town is all the better for it.

Promote Wellness: Step Out In Somerset

Spring is coming and Somerset's newly invigorated Health and Wellness Committee invites you to "step it out" in the neighborhood–all you need is a good pair of walking shoes! The American Heart Association recommends walking 10,000 steps, or five miles daily, to improve health and decrease the risk of heart disease–the number one killer of men and women in America. But don't be intimidated if 10,000 steps sound like a lot–start slowly and increase the amount over time. Every step counts!

Fortunately, Somerset is ideally located for walks to parks, schools, stores and restaurants. We've mapped out three routes (with more to come) in case you're interested in calculating and building your numbers. Here are a few routes:

Route #1: Start at Little Surrey and Dorset, head north on Surrey and take a right on Cumberland. Turn left at the alley (before Somerset School), cross Drummond, follow the walking path and continue on Stratford straight through the circle ending at Norwood Park. Turn around and retrace your steps back to the beginning. 2400 steps–approximately 1¼ miles and relatively flat.

Route#2: Follow the directions above; however, when you reach Stratford and Norwood Drive, take a left and follow Norwood Park through the parking lots until you reach the paved walking path adjacent to the fields. Stay on the path until it dead-ends at the bottom of the hill. Take a left

Town Website Redesign

At the April 2013 Council Meeting, it was decided to enter into a contract with a company called CivicPlus to begin a complete overhaul of the Town's website. CivicPlus is endorsed by the Maryland Municipal League and Maryland Association of Counties, and is a nationally known firm that specializes in municipal government websites. The Town's Ad Hoc Communications Committee researched multiple firms and will assist in the transition to the new site. This transition will likely take four to six months.

Swimming Pool Information

The Pool will be open on **Saturday, May 18, 2013** and remain open through **Sunday, September 15, 2013**.

WSSC Project



At the April 2013 Council Meeting, an Agreement with Washington Suburban Sanitary Commission was finalized, following three public meetings, for work to take place on roadways within the Town of Somerset starting in the next month or so. Please note that

WSSC will be coming back to the Town to apply to do work in the Environmentally Sensitive Areas in coming months. Please let me know if you have any questions.

4701 Willard Avenue Project

A project will be taking place at the 4701 Willard Avenue apartment building (formerly the Irene) starting in the next few months. The owners have obtained approval from Somerset to use a small portion of its land at the rear of the building as a staging area. The Town, through multiple public meetings with the applicant, has worked out a set of conditions that includes restoring the land back to its original condition, providing tree and stream protection and the planting of some tree screening upon completion of the project. Please let me know if you have any questions.

Council Meeting Actions

The Town Council met in regular session in April 1, 2013. The Council took the following actions:

- 6. Approval of the reappointment of Aaron Bobeck as the Youth representative to the Pool Committee for a 1 year term.
- 7. Approval of the reappointment of Miriam Tavens to the Parks and Natural Resources Committee for a 3 year term.
- 8. Approval of the reappointment of Kristen Khanna to the Parks and Natural Resources Committee for a 3 year term.
- 9. Approval of an application submitted by Sara Ridgway, 4708 Falstone Avenue, for a replacement HVAC Unit contingent upon it meeting the required noise levels.
- 10. Approval of an application submitted by Steven Guttentag and Stacey Winick, 5608 Warwick Place, to install a replacement HVAC Unit contingent upon it meeting the required noise levels.
- 11. Recommendation of the Local Advisory Panel to the Historic Preservation Commission on two planned modifications at 4727 Essex Avenue. The two proposed modifications are: construct a 5 foot wooden fence along the rear property; and construct a 5 foot double gate at the west rear of the house to an existing rear west side property line fence.
- 12. Approval of an application submitted by the Washington Suburban Sanitary Commission to perform sewer rehabilitation work in the Town of Somerset at the following locations: Surrey Street 126', Trent Court 177', Essex Avenue 286', Deal Place 105' (Pipe Bursting), Cumberland Avenue (Trenchless Repair of Lateral), Warwick Place (Manhole Repair), Dorset Avenue (Manhole Repair)
- 13. Approval of a Final Letter of Conditions Agreement for project to be located at 4701 Willard Avenue as reviewed by the Town Attorney.
- 14. Approval of the following trees to be planted by PEPCO: 9 Serviceberries along 4807 Dorset Avenue, 2 Serviceberries near the sign at the entrance of Little Falls and Dorset Avenue, and 1 Dogwood at 5812 Warwick Place.
- 15. Approval of the removal of 12 trees at 4816 Dorset Avenue and reforestation plan to include the planting of 16 trees at the property.
- 16. Approval of the emergency removal of a sugar maple tree at 4902 Cumberland Avenue as recommended by the Town Arborist.
- 17. Approval of a contract with Icon Enterprises, Inc, CivicPlus, for the re-design and maintenance of the Town Website.
- 18. Approval of a contract with Camp Summerset for the use of the Town Pool for the 2013 season.
- 19. Approval of revised Pool Party Rules as recommended by the Pool Committee.
- 20. Approval of a proposal from Vigilant Security for remote monitoring at the Town Pool for the 2013 pool season.

In addition to the actions taken by the Council, Mayor Slavin introduced the proposed FY'14 Budget and provided his Mayor's Report. Town Manager Charnovich presented the March Financial Report.

Mayor Slavin and the Town Council recognized Somerset Elementary School 5th grader, Caroline Louttit (Trent), for her diligent attendance to Town Council meetings over the years. Caroline's brother Benjamin, was also at the meeting and is close to achieving the rank of Eagle Scout.

Town Inspector Larry Plummer provided construction update reports for projects at 5529 Uppingham, 5510 Trent, and 5513 Uppingham Street.

Approval of the Swim Team Handbook was tabled until the May Council Meeting so the Town Attorney could review the Handbook.

Spring Tennis Reminders

The following is a report from the Tennis Committee on what you need to know about the upcoming season.

Tennis Identification Cards

- 1. Somerset residents may either purchase cards **in person** at the Town Hall **or mail a check** to **the Town Hall**. If you choose to **mail a check**, please be sure that your correct home address appears on the check. The tennis card will be delivered to this address. Checks should be made out to "Town of Somerset." The annual fee is \$20 per household, the same as last year.
- 2. When you are playing on the courts, please display a card in the appropriate slot on the entrance gate.
- 3. Please **do not lend** your card to non-residents.

Etiquette Rules

The board next to the courts displays a sheet entitled *"Town of Somerset: Tennis Etiquette."*

Here are some of the rules of etiquette on the courts:

- 1. "When taking possession of your court, don't walk across the back of another court while a point is in progress. Wait until it is completed."
- 2. "Don't carry on an extended conversation across the net while playing . . . your chatter will disturb players on the next court."
- 3. "Keep your shouts of dismay or jubilation in the low decibel range."
- 4. "While waiting for a court or after finishing, don't chat near the fence–it disturbs players."

Camp Summerset Court Days and Times

The Town Council has agreed to give Camp Summerset exclusive use of the courts from **10:30 a.m. to 12:00 p.m. on June 24th through July 5th** (except for July 4th). The courts will be closed to residents at those times.

We Want Your Views

The tennis courts are a great asset for the Town and its residents. Last year, almost 90 cards were sold, indicating that over 20% of households use the courts. As the tennis season progresses, the Tennis Committee welcomes residents' views. For example, we would like feedback on the following questions:

1. Are the new regulations, particularly those relating to group lessons, satisfactory?

- 2. Are there other rules of etiquette that should be adopted?
- 3. Should the town install a key or pass code system for access to the courts?
- 4. Should the town sponsor events such as tournaments, ladders, or group lessons?

Proposed Landscape Design For Dorset/Little Falls Entrance

Somerset's **Parks and Natural Resources Committee (PNRC)** is planning a renovation of the planting that surrounds the Somerset sign at the juncture of Dorset Avenue and Little Falls Parkway. Somerset's Town Council and Montgomery County have approved the plan.

The planting will be done in two phases. This spring, the borders will be enlarged, and two serviceberry trees and a grouping of American hollies will be planted behind the sign, incorporating three of the existing hollies. Next fall, native grasses, evergreen Cotoneaster, Pacificum chrysanthemums, and Nepeta (Catmint) will be placed in front of the sign. All of these plants are suitable for the conditions of this site which faces southwest. They are drought tolerant and thrive in our abundant summer sun. This planting is consistent with the principals of conservation landscaping which the committee is proposing for the Town. More information about conservation landscaping will be provided to residents by early summer.

heading back towards Somerset and make a left on Dorset. Return to the beginning at Little Surrey and Dorset. **3400 steps–approximately 1¾ miles with one major hill.**

Route #3: Start at Little Surrey and Dorset, head west down Dorset towards Kenwood. Cross Little Falls Parkway into Kenwood staying on Dorset until you reach the top of the hill. Turn right on Highland and follow until it dead-ends. Take a right on Chamberlin and a right on Kennedy. Take a left on Dorset crossing Little Falls Parkway back into Somerset and turn left on Devon. Proceed right on Cumberland up the hill and take a right at the school on Warwick. Make a right on Dorset and return to Little Surrey. **4900 steps–approximately 2½ miles with two major hills.**

Remember 10,000 steps is the magic number so grab your neighbor, take your dog, include your kids and start walking! In a couple of months we'll add more routes, form walking groups, provide information on pedometers, and sponsor some fun competition,

Update On Cicadas

The 17-year cicada in this area, Brood II, will emerge this year. These cicadas have black bodies and red eyes, emerge mid-May, and complete their life cycle by the end of June. The adults do

Cicadas Emerge This Year

feed on woody plants but potential damage to trees and shrubs occurs when the female cicadas insert eggs into the tips of twigs. These twigs are damaged enough to cause the loss of the tips of branches. On large trees, this loss is minimal. On smaller trees, it significantly reduces the canopy, but even smaller trees do recover. You may isolate young trees with screening to prevent damage, but there are no treatments to manage the cicadas.

Cicadas do not bite people or carry or transmit any diseases. They are a great food source for birds and a true wonder of nature. An informative website for more information is at *www.magicicada.com*.
