Dear Governor O'Malley:

On behalf of the Governor's Office of Crime Control & Prevention and the Maryland State Board of Victim Services, in accordance with Criminal Procedure Article Section 11-914, we are pleased to respectfully submit this comprehensive report covering fiscal year 2013. This report is submitted, as mandated, to you, the Attorney General and the Secretary of the Department of Public Safety and Correctional Services.

You will find the report contains both the Board's accomplishments in FY2013, along with recommendations for the continued strengthening of programs and services to Maryland's crime victims. The report clearly shows that the State Board continued many of its long-term, dedicated commitments to ensuring critical services and support to Maryland's crime victims remain available, i.e., Victim Information and Notification Everyday (VINE), continued funding for the Legal Services for Crime Victims grant; and a continued commitment to Maryland's Child Advocacy Centers.

In addition, the State Board undertook new initiatives to meet the needs of underserved crime victim populations. Specifically, the State Board convened a working group to begin to identify the support and service needs of homicide survivors and to identify if those services currently exist state-wide to create a true service map for homicide victims. This research will continue in FY14 and the findings will be presented in an Executive Summary once all research is complete to offer recommendations for ensuring a continuity of services no matter where a homicide survivor(s) live within the State. The State Board also collaborated with members of the Maryland State's Attorney's Association in reviewing and modifying the current Victim Witness Protection and Relocation Fund Guidelines resulting in increased financial assistance to families of homicide and other violent crime categories with trial attendance-related costs.

We are very proud of the dedicated work the State Board, the State Victim Services Coordinator and the staff of the Governor's Office of Crime Control & Prevention. We are honored to support you in our shared goals, and to see these efforts benefiting the needs of crime victims in our State. While we are all justly proud of the strides made on behalf of crime victims, we know that the needs of crime victims are ever changing and the State Board looks forward to working collaboratively with criminal justice, non-profits and other organizations around the State in FY14 to continue to bring dignity, respect, and sensitivity to all crime victims that addresses changing needs.

Annual Report FY2013

I. OVERVIEW

The Maryland State Board of Victim Services (Board) and the Governor's Office of Crime Control & Prevention (GOCCP) are pleased to present this report for Fiscal Year 2013. The annual report highlights the important work carried out by the State Board, State Victim Services Coordinator (State Coordinator) and GOCCP staff, who work in partnership with crime victim service providers, communities, State agencies and the federal government to better serve Maryland crime victims. This report encompasses the Board's activities for the period of July 1, 2012 through June 30, 2013. The Board continues its efforts to improve the treatment of crime victims through legislative action, working collectively with criminal justice agencies and private non-profit organizations, creating and expanding innovative initiatives, while welcoming feedback and suggestions from individuals and communities across the state.

II. STATE BOARD OF VICTIM SERVICES

Recognizing the unique and distinctive needs of crime victims, the Maryland General Assembly created the State Board of Victim Services and the position of the State Victim Services Coordinator in 1988. This was done for the purpose of monitoring, assessing, coordinating and making recommendations concerning state and local efforts to assist victims of crime. The Board's mission is to ensure that all crime victims in Maryland are treated with dignity, respect and compassion during all phases of the criminal justice process. In 1991, under the authority of GOCCP, the Maryland General Assembly created the Maryland Victims of Crime (MVOC) Fund to provide funding support for victim services. MVOC money is generated by the collection of court costs imposed on convicted defendants, which is subsequently used to award grant projects that provide direct services to help crime victims. The State Board and GOCCP administer and manage the MVOC and Legal Service for Crime Victims (LSCV) grant projects.

From a national perspective, the State Board is a unique entity; Maryland is a leader in this respect. The GOCCP continues to support State Board activities in the national and statewide arenas.

III. ACCOMPLISHMENTS

Listening to State and local criminal justice agencies and service providers in the field, the State Board took action, which resulted in the following accomplishments:

1. Families of Homicide: The highest and most pressing issue for the State Board over the last two years is meeting the needs of families of homicide victims. In order to accomplish this task, the State Board is assessing existing services; and researching models, best practices and recommendations from other states and the Nation to provide recommendations for these services in Maryland. A report will be completed by the end of 2014 for the Governor.
2. The State Board awarded thirty-two (32) grants totaling \$851,713 in FY 2013 from the Maryland Victims of Crime Fund for direct services to crime victims;
3. The State Board awarded one (1) grant totaling \$75,000 from the Legal Services for Crime Victims fund for legal services to crime victims in the criminal court system;

4. Child Advocacy Centers (CAC) is a priority for the State Board. In 2011, the General Assembly found there was an increase in the number of sexual assault victims in the State. To address this concern, GOCCP was charged with establishing and sustaining child advocacy centers in Maryland. Furthermore, money for child advocacy centers would now receive funding from the State Budget to supplement, but not supplant, money that programs received from other sources. (Md. CRIMINAL PROCEDURE Code Ann. § 11-923 (2011)). Simultaneously in support of this legislation, the Maryland Victims of Crime (MVOC) Fund law was amended to include supporting child advocacy centers. (Md. CRIMINAL PROCEDURE Code Ann. § 11-916 (2011)).
5. Victim Information and Notification Everyday (VINE) continues to provide information and notification for hearings in District and Circuit courts; custody status of inmates in twenty four (24) detention centers and at the Division of Corrections for offenders on parole and probation; as well status changes for offenders in the Sex Offender Registry. Since 2000, The State Board promotes VINE usage, coordinates trainings and provides daily maintenance and troubleshooting statewide for crime victims, governmental users and citizens who are involved in the criminal justice system.
6. In an effort to integrate crime victim access, mandated forms and information in the developing court case management system, the State Board is following directives from Administrative Office of the Courts, IT Department while collaborating with the Maryland Judiciary and Maryland Electronic Courts (MDEC) by providing documentation, recommendations and guidance for the inclusion of VINE and later the Crime Victim Notification and Demand for Rights Form (CVNF). Crime victims' rights, recognized in current court processing systems, remain an essential component of the planning and successful implementation of the new integrated electronic court system.
7. The State Board conducted two (2) meetings *on-the-road* this fiscal year. The purpose was to educate board members on the practices and needs of communities while providing service providers, local governments and non-profits a platform to voice their opinions before a panel of State and local government representatives. Child Advocacy Centers, government and non-profit organizations all stated that seeking additional funding was a priority to continue and improve services for crime victims in their communities. This topic and others are included in the *Recommendations to the Governor* section of this report.
8. The Roper Victim Assistance Academy (RVAAM) provided basic and advanced training to one hundred and twenty one (121) students in 2013. RVAAM is modeled on the national Victim Assistance Academy, a 40-hour, academically-based education and training program that covers a broad array of topics in victims' rights, victim advocacy and victim and witness services in the criminal adult and juvenile justice system. A victim service provider certification program was implemented in 2012 and this year, eighteen (18) students received their certification.
9. Criminal Injuries Compensation (CICB) funds: The State Board works closely with CICB, as the payer of last resort, to ensure that crime victims are properly compensated for funeral expenses, lost wages, medical expenses and other costs eligible under this mandated fund.

IV. RECOMMENDATIONS TO THE GOVERNOR

Building upon these accomplishments, the State Board of Victim Services has articulated specific recommendations for future initiatives. As required by Md. Code, Criminal Procedure §11-914, the State Board is submitting the recommendations to the Governor for the improvement of the treatment and services available to Maryland's victims of crime, as follows:

- Recommendation #1 Provisions should be made to accommodate the individual statewide needs of families of homicide victims. The loss of a loved one is devastating, and the added hardships of funeral and medical expenses, and lost wages are just a few of the costs that an already economically struggling family can incur as a result of a homicide.
- Recommendation #2 Provisions should be made in District and Circuit courts that increase costs imposed on convicted defendants that are distributed into the Maryland Victims of Crime (MVOC). Citizens and crime victim service providers are seeking continuing support for crime victims through services, statewide trainings, federal and State policies, technology and public awareness and community outreach.
- Recommendation #3 Child Advocacy Centers (CAC) should remain a priority for the Governor through state supported funding, collaborative regional trainings and the promotion of public safety linkages and partnerships between and among federal, state and local agencies.
- Recommendation #4 Roper Victim Assistance Academy (RVAAM) should remain in the state budget supporting basic and advanced training for crime victim service providers and first responders. The certification program for service providers who work at the local and state level provides the necessary skill set to best serve crime victims as they move through the criminal justice system and on with their lives.
- Recommendation #5 Maryland should be a leader in the effort to assist the underserved population of crime victims with disabilities through outreach, training and the encouragement of state and local agency collaboration.
- Recommendation #6 Maryland should continue to support Victim Information and Notification Everyday (VINE) courts, custody, parole, probation, sex offender alert line services as a line item in the State budget.
- Recommendation #7 Maryland should be an active participant with the Maryland Judiciary and Maryland Electronic Courts (MDEC), a new court case management system with integration of crime victims' rights court forms and information.

VII. LEGISLATION

The State Board Legislative Committee works closely with GOCCP during the legislative session. Information is shared and testimony provided before the Legislative committees, all in the best interest of serving crime victims in Maryland. The majority of proposed legislation from the Governor relating to crime victim issues is supported by the majority of State Board members.

2013 LEGISLATIVE SESSION

The State Board voted to send letters to the appropriate Legislative committees *in support* of the following bills:

SB 489/ Ch. 485 HB 1211 / Ch. 486

Senators Shank and Getty

Entitled: Estates and Trusts – Slayer’s Statute (Ann Sue Metz Law)

Synopsis: This bill disqualifies a person who feloniously and intentionally kills, conspires to kill, or procures the killing of a decedent from benefitting from the death of the decedent. The bill applies only prospectively, to the estate or property of a person who dies on or after the bill’s effective date of October 1, 2013. –*Passed*

SB 276/Ch. 156 HB 295

The President (By Request – Administration) and Senators Gladden, Raskin, Benson, Conway, Currie, Ferguson, Forehand, Frosh, Jones–Rodwell, Kelley, King, Madaleno, Manno, McFadden, Montgomery, Muse, Peters, Pinsky, Pugh, Ramirez, and Rosapepe

Entitled: Death Penalty Repeal and Appropriation from Savings to Aid Survivors of Homicide Victims

Synopsis: For the purpose of repealing the death penalty; repealing procedures and requirements related to the death penalty; providing that in certain cases in which the State has filed a notice to seek a sentence of death, the notice shall be considered withdrawn and it shall be considered a notice to seek a sentence of life imprisonment without the possibility of parole under certain circumstances; providing that certain persons serving life sentences are not eligible for Patuxent Institution under certain circumstances; altering the circumstance concerning parole for persons serving life sentences when the State sought a certain penalty; requiring the Governor to include in the annual budget submission for certain fiscal years a certain amount for the State Victims of Crime Fund; making conforming and clarifying changes; and generally relating to the repeal of the death penalty. - *Passed with amendments*

Entitled: Firearm Safety Act of 2013

Synopsis: For the purpose of altering the authorization for a person to wear, carry, or transport a handgun to be within certain limitations; ... - *Passed*

SB 258 HB 921/Ch. 652

Senator Shank

Entitled: Correctional Services – Inmate Earnings – Compensation for Victims of Crime

Synopsis: For the purpose of adding a requirement that the Department of Public Safety and Correctional Services pay compensation for victims of crime in accordance with certain provisions to a list of deductions that the Department is required to withhold from an inmate’s earnings; requiring the Department to withhold a certain amount of the earnings of an inmate in a certain program for compensation for victims of crime; requiring the Department to allocate earnings that are withheld in a certain manner; requiring the Criminal Injuries Compensation Board to distribute certain amounts to a certain person or governmental unit; establishing that compliance with a judgment of restitution is a required condition of work release if work release is allowed; applying certain provisions relating to responsibility for the administration of payments of restitution to the Department instead of to the Division of Parole and Probation; requiring the Department to submit a certain report by a certain date; altering the purpose of the Criminal Injuries Compensation Fund to include distribution of certain restitution payments; and generally relating to compensation for victims of crime. - *Passed*

HB 116/Ch. 39 SB 267/Ch. 38

Delegates Mitchell, Clippinger, Cluster, Conaway, Cullison, Gutierrez, Haynes, McDermott, Oaks, B. Robinson, and Rosenberg

Entitled: Courts and Judicial Proceedings – Interception of Communications – Abuse or Neglect of Vulnerable Adult and Medicaid Fraud

Synopsis: For the purpose of adding abuse or neglect of a vulnerable adult and offenses relating to Medicaid fraud to those crimes for which certain evidence may be gathered by, and a judge may grant an order authorizing, interception of oral, wire, or electronic communications; and generally relating to interception of communications. - *Passed*

HB 478/SB 861

Delegate Simmons

Entitled: Crimes – Committing a Crime of Violence in the Presence of a Minor – Penalties

Synopsis: For the purpose of prohibiting a person from committing a certain crime of violence when the person knows or reasonably should know that a minor of a certain age is present in a residence; establishing certain circumstances under which a minor is present; establishing a certain enhanced penalty for a violation of this Act; authorizing a court to impose an enhanced penalty if the State’s Attorney provides certain notice to the defendant in a certain manner and if certain elements have been proven beyond a reasonable doubt; authorizing the State to include a certain notice in a certain indictment or information; providing that a person who violates this Act is guilty of the abuse of a child under 18 for certain purposes; and generally relating to the commission of crimes of violence in the presence of minors. - *Not Passed*

HB 1186

Delegates McComas, Cardin, Carter, Clippinger, Cluster, DeBoy, Dumais, Eckardt, Frank, Glass, Hogan, Lee, McConkey, McDermott, McDonough, Mitchell, Otto, Ready, B. Robinson, Rosenberg, Simmons, Smigiel, Sophocleus, Stocksdale, Swain, Valentino–Smith, and Wood

Entitled: Task Force on the Prevention of Child Abuse and Neglect Synopsis: For the purpose of establishing the Task Force on the Prevention of Child Abuse and Neglect; providing for the composition, chair, and staffing of the Task Force; prohibiting a member of the Task Force from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Task Force to study and make recommendations regarding certain matters; requiring the Task Force to report its findings and recommendations to the Governor and the General Assembly on or before a certain date; providing for the termination of this Act; and generally relating to child abuse and neglect. - *Not Passed*

HB 1382

Delegates McDermott, Cluster, Ready, and Stocksdale

Entitled: Sentencing Procedures – Statement by Victim or Victim’s Representative (Alex’s Law)

Synopsis: This bill requires, if practicable, a court, in a sentencing or disposition hearing, to allow a victim or the victim’s representative (victim/representative), at the request of the victim/representative, to address the court before imposition of sentence or other disposition. - *Not Passed*

HB 154

Entitled: Criminal Procedure – District Court – Stay of Sentence Pending Appeal

Synopsis: FOR the purpose of requiring the District Court, if a person is convicted of a crime in District Court, to stay any sentence imposed that includes an unserved, non-suspended period of imprisonment for a certain period of time under certain circumstances; authorizing a defendant to waive a certain stay of sentence pending appeal; and generally relating to criminal appeals. - *Not Passed*

VII. STATE BOARD OF VICTIM SERVICES INITIATIVES

VICTIM INFORMATION NOTIFICATION EVERYDAY (VINE) INITIATIVE (TOLL FREE 866-634-8463 or www.VINELink.com)

VINE is an information service that provides victims of crime with dates for upcoming court hearings, custody status of offenders in local jails and state prisons, as well as parole and probation notification.

Appriss Contract (November 1, 2010 to October 31, 2015)


- The Appriss, Inc. contract and a state related technical portion of the services are managed by The Department of Public Safety and Correctional Services, Information Technology & Communications Division;
- The State Victim Coordinator works closely with the Appriss Account Manager to monitor usage, troubleshoot, and prepare statewide training events;
- VINE account and program are managed daily by the State Coordinator;
- The contract includes information and notification services for District court, Circuit court, detention centers, Division of Corrections, Community Supervision (parole and probation), sex offenders and Protective Orders;
- A professional Appriss, Inc. trainer provides seven (7) statewide VINE trainings per year;
- Materials are included in the contract and distributed by the State Victim Services Coordinator;
- VINE materials: 53,000 English and Spanish pamphlets, 300 Posters, 9,300 Tear-pads
- Public outreach is part of the agreement and a two (2) year extension was signed to start on November 1, 2013.

VINE Enhancements:

- In 2013, Appriss released the VINEMobile smart phone app that allows victims of crime to easily access information on offenders 24/7/365 from their smart phone.
- VINEWatch users now have the ability to update notification methods (phone number, TTY, email address) and apply this update to all offenders the victim is registered against.
- A Phone Number Extensions has been added to accept up to six digits for an extension.
- When registering on VINELink or VINEWatch users will now be required to enter their phone number twice to assure of accuracy and validity.
- Vinelink.com users have the option to check a box and view agency description and contact information fields.



Phone, more so than email notification continues to be preferred, however email notification is increasing annually.



VINE SERVICES

High-level

- Ongoing service operation, including live operator support 24/7/365;
- Support of interface hardware and proprietary software used to power VINE;
 - Hardware support may include providing agency a DSL line when needed or sending out a field tech to repair and/or replace hardware;
- Monitoring of all system hardware and software;
- 24 hour troubleshooting support for system alarms helping to minimize potential interruptions in service;
- All incoming and outgoing communications in both English and Spanish;
- Communications costs for transferring data;
- Ongoing support of system script and normal programming changes;
- Public relations support for generating ongoing media updates; and
- Supplies and materials to raise program awareness.

Details

- Ability to provide 24 hour sensitivity trained live operator support for English and Spanish victims including assistance with information and registration;
- Ability to provide access to a call center available from anywhere in the United States and capable of TTY communication for the hearing impaired and in various languages;
- Ability to provide automated telephone, email, and TTY notifications twenty four (24) hours a day, seven (7) days a week in English and Spanish;
- Ability to secure victim notification confirmations via assigned PIN;
- Ability to provide a means (PIN Confirmation) to stop calls when a notification has been achieved;
- Ability to provide and maintain a twenty four hours a day, seven days a week public website that allows victims to self-register;

- Ability to provide and maintain a free, private web portal for agencies to assist victims and generate usage reports;
- Ability to provide around the clock, live monitoring of Maryland statewide data feeds which assists in detecting disruptions and repairing problems proactively;
- Ability to monitor systems and agency data;
- Ability to maintain equipment, including antivirus security software, server replacement, upgrades to remote support console and Simple Network Management Protocol (SNMP) monitoring;
- Ability to conduct training (live, video, or web); and
- Ability to provide help desk support twenty four (24) hours a day, seven (7) days a week for victim advocates and Maryland officials.

Training

- VINEWatch menu for accessing *Appriss University* online training for VINE and VINEWatch;
- VINE training for parole and probation agents with DPSCS Community Supervision to better assist with offender monitoring; and
- Regional statewide trainings are conducted for service providers, law enforcement, detention centers and anyone who works with crime victims.

In conclusion, in order to operate efficiently the VINE system relies heavily on the daily flow of data from the Office of the Administration of the Courts, twenty-four (24) individual detention centers and the Department of Public Safety and Correctional Services. This requires full time supervision and attention from the State Victim Services Coordinator and the Appriss Account Manager. The VINE system continues to improve each year, providing a reliable service for Maryland citizens with accessible information and advanced notification for upcoming court hearings and changes in status for offenders in custody and on parole or probation.

VIII. MARYLAND VICTIMS OF CRIME (MVOC) AND LEGAL SERVICES FOR CRIME VICTIMS (LSCV) FUND

Maryland Victims of Crime Fund Mandate

The Maryland Victims of Crime Fund (MVOC Fund) was created by the Maryland General Assembly during the 1991 Legislative Session. The legislation created a source of revenue for programs across the state, dedicated to serving victims of crime. The primary purpose of the MVOC Fund is to ensure implementation of the Declaration of Crime Victims' Rights Amendment to the Maryland Constitution and the Guidelines for Treatment of and Assistance to Crime Victims and Witnesses and other laws adopted to benefit victims and witnesses of crime (MD Ann. Code, Criminal Procedure Article §11-916).

- The MVOC Fund receives money from court costs collected in criminal cases pursuant to §7-409 of the Courts and Judicial Proceedings Article as established under MD Ann. Code, Criminal Procedure Article, §11-916.
- The District Court and Circuit Courts have authority to impose fines on convicted offenders. In 1995 a bill was enacted increasing the fine courts could impose from \$20 to \$30 in Circuit Court and from \$10 to \$20 in District Court.
- In 1997, the court costs were increased again and codified whereby the Circuit Court fine is now \$45 and the District Court fine is \$35.
- For Traffic Court, in addition to any other costs required by law, a court shall impose on a defendant convicted of an offense an additional cost of \$3 in the case, including cases in which

the defendant elects to waive the right to trial and pay the fine or penalty deposit established by the Chief Judge of the District Court by administrative regulation.

- It is the intention of the State Board to propose another increase within the next few years. State and local criminal justice agencies and non-profits are struggling more and more each year to maintain existing crime victim services.

Court costs collections are distributed by the State Comptroller among three victims' funds under Courts and Judicial Proceedings Article Sec., 7-409:

District and Circuit Court

- MVOC (\$22.50 from each fee collected by circuit court, \$12.50 from each fee collected by District Court);
- Victim Witness Protection and Relocation Fund (\$2.50) from circuit court and District Court fees); and
- Maryland Criminal Injuries Compensation Fund (MCICB).

Traffic Court

- From the first \$500,000 in fees collected in Traffic Court in the above referenced subsection, in each fiscal year, the Comptroller shall deposit one-half of each fee (\$250,000) into the State Victims of Crime Fund and one-half of each fee into the Criminal Injuries Compensation Fund; and
- For fees collected over and above the referenced \$500,000 in each fiscal year, the Comptroller shall deposit the entire fee into the Criminal Injuries Compensation Fund.

State Board Grant Policy and Procedure

The Notice of Funding Availability (NOFA) for MVOC and LSCV funds are posted on the GOCCP Website ten months prior to the start date of the grant cycle. The State Coordinator will periodically conduct a technical assistance workshop for potential applicants. MVOC and LSCV applications are normally due by the end of November, allowing advance time for reviewing and processing the award packets. The advance grant application process allows local governments the opportunity to plan ahead for the upcoming fiscal year budget. The second and third year MVOC continuation grant applications are submitted to GOCCP and reviewed in the spring each year.

MVOC Requirements

MVOC Priorities

- Direct Services for Victims of Crime;
- Victim Advocates in Law Enforcement;
- Victim Advocates in State's Attorneys' Offices;

- Enhanced services and support for Child Advocacy Centers (Md. CRIMINAL PROCEDURE Code Ann. § 11-916 (2011)); and
- Enhanced services to crime victims that aid and promote the distribution of mandated pamphlets and educate them on their rights according to Maryland law.

MVOC PROGRAM PURPOSE AREAS

It is highly recommended that grants supported by the Maryland Victims of Crime (MVOC) Fund support at least one of the following purpose areas:

- Coordinating services for crime victims from first response through the criminal justice system and beyond which include those individuals in law enforcement, prosecutors' offices, courts, victim service agencies, other state agencies, and non-governmental organizations serving crime victims;
- Developing, enlarging, or strengthening all victim service programs including private non-profit organizations, police victim/witness sections, and District/Circuit Court victim/witness units;
- Developing or improving the delivery of crime victim services to underserved populations;
- Providing support to specialized domestic violence advocates in courts where a significant number of protection orders are granted;
- Developing, expanding, or strengthening crime victim programs addressing non-English speaking citizens;
- Providing state, regional, federal, and national training for crime victim service providers is encouraged as a sole project for an application or as an addition to a project. Topics may include, but are not limited to: communicating and networking with victim/witness service providers, cross training, interaction/communication with crime victims (i.e., first response, status of case, progress of case), judicial accountability, diversity/language barriers, understanding sexual violence, the dynamics of domestic violence, referring victims for follow-up services, promotion of Jane Doe reporting, and cultural sensitivity;
- Training of sexual assault forensic medical personnel examiners in the collection and preservation of evidence, analysis, prevention and providing expert testimony and treatment of trauma related to sexual assault; and
- Implementing community-driven initiatives to address the needs of crime victims who are included in the underserved populations: people with disabilities, elder victims of crime, and children of physical and sexual abuse.

LSCV Requirements

LSCV Priority

- The Fund was created to ensure that money obtained from unclaimed restitution under this title is used to provide legal counsel for victims of crime in the criminal court justice system [Md. Code Annotated, Criminal Procedure Article §11-919.
- Each year the Fund provides a salary for one (1) attorney salary.

- The Funds allow for legal representation and related legal support services to Maryland crime victims with special emphasis on some underserved victim populations including child, juvenile, elderly victims, sexual assault and families of homicide victims.

LSCV Purpose Area

- An attorney who will protect and defend crime victims' rights as provided by Maryland law; and
- An attorney who will provide legal counsel for crime victims in the *criminal court* system (not defense representation).

- First year MVOC applications: \$1,305,335
- First year MVOC awards: \$292,228
- Second year MVOC awards: \$279,364

- 107 crime victims were provided with counsel on victims' rights issues this quarter;
- 1 crime victim assisted was the victim of another crime during the prior 12 months;
- 227 people were referred to counseling, education and/or treatment programs; and
- 27 crime victims were assisted with restitution matters.

IX. OTHER ACTIVITIES OF THE STATE BOARD OF VICTIM SERVICES

STATE BOARD MEETING ON THE ROAD

CRIME VICTIM MANDATED PAMPHLETS AND FORMS

Pursuant to duties of the State Board and the mandates of the Constitutional Amendment, Declaration of Rights - Article 47 stating that "a victim of crime shall be treated with dignity, respect and sensitivity during all phases of the criminal justice process," the State Board developed two pamphlets to ensure that a victim's right to be informed are adhered to by law enforcement personnel, commissioners or juvenile

justice intake workers and State’s Attorneys. Statutes, entitled Victims and Witnesses, are detailed in Maryland Ann. Code, Criminal Procedure Article, Title 11.

The mandated materials are tracked in a Brochure Database system for the purpose of accountability and cost effectiveness.

Mandated Materials

CRIME VICTIMS AND WITNESSES: Your Rights and Services pamphlet

- Upon first contact with a crime victim or a crime victim’s representative, a law enforcement officer, District Court commissioner or juvenile intake officer shall give the victim or the victim’s representative the “*CRIME VICTIMS AND WITNESSES: Your Rights and Services*” pamphlet.
- This pamphlet is designed to inform the recipient of their rights and services, while outlining the steps a case may go through in the criminal justice process and explaining the criminal justice system’s responsibilities to crime victims and witnesses.
- In addition to law enforcement officers, District Court commissioners and juvenile intake officers shall also give the victim or the victim’s representative the mandated pamphlet (MD Crim. Pro. Code Ann. § 11-914(9)(i)).

The Crime Victim Notification and Demand for Rights Form (CVNF)

- The prosecuting attorney is mandated to deliver the CVNF form, together with the *Your Rights as a Victim in the Criminal and Juvenile Justice Process* brochure (below) to a crime victim within 10 days of an indictment or information filed in Circuit court.
- The CVNF provides a formal procedural request for a victim or victim’s representative to be notified of all related court hearings and offender status changes in the criminal court system.
- The CVNF follows the offender through the criminal court system, the multi-layer form provides a copy for each agency: Clerk of the Court, State’s Attorney, Detention/Division of Correction/Department of Mental; Hygiene, Parole and Probation, Attorney General’s Office and the victim/victim’s representative.

Your Rights as a Victim in the Criminal and Juvenile Justice Process pamphlet

- The pamphlet provides a crime victim or a crime victim representative in Circuit Court with information about their rights and referrals for services in the state.
- The prosecuting attorney is mandated to deliver this pamphlet, together with the *CVNF (above)* to a crime victim within 10 days of an indictment or information filed in Circuit court.

ANNUAL STATEWIDE MEMORIAL SERVICES

The Victims of Crime Memorial Service is one of two annual events sponsored by the Maryland State Board of Victim Services. The annual services are held to honor those who lost their lives to violent crime in the State of Maryland. The event commences with National Crime Victims Rights Week, which traditionally begins each year in April.

Since 2002, four regional memorial services are held simultaneously statewide. The regional locations address the growing number of participants and provide accessible locations for surviving family members.

Each year the State Board's Memorial Service Committee members meet with the hosts from the prior year's service and the hosts for the upcoming year to share information, plan, coordinate and collaborate with one another. All four services maintain uniformity with opening ceremonies led by a color guard, musical selections and the symbolic raising of the banner arranged with doves or stars representing those remembered. Two Governor's proclamations are presented: one to the hosting State's Attorney, and the other to an attending Board member. The most important and compelling part of the Memorial Service is the "Reading of the Names". Names of crime victims are written, read aloud and displayed as remembrance for family, friends and community members.

The State Board provides an annual allocation of \$1,000.00 to each region hosting a memorial service to afford regional coordinators the opportunity to plan programs without added concerns of raising money to finance events, and eliminate ensuing ethical concerns of elected officials regarding fund raising. The State Board supports the continuation of funds for each of the regions hosting services.

2013 Victims of Crime Memorial Service

Committee members from the State Board and service providers from the respected state's attorneys' offices coordinated the memorial services.

- The Northern Region service was hosted by The Honorable Frank Weathersbee, State's Attorney's Office of Anne Arundel County and held at Broadneck High School in Annapolis, Md.
- The Southern Regional service was hosted by The Honorable Lance G. Richardson, State's Attorney's Office of Dorchester County and held at the Governor's Hall at Sailwinds Park in Cambridge, Md.

GOVERNOR'S VICTIM ASSISTANCE AWARDS and COMMEMORATIVE DAY LUNCHEON



In 2013, the State Board of Victim Services combined the annual Governor's Victim Assistance Awards Luncheon with a new mandate that commemorates April 3 as Crime Victims and Advocates Commemorative Day. From this day forward, the State will annually recognize individuals who have become crime victims and will take a moment to honor the advocates who serve them. The 2013 Luncheon additionally celebrated the 30 year milestone, a historical view of Maryland crime victims' rights movement, with panel speakers and a slide show.

The Governor's Victim Assistance Awards Luncheon is held each year to show appreciation and recognition to an individual, agency, organization or group who does meritorious work on behalf of crime victims or in furtherance of the crime victims' movement in Maryland. The award recognizes outstanding work done in the area of victim advocacy and services that exceeds expected work responsibilities, and exemplifies a high level of commitment and dedication to the field of victims' rights and services and to the victims themselves. This year's awards reflect the period from January 1, 2012 to December 31, 2012.

In 2012, the Governor signed into law House Bill 766 (Chapter 678 of the Laws of Maryland 2012) which requires the Governor annually to proclaim April 3 as *Crime Victims and Advocates Commemorative Day* to give recognition to individuals in the State who have become crime victims and to honor the advocates who serve those victims. Additionally, the law requires the Governor to take appropriate steps to publicize Crime Victims and Advocates Commemorative Day. April 3 was chosen as the date for the commemorative day in memory of Stephanie Roper, who was murdered on that day in 1982 and whose family members established the Maryland Crime Victims' Resource Center, Inc.

The 2013 Governor's Victim Assistance Awards Luncheon was held on Wednesday, April 3rd at DoubleTree by Hilton Hotel Annapolis in Annapolis, Maryland.

X. MILESTONES AND ACCOMPLISHMENTS

ROPER VICTIM ASSISTANCE ACADEMY OF MARYLAND

(<http://rvaam.org>)

The Roper Victim Assistance Academy (Academy) offers two levels of training to victim service professionals throughout Maryland, a basic 40-hour Academy designed for newer professionals, and advanced and more specialized training programs designed for more experienced professionals. The basic program is a 40-hour standardized multi-disciplinary academic curriculum program conducted as a 1-week residential program. The 2013 Academy was held April 15-19, 2013 with 36 professionals graduating from the program. The Academy celebrated its tenth Anniversary with more than 2,000 participants who have received training. At the graduation ceremonies several special guests presented including Joye Frost, the Interim Executive Director of the Office for Victims of Crime, U.S. Department of Justice, who also presented staff with a Certificate of Appreciation acknowledging ten successful years as a role model for other state academies. In April, the Academy staff members were honored with a Governor's Victim Assistance Team Citation Award. The staff members were recognized for their outstanding contributions toward improving the status of crime victim services in the state of Maryland. In addition to the basic training Academy, the Academy also offered three different advanced training sessions with 85 participants completing the training. One session was offered in September and two other sessions were held in April concurrently with the Academy basic training program. (Refer to Chart 1 below for additional details).

All Academy training is nationally approved and certified for professional certification units and university credits. The Academy offers CEU's and university credits for both the Basic and Advanced training programs.

CERTIFICATION PROGRAM: The Academy's state level certification and professional standards program ties together with certificate programs and courses at UB. To date there are eighteen certified advocates, and another dozen are in various stages of preparing for the examination. Certifications are held at three different levels, for each level there is a separate application and examination process.

The RVAAM is nationally recognized for having sustainability, solid linkages with an academic partner, an active Alumni Association, state certification, a robust advanced training program, and higher education programs that directly link with the Academy trainings. Maryland is recognized as one of the nation's leaders in the movement to advance education and professionalize the field of victim services. To date, in addition to the 380 graduates of the basic 40-hour training program (2004-2013), more than 1,615

participants have benefited from advanced trainings, conferences, workshops, and symposiums conducted through the Academy.

APPENDIX B

THE STATE BOARD OF VICTIM SERVICES STAFF

State Victim Services Coordinator

The Maryland General Assembly created the State Board of Victim Services and the position of State Victim Services Coordinator (State Coordinator) in 1988. The State Coordinator is charged with the responsibility of compliance, monitoring, assessing, coordinating and making recommendations to the Governor concerning state and local efforts to assist victims of crime. The State Coordinator serves under the authority of the Executive Director of the Governor's Office of Crime Control & Prevention. The State Coordinator has the overall responsibility for program development and program operations, as well as administering the provisions of the State Board of Victim Services. The State Coordinator provides staff support to the State Board on victim service matters while providing technical assistance to local public and private programs that provide victim assistance. The State Coordinator also performs research and gathers data on victims and victim assistance programs, and disseminates that data to the public.

A full-time MVOC Program Assistant provides dedicated State Board administrative support to the State Coordinator.

APPENDIX C

2013 Crime Victim Related Legislative Session Summary

Objective: To create and pass public safety legislation that will help Maryland fight crime and improve public safety for all of its citizens.

During 2013, the State of Maryland continued its ongoing efforts to explore new legislation to more effectively reduce crime and save lives. There were several significant bills passed during the 2013 session of the Maryland General Assembly that will help protect Maryland's citizens and assist criminal justice stakeholders in their fight. Below is a list of those bills that protect and benefit crime victims.

2013 Enacted Legislation

Firearm Safety Act of 2013: The O'Malley-Brown Administration championed the Firearm Safety Act of 2013, a comprehensive plan of common sense reforms to make Marylanders safer. The law includes some of the following provisions:

- Protective Orders – The law expands the protective order prohibition for possession of a firearm to include a protective order issued from any state.
- Prohibited Possession – The law adds to parties who are prohibited from possession of a firearm for mental health reasons to include those who suffer from a mental disorder and have a history of violent behavior; have been found incompetent to stand trial or not criminally responsible; have been voluntarily admitted for more than 30 consecutive days to a facility or involuntarily committed; or are under the protection of a court-appointed guardian for reasons other than physical disability.
- Restriction of Ammunition Possession – Prohibited persons, such as convicted felons, are also unable to possess ammunition. The law also prohibits the use of armor-piercing bullets in a crime of violence.
- Report – MSP is required to report to the Governor and the General Assembly on their findings related to firearms investigations, number and types of firearms seized, and the best information as to the source of the seized firearms by December 31, 2015.

Death Penalty Repeal - Substitution of Life Without the Possibility of Parole: House Bill 295/Senate Bill 276 repeals the death penalty and establishes that a person found guilty of murder in the first degree will be sentenced to imprisonment for life or imprisonment for life without the possibility of parole.

Family Law - Protective Orders - Notification of Service - Sunset Extension: Senate Bill 1001 extends the sunset provision of VPO until December 31, 2016.

Human Trafficking Seizure and Forfeiture Law House Bill 713: authorizes State and local law enforcement agencies to seize property in connection with a "human trafficking" violation and establishes procedures for the seizure, forfeiture, and sale of property related to human trafficking violations. Proceeds of seized property will go to the state general fund or a local financial authority, depending on the seizing entity. The bill's references to "human trafficking" include the following additional offenses: (1) sexual solicitation of a minor; (2) child pornography; (3) receiving earnings of a prostitute; and (4) abduction of a child younger than 16 years old.

Priorities for the Future

Human Trafficking:

- Abduction of Child Under 16: The Maryland Human Trafficking Task Force intends to introduce legislation that would re-classify the crime of kidnapping a child under the age

of 16 as a felony as opposed to a misdemeanor and increasing the penalty to 20 years. Traffickers are known to exploit young children, especially teens, and have abducted children in order to do so. Reclassifying this crime as a felony would align the classification of the offense with the crime's seriousness and ensure that a conviction under this statute carries the appropriate consequences of a felony conviction.


- Termination of Parental Rights: The Maryland Human Trafficking Task Force is proposing legislation that would terminate parental rights for certain offenses, including sex trafficking or commercial sexual exploitation of children, in order to remove vulnerable children of traffickers from their control and exploitation.

Domestic Violence: The O'Malley-Brown Administration has championed legislation to protect domestic violence victims, including removing firearms from protective order respondents in 2009. In furtherance of the Governor's goal of reducing violent crime against women and children by 25% by the end of 2018, GOCCP will work with advocates on domestic violence legislation that accomplishes the following:

- Alters the standard for a protective order from "clear and convincing" to a "preponderance of the evidence." Senator Frosh has expressed an interest in sponsoring this legislation for the 2014 session.
- Alters the definition of a "person eligible for relief" to include individuals in dating relationships.
- Alters the circumstances under which a permanent final protective order must be issued by requiring a court to issue an order against individuals who are sentenced to serve at least 5 years. Currently, an offender must have served the full 5 years for the victim to get relief.
- Adds the crime of assault in the second degree to the list of crimes for which a victim is eligible to receive a permanent final protective order. Ideally, advocates would like final protective orders to apply to all crimes.
- Repeals sunset for VPO, which is funded through the DPSCS budget. The use of VPO has provided significant benefits for victims of domestic violence. The time immediately after a respondent has been served with a protective order is a critical and dangerous time for the petitioner. Knowing when the respondent has been served helps ensure that the petitioner has time to enact a safety plan. VPO also notifies the victim that the respondent is on notice and that the respondent will be arrested for any violation.
- The Maryland Network Against Domestic Violence (MNADV) is drafting legislation in response to *Lawrence La Valle v. Janet La Valle*, a June 2013 Maryland Court of Appeals case that requires a protective order extension hearing to take place prior to expiration of the original order. Current law does not require the court to schedule a hearing prior to an order's expiration, and lengthy scheduling delays currently exist. Legislation would provide for an automatic one-month extension of a final protective order and require the Court to hold a hearing prior to expiration.


